We engage in due diligence with all of our suppliers to ensure they adhere to the highest ethical standards, and our Code of Conduct policy is a key component in promoting these standards. All employees, contractors, and suppliers must comply with our policies that prohibit any form of modern slavery.

#### **Our Values and Commitment**

These values are at the heart of everything we do, and we firmly believe in upholding them across our business practices. We are fully committed to ensuring that modern slavery is not tolerated within our operations or supply chains. ## **Ongoing Efforts and Due Diligence**

Our due diligence process involves a **comprehensive and systematic approach** to evaluating potential risks within our supply chain. This includes the vetting of all new suppliers, where we request documentation that confirms their commitment to ethical labor standards, including their Code of Conduct and business policies. We also ensure that our Supplier Code of Conduct is clearly communicated and adhered to by all partners. To further strengthen our commitment, we regularly **review and assess the practices of existing suppliers.** In the event that modern slavery risks are identified, we are prepared to **take swift action**, **including terminating contracts or engaging in corrective actions to ensure compliance with our ethical standards**. Our due diligence platform helps us maintain a clear and efficient process to track and address potential risks proactively.

#### Ethics Training, Awareness, and Whistleblowing Mechanisms


We have developed a robust Ethics training program which empowers our employees to identify and report any signs of modern slavery. All employees are required to complete a **Ethics Training** module as part of their onboarding process, which is refreshed annually to ensure they are up-to-date on the latest trends and legal requirements. In addition to training, we ensure that the entire workforce is kept informed through regular communications, reminding them of the importance of remaining vigilant and proactive in identifying any breaches of human rights. This information is also readily available to employees on our internal platform, **Campus Booster**, ensuring continuous access to vital resources.

Through these ongoing efforts, we continuously refine our practices to prevent modern slavery, holding ourselves and our suppliers accountable to the highest ethical standards. We remain committed to upholding our values of **United, Passionate, Engaged, Reliable, and Agile**, ensuring a responsible and transparent approach in everything we do.
