

## **PRIVACY POLICY and DATA PROCESSING**

### **AGON APP**

#### **Information in the User**

The person responsible for processing your personal data is Marc Gassió, as the owner of the AGON application.

AGON informs the users of its APP of strict compliance with respect to the treatment and protection of your personal data that can be obtained through its use according to the provisions of Organic Law 3/2018 of December 5, Protection of Personal Data and guarantee of digital rights.

In application of the provisions herein, AGON has a duty of confidentiality in accordance with article 5.1 as responsible and in charge of data processing, guarantees the duty of confidentiality referred to in article 5.1.f) of the EU Regulation 2016/679.

AGON is responsible for processing the personal data of Users and Clients, and reports the following purposes:

- The address registered by a user, as well as the rest of their data necessary for the provision of the main service of the application, will only be used precisely for that purpose, to ensure offering the service with the best possible treatment.
- The user will be kept informed about modifications and/or updates to the applicable data protection regulations.

#### **Rights of Users and Clients**

In accordance with article 6.1 of the LOPD and in relation to article 4.11 of the Regulation of the UE 2016/679, will be understood as consent of the user / to any manifestation of free,

specific, informed and unequivocal will with which it is accepted, either through a statement or clear affirmative action.

As a User you will have the right to access to obtain confirmation on whether AGON is treating the personal data that concerns you.

Likewise, you will have the right to access your personal data, to request your rectification according to article 14 of the LOPD in relation to 16 of RD 2016/679.

If there is any exact variation or, where appropriate, request its deletion when, among other reasons, the data is no longer necessary for the purposes for which were collected. To do this, you must always accompany precise, the supporting documentation of the inaccuracy or unfulfilled nature of the data object of treatment.

In certain circumstances, you may request the limitation of the treatment of the your data, in this case we will only keep them for the exercise or defense of claims.

Additionally, in certain circumstances and for reasons related to the your particular situation, you may exercise the right to object to the processing of your data. AGON will stop processing your data, except for legitimate reasons imperative, or the exercise or defense of possible claims.

Likewise, you can exercise the right to data portability, as well as to withdraw the consents provided at any time, without affecting the legality of the treatment based on the consent prior to its withdrawal.

To exercise the identified rights, AGON must communicate it in a reliable by email to the address [info.agon.app@gmail.com](mailto:info.agon.app@gmail.com) or by postal mail, enclosing a photocopy of the DNI, for the certainty of your identity. Remember to facilitate the greatest possible information about your request: name and surname, email address email you used for your registration request.

Finally, we inform you that you can contact the Spanish Protection Agency Data and other competent public bodies for any claim derived from the processing of your personal data.

## **MINORS**

In the event that the user is over fourteen years of age, the treatment of the your data will be sufficient with your consent, as provided in article 7 of the LPD.

The parents/guardians of minors authorized in application of current regulations, who become aware that your child has provided information without your consent, you must contact [info.agon.app@gmail.com](mailto:info.agon.app@gmail.com), in order to delete the information provided from the files within a reasonable period of time.

Users of AGON services guarantee and respond, in any case, of the accuracy, validity and authenticity of the personal data provided, as well as they also undertake to update them in the event of their variation.

The User, when accessing the AGON application, guarantees that the personal data provided are true and is responsible for communicating any variation that exists in relation to them.

Likewise, you also agree to accept the privacy policy, unless disseminate to third parties information that you may have learned through the use of the application, and in the event of doing so, exempts AGON from the responsibilities that may cause the negligence of his action.

Without prejudice to what is foreseen in everything that is indicated in each of the APP forms, when the user provides their personal data, you are expressly authorizing AGON to process your personal information for the purposes indicated and its incorporation into the databases of the company.

AGON will incorporate the data provided by the user in a file duly legalized before the Data Protection Agency and will establish the measures of technical and organizational security to protect the confidentiality and integrity of the information in accordance with the provisions of LO 15/1999 of December 13, of protection of personal data and the additional applicable legislation.

### **Security measures**

In accordance with the provisions of current personal data protection regulations, AGON complies with all the provisions of the RGPD and LOPD regulations for the treatment of the personal data subject to their responsibility. always preserving the information in a lawful and transparent manner with the holders.

AGON guarantees that it adopts the necessary policies to apply the measures related to the applicable regulations in order to act in accordance and protect the rights and freedoms of Consumers and Users who may visit your Web page.

In the event of any incident that may affect the security of the database obtained from the website, will inform all those affected during the 72 hours after detection.

### **Applicable legislation**

For the resolution of any possible controversy or question related to the application AGON, will be subject to Spanish and regional legislation. AGON and the Users expressly submit to the jurisdiction of the Courts and Competent courts.

Information received from sports and/or leisure activities provided by users of the application, will be understood as assigned to AGON free of charge.
