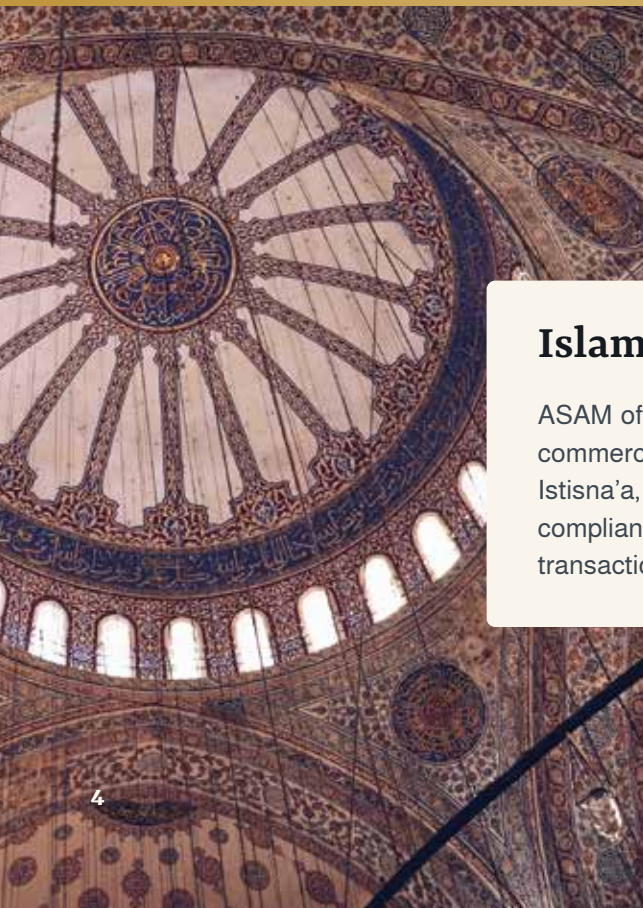

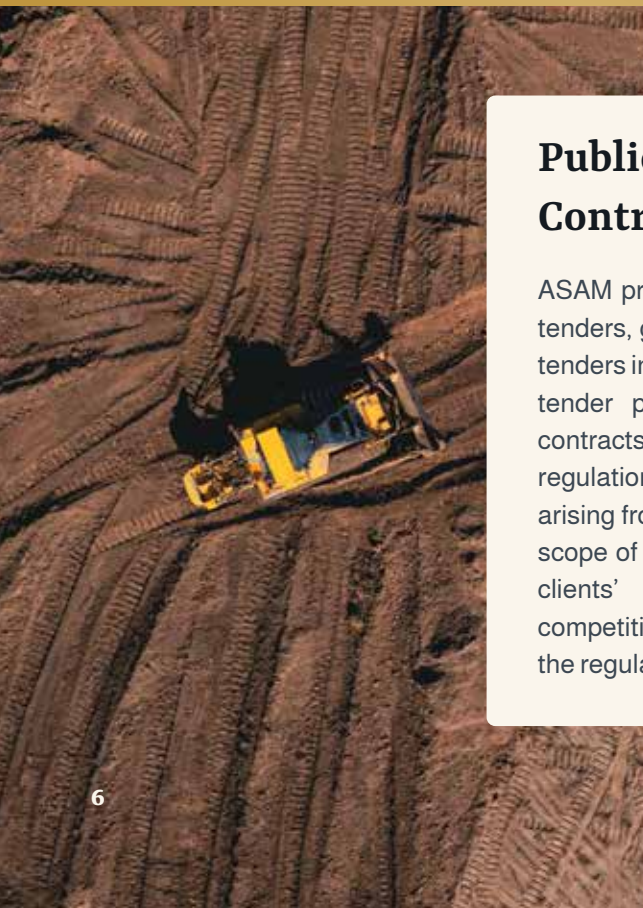
Competition & Market Regulation

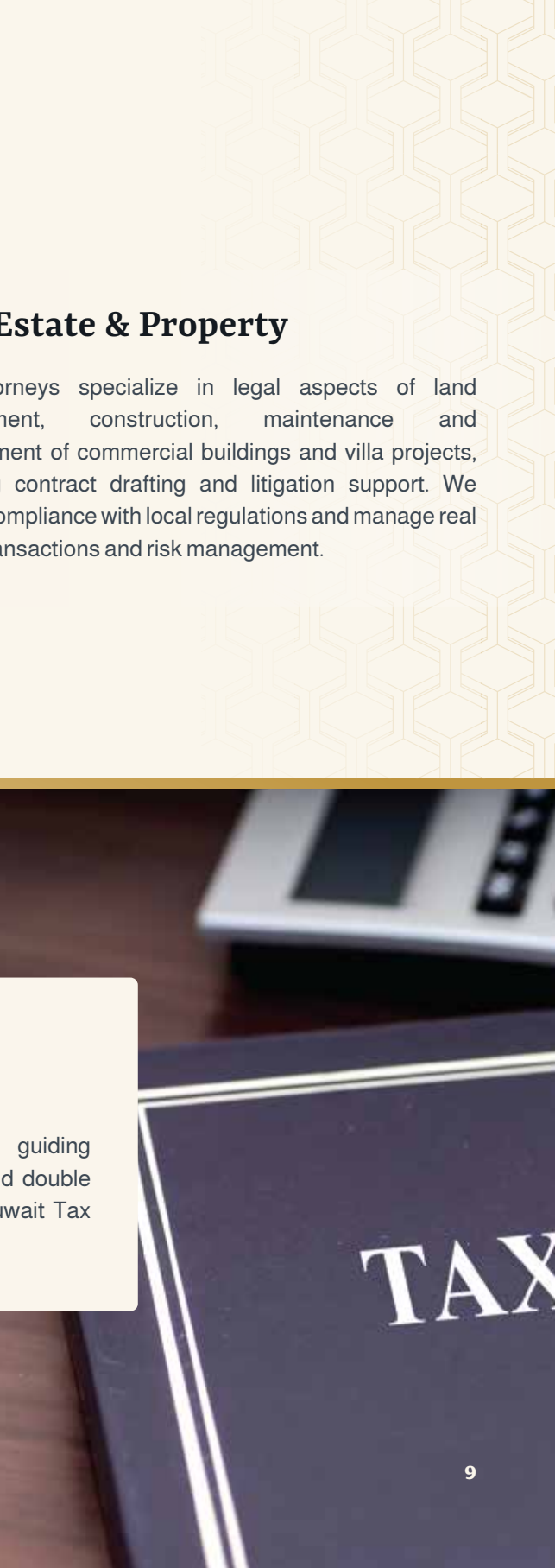
