MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

MAO TOWN COMMITTEE, MAO, MANIPUR

AND

ASUFII CHRISTIAN INSTITUTE, MAO, MANIPUR.

This Memorandum of Understanding is entered between the Mao Town Committee (MTC) and Asufii Christian Institute (ACI) on 15<sup>th</sup> February 2022.

Therefore, the parties agree to establish partnership in areas of mutual interest in accordance with terms and conditions set forth in this memorandum of Understanding (MOU)

- To sensitize in minimizing the use of plastics

3. Encourage and promote communities to properly segregate domestic waste
4. To put concerted efforts and participate in solid waste management projects.

### **Agreement of the MOU**

In quintessence to the mutual interest, set forth in this MOU, the parties enter into agreement on the following terms and conditions:

#### **Article 1**

- 1.1 The parties shall enable social interactions through street plays and theatricals on environmental consciousness and preservations.
- 1.2 The parties shall have access to field works and relevant data collections with regard to research and innovation, under respective jurisdictions, within the preview of the objectives laid down in the MOU.
- 1.3 As part of responsible agent in waste management, the Mao Town Committee (MTC) shall depute the garbage truck twice a week to Asufii Christian Institute (ACI) campus to collect the solid waste from the campus.
- 1.4 The parties shall allow activities of cleanliness drives, awareness programs, social experiments, public service advertisements and relevant other activities on environment conservation.

#### **Article 2**

- 2.1 The parties shall duly acknowledge/recognize/ credit each other on all joint ventures.
- 2.2 Parties shall not use the names, logos, likeness, trademark or images of the other party for any advertising, marketing, endorsement or any other purpose without specific prior consent of an authorized representative of the other party.

#### **Article 3**

- 3.1 The initial period of the MOU shall be 5 (Five) years from the date of signing, after which parties may renew or revoke on mutual agreement.
- 3.2 Notwithstanding anything in the Articles of the MOU, either party may terminate this MOU by notifying the other party in writing through appropriate channel at least 5 Months prior to its intention to do so. Unless otherwise, agreed by the parties in

writing, the termination of this MOU shall not affect the implementation of any cooperative activity in-progress undertaken under this MOU.

3.3 The MOU is at-will and may be amended or modified by mutual consent of authorized officials from both parties.

3.4 The MOU will not imply any financial duty upon parties.

3.5 All activities shall subject to availability of funds and Approval of each party's authorized representatives.
