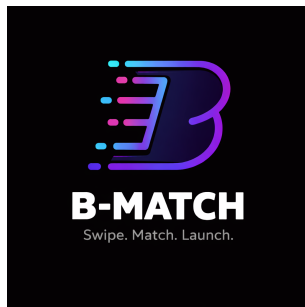




Terms of Service

These Terms of Service (“Terms”) govern your access to and use of the B-Match mobile application and related services (“B-Match”, “the App”, or “the Service”).

By creating an account or using the B-Match app, you agree to these Terms.
If you do not agree, you must not use the Service.

1. Description of the Service

B-Match is a networking and collaboration platform designed to help individuals:

- discover other members
- connect and match with potential collaborators
- form startup teams
- communicate via chat and connection requests
- schedule calls
- collaborate on projects
- discover independent startup programs or initiatives offered by third parties

B-Match provides tools to facilitate networking and collaboration, but it does not guarantee:

- business success
- team compatibility
- funding opportunities
- startup outcomes
- acceptance into external programs
- the reliability of other users

Users are responsible for their own decisions and collaborations.

2. Eligibility

You must be at least 18 years old to use B-Match.

By using the Service you confirm that:

- you are at least 18 years old
- you are legally able to enter agreements
- you will use the platform responsibly

B-Match may suspend or terminate accounts that violate these conditions.

3. User Accounts

To use B-Match you must create an account.

You agree to:

- provide accurate information
- keep your login credentials secure
- not impersonate others
- not create multiple accounts for deceptive purposes

You are responsible for activity under your account.

4. User Content

Users may upload or share content including but not limited to:

- profile information
- profile photos
- descriptions of ideas or businesses
- documents such as business plans
- links
- messages
- team information

You retain ownership of your content.

However, by posting content on B-Match you grant B-Match a non-exclusive, worldwide license to:

- display
- host
- store
- process

that content solely for the purpose of operating the Service.

You must ensure that the content you upload:

- does not violate intellectual property rights
- is not misleading or fraudulent
- does not contain illegal material

5. Prohibited Conduct

B-Match maintains a zero-tolerance policy for objectionable content and abusive behavior.

This includes, but is not limited to:

- harassment, hate speech, or threats
- sexually explicit or inappropriate content
- scams or fraudulent activity
- misuse of the platform for non-professional purposes

Users engaging in such behavior may be permanently removed from the platform without notice.

Users must not use B-Match to:

- harass, threaten, or abuse other users
- impersonate individuals or organizations
- promote scams or fraudulent activities
- share illegal content
- distribute spam
- attempt to exploit or manipulate other users
- misuse the platform for unlawful purposes

B-Match reserves the right to:

- remove content
- suspend accounts
- permanently ban users

if misconduct is detected.

6. User Reporting and Moderation

Users can report, flag, or block other users directly within the app.

Blocking a user immediately prevents further interaction and removes the user from discovery and communication features.

B-Match reviews reports and may take action within 24 hours, including:

- content removal
- temporary suspension
- permanent account termination

B-Match reserves the right to act at its sole discretion to maintain a safe environment.

7. Teams and Collaborations

B-Match enables users to form teams and collaborate.

However:

- B-Match does not supervise collaborations
- B-Match does not verify the intentions of other users
- B-Match is not responsible for disputes between users

All collaborations are conducted at the users' own risk.

8. External Programs and Opportunities

B-Match may display or promote independent startup programs or initiatives. These programs are operated by third parties.

B-Match:

- does not guarantee admission
- does not manage contracts
- does not supervise relationships
- does not guarantee outcomes

Any agreements made or not made between users and external programs are solely between those parties.

B-Match is not responsible for such agreements.

9. Subscriptions and Premium Features

B-Match offers optional paid subscriptions.

Premium subscriptions may include features such as:

- increased team capacity
- enhanced collaboration tools
- additional platform features

Subscriptions are available as:

- monthly plans
- yearly plans (discounted)

All subscriptions:

- renew automatically
- can be managed through your App Store account
- can be cancelled through Apple's subscription settings

No free trials are currently offered.

The free version of the app remains available.

10. Payments

Payments are processed through Apple's App Store payment system.

B-Match does not directly process payment information.

Refunds are subject to Apple's policies.

11. Account Termination

Users may delete their account at any time.

B-Match may terminate or suspend accounts if users:

- violate these Terms
- engage in misconduct
- misuse the platform

B-Match may remove inactive accounts after 24 months of inactivity.

12. Intellectual Property

The B-Match platform, including:

- the app
- branding
- interface
- software

is owned by Grupo Alpom Importaciones S.L.

Users may not copy, reverse engineer, or distribute the platform.

13. Limitation of Liability

To the fullest extent permitted by law:

B-Match is not liable for:

- user behavior
- collaborations between users

- business outcomes
- startup success or failure
- disputes between users
- agreements with third parties

The platform is provided “as is” without warranties of any kind.

14. Global Use

B-Match may be accessed globally where permitted by law.

Users are responsible for complying with local laws in their jurisdiction.

15. Governing Law

These Terms are governed by the laws of Spain.

Any disputes will be subject to the jurisdiction of the courts of Madrid, Spain.

16. Changes to These Terms

B-Match may update these Terms periodically.

Users will be notified of significant changes through the app or via email.
