Preventive measures and rules of conduct

Provide good ventilation.

Do not breathe vapor or spray. Wear appropriate protective equipment.

After work, wash hands and face.

Respiratory protection:

Respiratory protection must be worn whenever the TLV (WEL) levels have been exceeded.

Half mask with particle filter P2/P3 according to OSHA Standard - 29 CFR: 1910.134 or ANSI Z88.2.

Protective gloves according to OSHA Standard - 29 CFR: 1910.138.

Glove material: Nitrile rubber Layer thickness: 0.11 mm. Breakthrough time: >480 min.

Observe glove manufacturer's instructions concerning penetrability and breakthrough time.

Eve protection:

Tightly sealed goggles according to OSHA Standard - 29 CFR: 1910.133 or ANSI Z87.1-2010.

Wear suitable protective clothing.

Reaction in case of danger

Avoid contact with the substance.

Do not breathe vapor or spray. Wear suitable protective clothing.

Ensure adequate ventilation, especially in confined areas.

Extinguishing media:

Product is non-combustible. Extinguishing materials should therefore be selected according to surroundings.

Accidental release measures

Soak up with absorbent materials such as sand, siliceus earth, acid- or universal binder. Store in special closed containers and dispose of according to ordinance. Final cleaning.

To clean the floor and all object contaminated by this material, use water.

First aid

In case of inhalation: Move victim to fresh air.

After contact with skin, wash immediately with plenty of water.

Immediately flush eyes with plenty of flowing water for 10 to 15 minutes holding eyelids apart. After eye contact:
