Preventive measures and rules of conduct

Keep out of reach of children. P234 Keep only in original container.

Eve protection:

Tightly sealed goggles according to OSHA Standard - 29 CFR: 1910.133 or ANSI Z87.1-2010.

Body protection:

Field of activity:

Reaction in case of danger

Do not breathe dust. Avoid generation of dust. Take off contaminated clothing and wash it before reuse. Avoid contact with the substance. Provide adequate ventilation.

Wear appropriate protective equipment. Keep unprotected people away.

Extinguishing media:

Product is non-combustible. Extinguishing materials should therefore be selected according to surroundings.

Extinguishing powder, carbon dioxide, water spray jet.

In case of large fires: Water spray jet or foam.

Extinguishing media which must not be used for safety reasons:

Full water jet

Accidental release measures:

Avoid generation of dust. Knock down dust with water spray jet.

Take up mechanically, placing in appropriate containers for disposal.

Wash spill area with plenty of water.

Never return spills in original containers for re-use.

Absorb spillage to prevent material damage.

First aid

In case of inhalation:

General information: First aider: Pay attention to self-protection!

Take off immediately all contaminated clothing.

Symptoms of poisoning may develop several hours following exposure. Victim should be under medical observation for at least 48 hours after exposure.

If victim is at risk of losing consciousness, position and transport on their side.

medical attention.

Following skin contact: Clean with plenty of water. If possible, also wash with polyethylene glycol 400. Cover with

sterile dressing material to protect against infection. Immediately get medical attention.

Move victim to fresh air; if necessary, provide artificial respiration or oxygen. Immediately get

After eye contact: Immediately flush eyes with plenty of flowing water for 10 to 15 minutes holding eyelids

apart. Remove contact lenses, if present and easy to do. Continue rinsing. Subsequently

seek the immediate attention of an ophthalmologist.

After swallowing: Rinse mouth immediately and drink plenty of water.

Do not induce vomiting. Risk of perforation in case of vomiting! Immediately get medical attention. Do not try to neutralize.
