CannaHauler LLC Privacy Policy

A. INTRODUCTION

1. CannaHauler LLC ("CannaHauler", "we", "our" or "us", whether or not capitalized) respect your privacy and are committed to protecting your privacy by establishing and complying with this policy (the "policy" or our "Privacy Policy").

2. This policy describes the types of information that we may collect from you or that you may provide when you visit https://cannahauler.io/ (or any successor site) and/or your specific CannaHaule account, including all content, functionality and services offered (all collectively our "Website"), whether as a guest or a registered user, and our practices for collecting, using, maintaining, protecting and disclosing your information.

- (a) This policy applies to information that we collect:
 - (i) on our Website; and
 - (ii) in email, text, and other electronic messages between you and us, or our Website.
- (b) This policy does not apply to information collected by:
 - (i) us offline or through any other means, including on any other website operated by CannaHauler or any third party; or

(ii) any third party, including through any application or content (including advertising) that may link to or be accessible from or on our Website.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Website. By accessing or using our Website, you agree to this Privacy Policy. This policy may change from time to time (see "CHANGES TO OUR PRIVACY POLICY" in <u>Section N</u> below). Your continued use of our Website after this policy has been updated is deemed to be your acceptance of those changes, so please check this policy periodically for updates.

B. MINORS UNDER THE AGE OF 21

Our Website is not intended for anyone under twenty-one (21) years of age. No one under the age of 21 may provide any information to or on our Website. We do not knowingly collect personal information from anyone under 21 years of age. If you are under 21, do not use our Website. If we learn we have collected or received personal information from a person under the age of 2, we will delete that information. C. INFORMATION WE COLLECT ABOUT YOU AND HOW WE COLLECT IT

1. We collect several types of information from and about users of our Website, including information:

- by which you may be personally identified, such as your name, postal address, business location address, email address, telephone number, or any other identifier by which you may be contacted online or offline (your "personal information"); and/or
- b. about your login credentials used to access our Website, your internet connection, the equipment you use to access our Website, and usage details.

2. We collect this information:

- a. directly from you when you provide it to us;
- b. automatically as you navigate through our Website. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies.
- c. from third parties, for example, our business partners, and your service providers that you may have authorized to provide your data to CannaHauler.

D. INFORMATION YOU PROVIDE TO US.

1. The information we collect on or through our Website may include:

- a. information that you provide by filling in forms on our Website. This includes information provided at the time of registering to use our Website, subscribing to or using our service, downloading information or material, or requesting further services. We may also ask you for information when you report a problem with our Website.
- b. records and copies of your correspondence (including email addresses), if you contact us or respond to correspondence from us.
- c. your responses to surveys or questionnaires that we might ask you to complete for research purposes.
- d. details of transactions or activities you carry out through our Website.
- e. your search queries on our Website.

E. INFORMATION WE GATHER VIA AUTOMATIC DATA COLLECTION TECHNOLOGIES.

1. As you navigate through and interact with our Website, we may use automatic data collection technologies to gather certain information about your equipment, browsing actions, and patterns, including:

- a. details of your visits to our Website, including traffic data, location data, logs, and other communication data, and the resources that you access and use on our Website.
- b. information about your computer and internet connection, including your IP address, operating system, and browser type.

2. We may maintain automatically-collected information or associate it with your personal information we collect in other ways or receive from third parties. Collecting this information helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- a. Understand usage patterns.
- b. Store information about your preferences, allowing us to customize our Website according to your individual interests.
- c. Speed up your searches.
- d. Recognize you when you return to our Website.

3. The technologies we use for this automatic data collection may include:

- a. **Cookies** (or "**Browser Cookies**"). A cookie is a small file placed on the hard drive of your computer. You may refuse to accept Browser Cookies by activating the appropriate setting on your browser. However, if you refuse to accept Browser Cookies, you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that your browser will refuse cookies, our system will issue cookies when you direct your browser to our Website.
- b. Flash Cookies. Certain features of our Website may use local stored objects (called "Flash Cookies") to collect and store information about your preferences and navigation to, from, and on our Website. Flash Cookies are not managed by the same browser settings as are used for Browser Cookies. For information about managing your privacy and security settings for Flash Cookies, please see Section I (the letter "i" as in "eye", not the roman numeral "one") titled "CHOICES ABOUT HOW WE USE AND DISCLOSE YOUR INFORMATION" below.
- c. Web Beacons. Pages of our Website and our emails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that may permit Dimebags, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

F. THIRD-PARTY USE OF COOKIES.

1. Some content or applications, including advertisements, on our Website are served by third parties, including advertisers, ad networks and servers, content providers, and application providers. These third parties may use cookies, alone or in conjunction with web beacons or other tracking technologies, to collect information about you when you use our Website. The information they collect may be associated with your personal information or they may collect information, including personal information, about your online activities over time and across different websites and other online services. They may use this information to provide you with interest-based (behavioral) advertising or other targeted content.

2. We do not control these third parties' tracking technologies or how they may be used. If you have any questions about an advertisement or other targeted content, you should contact the responsible provider directly. For information about how you can opt-out of receiving targeted advertising from many providers, see <u>Section I</u> titled "CHOICES ABOUT HOW WE USE AND DISCLOSE YOUR INFORMATION" below.

G. HOW WE USE YOUR INFORMATION

1. We use information that we collect about you or that you provide to us, including any personal information:

- a. To present our Website and its contents to you.
- b. To provide you with information, products, or services that you request from us.
- c. To fulfill any other purpose for which you provide your information to us.
- d. To provide you with notices about your account, including expiration and renewal notices.
- e. To carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.
- f. To notify you about changes to our Website or any products or services we offer or provide though our Website.
- g. To allow you to participate in interactive features on our Website.
- If you have difficulties getting our service to work as desired, to assist us and you in helping to identify the root cause of your problem.
- i. In any other way we may describe at the time you provide the information to us.
- j. For any other purpose with your consent.

H. DISCLOSURE OF YOUR INFORMATION

1. We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

2. We may disclose personal information that we collect or you provide as described in this Privacy Policy, in each instance, to recipients who are bound by contractual obligations to keep your personal information confidential and use your information only for the purposes for which we disclose your information to them, as follows:

- a. to our subsidiaries and affiliates;
- b. to contractors, service providers, and other third parties that we use to support our business;
- c. to your service providers that you have authorized to provide your data to CannaHauler;
- d. to a potential buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of CannaHauler' assets which occurs for any reason, in which your personal information held by our Website users might be among the assets transferred;
- e. to fulfill the purpose for which you provide the information to us;
- f. for any other purpose disclosed by us when you provide the information to us; and
- g. with your consent.

3. We may also disclose your personal information:

- a. to comply with any court order, law, or legal process, including to respond to any government or regulatory requirement;
- b. to enforce or apply our terms of use and service (that may be seen at [insert applicable webpage] or other agreements, including for billing and collection purposes; and
- c. if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of CannaHauler, our customers, or others.

I. CHOICES ABOUT HOW WE USE AND DISCLOSE YOUR INFORMATION

1. We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

- a. **Tracking Technologies and Advertising**. You can set your browser to refuse all or some Browser Cookies, or to alert you when cookies are being sent. To learn how you can manage your Flash cookie settings, visit the Flash player settings page on Adobe's <u>website</u>. If you disable or refuse cookies, please understand that some parts of our Website may then be inaccessible or not function properly.
- b. Promotional Offers from CannaHauler. If you do not wish to have your email address or other contact information used by CannaHauler to promote our own or third parties' products or services, you may opt-out by contacting us at nick@cannahauler.io. If we have sent you an unwanted promotional email, you may forward that unwanted email to us at nick@cannahauler.io asking to be omitted from future such email distributions. This opt-out does not apply to information provided to or by CannaHauler as a result of CannaHauler providing services to you or other transactions.

J. ACCESSING AND CORRECTING YOUR INFORMATION

1. You may review and change your personal information by logging into our Website and visiting your account profile page.

2. You may also send us an email at nick@cannahauler.io, asking to request access to, correct or delete any personal information that you have provided to us. We cannot delete all of your personal information except by also deleting your user account. We may not be able to accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect.

K. YOUR CALIFORNIA PRIVACY RIGHTS

California Civil Code Section §1798.83 permits users of our Website that are California residents to request certain information regarding our disclosure of personal information to third parties for their direct marketing purposes. L. EUROPEAN UNION CITIZENS' RIGHTS UNDER GDPR

If you are a citizen under the European Union, you have certain rights under the General Data Protection Regulation regarding information we collect, including the following:

- b. The right to require us to correct any mistakes in your personal information.
- c. The right to require us to delete your personal information in certain situations.
- d. The right to require us to restrict processing of your personal information in certain circumstances, e.g. if you contest the accuracy of the data.
- e. The right to receive the personal information you provided to us, in a structured, commonly used and machine-readable format and/or transmit that data to a third party—in certain situations.
- f. The right to object:
 - i. at any time to your personal information being processed for direct marketing (including profiling);
 - ii. in certain other situations to our continued processing of your personal information, e.g. processing carried out for the purpose of our legitimate interests.
- g. The right not to be subject to a decision based solely on automated processing (including profiling) that produces legal effects concerning you or similarly significantly affects you.

M. DATA SECURITY

1. We have implemented measures designed to help us keep your personal information secure from accidental loss and from unauthorized access, use, alteration, and disclosure.
