

Car Share Privacy Policy

Principles of car sharing

We have created **Car Share** App to make it easier to share cars with your friends and people around you.

Our default privacy settings are limited to the information displayed on your profile on your networks and other reasonable community restrictions we tell you

We want to help you get this information easily.

So that sharing information should be easy.

We want to provide you with the privacy tools to control how this information is shared and with whom.

Our privacy policy is designed to help you understand how we collect and use the personal information you decide to share, and to help you make informed decisions when using the app.

Car Share, located in and directly related fields.

By using or accessing **Car Share**, you accept the practices described in this Privacy Policy.

You may also collect information about you from other sources, such as newspapers, blogs, instant messaging services, and other users of the **Car Share** Service by operating the Service (e.g., image tags) in order to provide you with more useful information and a more personalized experience.

Children under 13 years of age

By using **Car Share**, you consent to the transfer and processing of your personal data in the **Car Share** application.

Children under the age of 13 do not knowingly collect or solicit personal information from anyone under the age of 13 or intentionally allow such persons to register.

If you are under the age of 13 please do not attempt to register with **Car Share** or send us any information about you, including your name, address, phone number or email address.

Sharing your information with third parties

The idea of **Car Share** is to share your car and information with others – friends and people in your networks – while providing you with privacy settings that restrict other users from accessing your information.

We allow you to choose what information you provide to friends and networks by sharing the car.

We do not provide contact information to third-party marketers without your permission.

We share your information with third parties only in limited circumstances where we believe such sharing is reasonably necessary to provide the legally required service permitted by you.

For example:

1. The News Feed and Mini-Feed may compile the information you provide and make it available to your friends and network members in accordance with your privacy settings.

2- Unlike most websites on the web, car sharing limits access to location information by third-party search engine "crawlers" such as

(Google, Yahoo, MSN, Ask{

Car Share takes measures to prevent these engines from accessing personal information other than your name, profile picture, and limited aggregated data about your profile.

3. We may provide information to service providers to help us provide the services we provide. Specifically, we may use third parties to facilitate our business, such as hosting the Service in a shared server facility, to send email updates about **Car Share**, or to remove duplicate information from our user lists,

or to process payments for products or services, to submit an online job application process, or to provide search results or links (including advertising links).

In connection with these offers and business operations, our service providers may have access to your personal information for use for a limited time in connection with these business activities.

When we use third parties to process any personal information, we implement reasonable contractual and technical protections that limit the use of such information for the purposes specified by **Car Share**.

4. If you, your friends or members of your network use any third-party applications developed using the **Car Share** Platform ("Platform Applications"), such Platform Applications may access certain information about you and share it with others in accordance with your privacy settings.

In addition, third-party developers who have created and operated Platform Applications ("Platform Developers") may have access to your personal information (excluding your contact information) if you allow the Platform Applications to access your data.

Before allowing any Platform Developer to make any Platform Application available to you, **Car Share** requires the Platform Developer to enter into an agreement that requires it, among other things, to respect your privacy settings and strictly limits the collection, use, and storage of your information.

However, while we have taken contractual and technical steps to restrict the potential misuse of this information by these platform developers, we at **Car Share** of course cannot guarantee that all platform developers will comply with these agreements.

Please note that **Car Share** does not screen or approve the developers of the Platform and cannot control how these Platform developers use any personal information they may obtain in connection with the Platform Apps.

In addition, platform developers may require you to subscribe to their Terms of Service, privacy policies, or other policies, which may give them additional rights or impose additional obligations on you, so please be sure to review these terms and policies carefully before using any Platform application.

You may report any suspected misuse of information through the **Car Share** Platform and we will investigate any such claim and take appropriate action against the platform developer including termination of their participation in the **Car Share** Platform and/or any other official legal process.

5- We may be required to disclose user information in accordance with lawful requests, such as subpoenas or court orders, or in accordance with applicable laws.

We do not disclose information until we have a good faith belief that a request for information by law enforcement or private litigants meets applicable legal standards.

In addition, we may share account or other information when we believe it is necessary to comply with the law, to protect our interests or property, to prevent fraud or any other illegal activity committed through the **Car Share** Service or the use of the **Car Share** name, or to prevent imminent bodily harm.

This may include sharing information with other companies, lawyers, agents, or government agencies.

6- We allow you to choose to share information with marketers or e-commerce providers through sponsored groups or other offers on the site.

6- We may offer stores or services in conjunction with other companies on **Car Share**.

7- The car-sharing beacon is a way to share actions you have taken on third-party websites, such as when making a purchase or posting a review in order to provide you as a car sharing user with clear disclosure of certain information.

You have the option to have **Car Share** ignore this information, or share it with your friends.

Like many other websites that interact with third-party websites, we may receive some information even if you log out of **Car Share** Share's or that relates to non- **Car Share** users from those sites in conjunction with the technical operation of the system.

In cases where Car Share receives information about users who are not logged in, or about non-Vehicle Sharing users, we do not attempt to link it to individual Vehicle Sharing accounts and will ignore it.

8- If the ownership of all or a substantial part of a business on **Car Share**, or individual business units owned by **Car Share** shares, if the change is made, your user information may be transferred to the new owner so that the service can continue operations.

In any such transfer of information, your user information will remain subject to the promises made in any pre-existing privacy policy.

10. All such sharing of information is done at your own risk.

11. Please keep in mind that if you disclose personal information in your profile or when posting comments, messages, photos, videos, lists or other items, such information may become publicly available.

Third Party Advertising

Sometimes ads that appear on **Car Share** (or "delivered") are delivered directly to users by third-party advertisers.

They receive your IP address automatically when this happens.

Third-party advertisers may also download cookies to your computer, or use other technologies such as JavaScript and "web beacons" (also known as "1x1 GIFs") to measure the effectiveness of their ads and personalize ad content.

Doing so allows the ad network to recognize your computer every time they send you an ad in order to measure the effectiveness of their ads and personalize the content of the ad.

In this way, they can collect information about where individuals using their computer or browser saw their ads and identify which ads are clicked.

Car Share does not have access to or control cookies that may be placed by third-party advertisers.

Third-party advertisers can't access your contact information stored on Facebook unless you choose to share it with them.

This Privacy Policy covers the use of cookies by **Car Share** and does not cover the use of cookies or other tracking technologies by any advertisers.

Safety & Security

Car Share takes appropriate precautions to protect our users' information.

Your account information resides on a secure server behind a firewall.

When you enter sensitive information (such as your credit card number or password), we encrypt that information using SSL technology.

Since email and instant messaging are not recognized as secure communications, we ask that you do not send us private information via email or instant messaging services.

Terms of Use, Notices and Reviews

1- Your use of the **Car Share** App and any disputes arising out of it are subject to this Privacy Policy as well as our Terms of Use and all dispute resolution provisions including arbitration, limitations on damages and choice of law.

3. Non-material changes and clarifications will take effect immediately, and material changes will take effect within 30 days of posting on this website.
4. If we make changes, we will publish them and indicate at the top of this page the new effective date of the policy.
- 5- If we make material changes to this Policy, we will notify you here, by email or through a notice on our homepage.
6. We encourage you to refer to this policy on an ongoing basis so that you understand our current privacy policy.
7. Unless otherwise stated, our current Privacy Policy applies to all information we have about you and your account.
