BACKGROUND:

The Small Business Association of Jamaica (SBAJ) will host the 2nd Regional Micro, Small and Mediumsized Enterprise (MSME) Conference April 16-18, 2019 at the Jamaica Pegasus Hotel. As with the previous conference held in 2017, the organizers envisage the participation of a broad mix of stakeholders, particularly business owners, innovators, regulators, buyers and sellers of goods and services who will be networking, collaborating, promoting their capabilities and brands, developing new business and outsourcing opportunities.

Our Inaugural Regional MSME Conference in 2017 was successful in hosting 185 participants, 62 of which represented 28 countries from across the region.

It is the belief that most successful businesses, small, medium, and large alike, are inexorably linked to challenges at different stages from concept to the agile stage of growth. As such, the organizers are convinced that scheduled pre- Conference presentations and discussions of three (3) business success stories will be useful as a contextual lead-up to the Conference. The selection process will be a collaborative effort between the Conference Planning Committee and partners.

OBIECTIVES

Our objectives for this year's conference include:

- · Facilitating exposure to new trends in business development and management
- Promoting success stories among MSMEs
- Examining MSME policy within a context of macro-economic strategy and its impact on business profitability
- Providing a forum for B2B interaction to explore opportunities for national, regional and international business collaboration/linkages
- Exposing participants to new technologies and research and development in agriculture as well as climate smart innovation



B2B

One of the indicators of success that was gleaned from the Inaugural Conference Survey(2017) was the effective execution of a Business-to-Business (B2B) event. Fundamentally a B2B matchmaking event will pair interested companies from across the region and arrange one-toone meetings. This year the B2B event will be focussed on tourism linkages particularly in agriculture and services. The information obtained from this event will be useful to inform the region of emerging innovative ideations and how best to support business opportunities.

Policy

The MSME policy environment is changing rapidly and it is important for participants to be aware of key initiatives and changes at both the policy and regulatory level as well as becoming aware of innovations driven by the private sector.

A fourth activity which is integral for the success of the conference is the promotion of success stories which will be pre-selected from across the region. They will be promoted through social media and other means and will serve as a source of inspiration and knowledge for those participating in the conference.

Throughout the conference a cadre of specialists and advisors will make themselves available as volunteers who will enhance the learning experience of conference participants.

This year's Regional Conference will be prescriptive in promoting cross-border cooperation and links between upper-tier enterprises and SME's. As such, the B2B forum for buyers and sellers of goods and services will be introduced as an additional feature of this year's conference. This intentional aspect is essentially to ensure that the interaction of these enterprises are not left to chance as we are desirous of seeing the execution of a structured and pre-emptive matchmaking approach.
