Memorandum of Understanding (MoU)

Between Combine Foundation and NGAS

Background

Combine Foundation is a non-profit organization (NPO) focused on educational advancement, skill development, and community engagement. The Foundation conducts workshops, mentorship sessions, and structured learning programs aimed at equipping students with practical and future-ready skills.

NED Girls' Affairs Society (NGAS) is a student-led organization dedicated to women empowerment, leadership development, and community engagement through impactful events and initiatives.

This collaboration is established to empower female students through skill-based learning, mentorship, and professional development opportunities.

Purpose of the MoU

This MoU outlines the mutual intention of Combine Foundation and NGAS to collaborate in areas related to student development, women empowerment, and educational growth.

The primary purpose is to provide NGAS members with access to professional learning opportunities, mentorship, and collaborative events that contribute to their personal and professional growth.

Objectives

- To promote skill development and professional growth among NGAS members.
- To support women empowerment through education and practical exposure
- To provide selected NGAS members with free course enrollment opportunities.
- To strengthen outreach and impact through joint initiatives and collaborations.

Areas of Collaboration

- Co-organizing workshops related to skills, professional development, health awareness, and community engagement.
- Providing mentorship and business-oriented sessions for NGAS members.
- Offering free course enrollment to selected NGAS members (2–3 students).

- Providing Zoom platform access for hosting large-scale online events (300+ participants).
- Designing customized courses aligned with NGAS's focus areas.

Responsibilities of Combine Foundation

- Facilitate and manage events, workshops, and webinars.
- Provide access to mentors, speakers, and professional network.
- Provide Zoom platform subscription for virtual events.
- Offer free course enrollment to selected NGAS members.
- Design customized courses based on NGAS needs.

Responsibilities of NGAS

- Promote Combine Foundation's initiatives through social media (minimum 2 videos).
- Support event organization through student mobilization and participation.
- Share promotional content within its network.
- Facilitate connections with the student community.
- Provide updates on upcoming events for collaboration opportunities.

Duration and Termination

- This MoU shall remain in effect for One (01) year from the date of signing and may be extended upon mutual agreement.
- Either party may terminate this MoU with 30 days' written notice.

General Provisions

- This MoU does not create any legally binding financial obligation but serves as a framework for cooperation and mutual understanding.
- Any specific activity requiring detailed planning shall be documented separately if required.
