Privacy Policy for Studiloo

Studiloo ("we," "us," "our") provides a Chrome extension designed to help users analyze webpage content and receive study-assistance responses. This Privacy Policy explains how we collect, use, store, and protect your information when you use the Studiloo Chrome Extension ("Extension").

By using the Extension, you agree to the practices described in this Privacy Policy.

1. Information We Collect

We collect only the information necessary to authenticate users and provide the core functionality of the Extension.

1.1. Information You Provide Directly

- **Email Address:** Used to create and manage your account through Firebase Authentication.
- **Password:** Processed securely by Firebase Authentication. We do not access, handle, or store your password.

1.2. Information Collected Through Your Use of the Extension

• Page Content Captured on Demand:

When you click the "Send Page Content" or similar button, the extension extracts visible text from the current webpage and sends it to our backend API for processing.

This action occurs only when you explicitly trigger it and is never performed automatically or in the background.

Authentication Token:

A secure Firebase-generated token is used to verify your identity when communicating with our backend services.

1.3. Technical Data

We may collect limited technical information such as:

- Browser version
- Extension version

• Basic diagnostic information for troubleshooting

We do not collect browsing history, keystrokes, or continuous background activity.

2. How We Use Your Information

We use collected information solely for the following purposes:

1. Authentication:

To log you in, validate your identity, and maintain your account.

2. Service Functionality:

To analyze webpage content you explicitly choose to send and return AI-generated study results.

3. Service Maintenance and Improvement:

To fix errors, improve performance, and maintain the overall quality of the Extension.

We do not use your information for advertising, profiling, or unrelated purposes.

3. Data Sharing

We share data only with the following service providers:

3.1. Firebase

Used for secure authentication and account management.

3.2. Backend API and AI Processing Services

Used to process the text you choose to submit and generate responses.

We do not sell, rent, or disclose user data to third parties for marketing, analytics, or unrelated purposes.

4. Data Security

We use industry-standard security measures, including:

- HTTPS and TLS encryption
- Secure token-based authentication

- Access controls
- Encrypted connections

While no system is completely secure, we take appropriate steps to protect your information.

5. Data Retention and Deletion

We retain:

- Your account information until you request deletion
- Submitted page content only as long as required to generate the requested output or provide the service

We will process deletion requests within a reasonable timeframe.

6. Children's Privacy

Studiloo is not intended for children under 13 years of age.

We do not knowingly collect information from children under 13.
