Camping at Kenilworth Homestead

A general booking attracts full payment and is <u>non-refundable</u>, however is transferrable to an alternative date outside peak holiday periods. Please note peak holiday rates (e.g. Easter, Christmas and Long Weekends) apply and therefore transferred bookings may not be possible at peak times and may attract an incremental payment.

CAMPING RULES

To help us make your (and others') stay the best possible, please observe the following:

- A strict 10:30pm noise curfew applies AT ALL TIMES. All music and noise must cease at this time.
- All campers under the age of 18 MUST be accompanied by a parent or legal guardian at all times. Photo identity must be provided upon request.
- We are a family friendly campground and request that people behave and speak with respect and courtesy towards others at all times.
- All speed limits must be followed whilst driving on the property. The speed limit is 10km/ph unless otherwise indicated.
- No unlicensed vehicles are to be driven on the property. Queensland driving regulations apply and unlawful activities related to driving offences will be reported to the police, including driving of vehicles by unlicensed youths/adults.
- We welcome family pets. To ensure a safe stay, we require <u>all pets must be under owners control at all times and kept on a lead</u>. Pets must not be left unattended at any time. All pet waste must be collected immediately and disposed of using appropriate bags and placed in the skip bins. Owners are liable for any damages or injuries caused by their pet during their stay and will be asked to leave the property if pets are unrestrained or cause incident.
- Generator hours: 8am-10am & 4pm–6pm ONLY

- Children must be under parent supervision at all times, including the visitation of property animals.
- ALL BUILDINGS, INCLUDING SHEDS, AND FENCED PADDOCKS ARE OUT OF BOUNDS, irrespective of whether the paddocks are vacant or holding animals.
- All Rubbish must be removed from your camp site. Skip bins are provided for rubbish disposal.
- For the safety of all campers, especially children, we require <u>ALL campfires to be completely extinguished before you retire each evening</u>. Fire circles must be completely dismantled before departure.
- The Mary River is a great place to cool off, however please be aware this river may contain debris, particularly following heavy rain and flooding. Extra precautions are recommended at all times. E.g. the wearing of footwear. Take care as there are deep holes and undercurrents. Swimming and paddling is at your own risk. Adult supervision is always required. Safety and first aid is your responsibility whenever you are using the waterways.
- Please be aware <u>PATRONS ARE REQUIRED TO USE A PERSONAL FLOTATION DEVICE (PDF)</u> at all times when using hire vessels.
- Please be aware the Mary River can rise suddenly. If you are ask to evacuate it is for your own safety so please comply with requests without question or hesitation.
