

Artist's Statement

Death truly is my art. I specialize in visual, written and performance art and all aspects of its creation including costume design, set design, prop creation and theatrical writing, and am currently using Gas Light Players theater and its Haunted Attraction, Gentleman Death's Shocktale Show, as a venue for my creations.

Shocktale is presented using a unique progressive black-box theater setting which stays true to the Grand Guignol style of theater, which presents a very real, immersive experience for the patron. This allows me to explore the various aspects of fears, phobias and all things psychological.

Being Mum to triplets and a teen, I tend to relate to sideshow and circus themes and my visual, written and performance art reflect these influences heavily.

I use a unique guided style of haunted attraction for Shocktale that was created locally back in 1975 especially for Gas Light Players by Drew Edward Hunter, known affectionately as "Dr. Blood" to the Shreveport-Bossier patrons. This allows me to carry on a longtime Shreveport-Bossier area tradition each fall.

In this way, I am able to reach beyond the traditional art-seeking patron-base into a broader demographic of audience. My audience may find themselves lured in by their morbid curiosity, but they find themselves immersed within an interactive and theatrical artistic experience.

I am a professional artist, working within the community theater and haunt industry where I am able to express myself creatively using a wide range of techniques whether it be scripting for the stage, costuming haunt-icon characters created especially for Gas Light Players annual Shocktale Show, or even creating props and scenery out of up-cycled media.

I have been an active part of the local community theater Gas Light Players since 1989, performing in various aspects and roles within the theater and currently serve as President of the Board as well as Writer, Director and Designer of the theater's haunted attraction.

Festival performance art is also one of my favorite venues. I have performed at Four Winds Renaissance Festival as well as served as their Casting Director from spring of 1997-2000, moving on to performances with Scarborough Faire and later as a paid performer with Texas Renaissance Festival Performance Company. Currently I can be seen at the State Fair of Louisiana as "The Artist" who creates Gentleman Death's Shocktale Show, performing in front of Gas Light Players Box Office during the Fair.

I have been involved within the Haunt Industry since 1989, beginning as a cast member with Gas Light Player's Terror Show. Also, I have worked nationally with the Chateau du Macabre and The Dungeon attractions.

As of 2007, I chose to focus on Gas Light Players unique show, immersing myself into all aspects of it where I currently script, direct and creates costumes, props and scenery each year.

Death truly has become my art as I enjoy not only writing in the unique style of the Dr. Blood shows but also creating the various unique characters and art to display within the haunted attraction itself. Photographing my scene design and pieces has also become a passion of mine as I document each year of the show.

From 2007-2011, I also have had the pleasure of writing anecdotes of my children's antics and shared Mommie advice for RedRiverMomsLikeMe.com. As Mother to 6 year old triplets and a Teen, I have had several of my pieces published locally in the sister magazine Red River Moms and a few also printed in our local paper, The Shreveport Times.

My work with Gas Light Players Shocktale Show will be featured in the upcoming book by Bonnye Stuart, "Louisiana Curiosities: Quirky Characters, Roadside Oddities and Other Offbeat Stuff due out in November, 2012.

I am also president of Gas Light Players, a local community theater we have just recently resurrected. And then I do freelance writing for the stage and local publications.

How long have you been working with MomsLikeMe.com?: Since right before it

launched originally as RedRiverMoms.com. It's been awhile; my triplets were only a few months old and now they are almost 3.

Number of kids, ages, names: I have four: Bregon is 14 now and Kaiden, Kian and Vivienne will be 3 in March.

In addition to being a mother, what do you like doing?: Community theater, stage work, haunted attractions, renaissance festivals, writing, directing, acting, sewing, literature, art and music.

What funny things are your children doing now at this age?: My eldest just started competition fencing, with his first tournament being the qualifiers for Junior Olympics earlier in December. My triplets never have a dull moment. They think they have a sandbox in the living room (adults would consider this a fireplace) and one of my tiny trio would really like to fly — so much so that he tries to swing from the dining room chandelier (he is responsible for us having to raise it). She will even stop to try and soothe her baby should she start crying on the way up.

Kian starts saying his "Hi Daddees" at the bottom landing just in case he has to rush up the stairs to try and beat his brother to the top, just so he doesn't forget!

Triple Giggles, Triple Terror!

Hearing your baby giggle for the first time is almost as priceless as the first time they look at you and smile.

My husband and I have triplets, which means three different giggles to enjoy.

Kian's is warm and fuzzy and has a little bit of a growl to it. Vivie's is light and airy and full of mischief. And Kai's is just an outright guffaw as he puts every bit of emotion he has into it.

Once upon a time, my husband and I used to tickle their tiny tummies just to hear them giggle. Now, though, I've learned those tiny

baby giggles often mean trouble.

My kids love to revel in each other's misfortune and their giggles often signify that one of them is in a compromising position.

You have to remember that most multiples are born with a means of communication amongst themselves. Experts say they have their own language, and there are sets of multiples out there who are now adults who've confirmed this to be true. My kids will often sit in a triangle in their playyard quite obviously having a conversation amongst themselves.

I cannot always understand them, but they seem to find each other hysterically funny.

Then there are the days when I feel like an outsider because all of the sudden that conversation will stop and all three sets of little eyes will be staring up at me as if I am interrupting something. I may be overreacting, but it seems like they are giggling at me as they go back to their little conversation.

These conversations are the basis of what triplet terror really is. Having triplets is much different than having kids of different, yet close ages. Multiples have an uncanny ability of working together, sometimes in silence, to achieve a common goal.

Often times, their endeavors involve working together to build piles of toys that serve as stairs to

either escape their playyard or retrieve a toy put up out of their reach for one reason or another.

I am sure they have their reasons, but as a mom, I also have mine, which is generally their

safety. It's those giggles that are the

most frightening.

Sometimes a bad case of the giggles can just mean that Kian was gullible again and lost the tantalizing game of Let's Throw Everything Out of Our Crib into the Center of the Nursery.

The object of the game, of course, is to fool your sibling into emptying the entire contents of their bed onto the floor so they have nothing left to play with.

All the while, the initiating sibling only appears to energetically race you to the finish while secretly stockpiling a favorite toy or two in the front corner of the bed, hidden by the baby bumpers.

The winners get to sit and giggle at the loser, who is now terribly

Watching Kai try to pick up the super-huge cloth covered ball that's almost the same height as he is can be very amusing. He often does this whole "atlas" thing, where he picks it up with both hands and raises it over his head before trying to toss it over the rail.

Then there are the mischievous little giggles that occur usually while the babies are having lunch or dinner. This giggle is accompanied by one or more of them saying, "Kitty Cat!" over and over again.

If I am quick enough, I usually catch them holding out bits of meat to lure the animals over to their feeding chairs so they can pull on the poor creatures' tails and ears. They really do love their cats and the dog, but I'm not too certain the cats and dog really appreciate those extra weighted tidbits the babies are offering.

Don't get me wrong, I do love to hear my babies giggle. It's just that I've learned that in my house, those haunting giggles usually mean trouble is brewing and I had best be very vigilant with the babies.

I never know what they will come up with next.

This Is a Potty Emergency!



We've covered the fact that our triplet stroller is unusually long and verysuperhuge, making public appearances very awkward.

We decided to try an outing to the museum last summer while in New Orleans visiting family.

Being babies, of course the need arises to have to change them at some point and of course it's never in a convenient and appropriate place. This time it was smack dab in the dividing line between the Ansel Adams exhibit and the Hurricane Katrina Photography exhibit.

Now, there was this very nice leather-looking chaise-lounge piece of furniture in the middle area that looked very inviting, but being in a part of the museum

that was as quiet as a church sanctuary due to the content and seriousness of the subject matter, I had decided that this was NOT the place to change our panties and britches.

My aunt and I decided to demurely head for the nearest restroom. NOMA appears to have been built quite a long time ago, as the handicap allocations are mostly out of place (they are there, but hard to access) and the bathrooms would reflect this, unfortunately.


