

# MOBILE APPLICATION TERMS & CONDITIONS

***PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY***

## **1. AGREEMENT TO TERMS**

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Tata BlueScope Steel Limited (“we,” “us” or “our”), concerning your access to and use of the Mobile Application related, linked, or otherwise connected thereto (collectively, the “Application”). You agree that by accessing the Application, you have read, understood, and agree to be bound by all of these Terms and Conditions of Use. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS and CONDITIONS, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE APPLICATION AND YOU MUST DISCONTINUE THE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Application from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms and Conditions at any time and for any reason. You waive any right to receive specific notice of each such change. It is your responsibility to periodically review these Terms and Conditions to stay informed of updates. You will be subjected to, and will be deemed to have been made aware of and to have accepted, the changes in any revised Terms and Conditions by your continued use of the Application after the date such revised Terms are posted.

The seat of the arbitration shall be Pune and conducted in English language. The Parties shall bear their own cost for Arbitration including the fees paid to Attorneys and shall bear equally the charges to be paid to the Arbitration Panel. The Award of Arbitration shall be binding on the Parties.

## **23.CORRECTIONS**

There may be information on the Application that contains typographical errors, inaccuracies, or omissions that may relate to the Application, including descriptions, pricing, availability, and various other information.
