# COMPETITOR DETAILS & REQUIREMENTS

Each competition must be conducted in accordance with the FEI rules and applicable USEF rules. Entry into the competition represents acknowledgement and acceptance, with no appeal, to these competition rules for all classes.

## ENTRIES

A separate entry form (online, print, email) must be filled out for each horse. Each entry must be signed by the owner, rider, trainer, and coach (if applicable) and said signature shall constitute verification that the information contained thereon is accurate to the best of the signer's knowledge and belief.

Deposit must be paid with each entry, and an open check or credit card must be on file in the show office before back numbers are issued.

Entries and Stalls will be limited. Competitors are encouraged to get their entries in early. Entries received after the show is sold out of stalls will be placed on a waitlist in order of received entries. Late entries (received after the closing date) will be charged a \$50 late entry fee. Under extreme circumstances, management reserves the right to accept or deny any entry.

Any entry scratched after the closing date is responsible for stabling fees. Under certain circumstances and/or veterinary verification letter, SRJT Management reserves the right to enforce or waive fees.

All horses must pay an office fee of \$75. This office fee also permits each horse to properly add/scratch regular classes. There are no same day adds, but classes may be scratched in the office prior to the start of the class. Scratching at the in-gate does not scratch the class and the class fee will still be charged. If a horse is shown in a class it was not properly entered in, it will be charged a \$25 Ride Did Not Enter (RDNE) fee in addition to the class fee. Entries can be done by 3pm through the app or in the office until 4pm.

## NIGHTWATCH

All horses occupying a stall will be required to pay a flat night watch fee of \$15. No exceptions. Please provide contact name and cell phone number on the stall.

All horses are required to pay a Paramedic Fee of \$20 and a Horse Ambulance fee of \$15. No exceptions.

## NON-SHOWING

All horses on the grounds must have a completed entry in the office, complete with signatures. Non-show horses must pay for the office, nightwatch, paramedic, and horse ambulance fees as their non-showing fee. Scratched horses present on the grounds are considered non-showing.

## MOVE IN/OUT

Move in for the Denver International will be Monday July 19 at 10am. Move out is Monday July 26 at 8am.

Horses arriving early or staying late will pay \$50 per stall per night (exception - horses that were showing at the previous week's LEG show will not pay early arrival). Please contact Kaitlin if you would like to arrive early or stay late so arrangements can be made. Horses must come in through Gate 1, 7375 Bayou Gulch.

## CHECKOUT

Accounts must be closed out by Sunday, July 25. If you wish the office to fill out your check or run your card, we will be happy to. Please leave instructions as to which card/check covers which horse(s). Starting Sunday morning, checking out through the app will be available. Please look over your statement and report any errors to a secretary immediately as to horse's name, riders, owners, addresses, associations numbers, etc. Please double check that the Payee for prize money is correct with the correct address.

## PRIZE MONEY

Prize money is NOT applied to the invoice at the show. All prize money is mailed within thirty (30) days of the conclusion of the show to the owner listed on the entry form, or the Payee if given. Prize money will only be mailed if the owner's or payee's W-9 Form is on file with the show office, and all balances are paid. Foreign competitors must include a U.S. Tax ID Number on their entry form or will be asked to complete a W-8BEN or W-8 Certificate of Foreign Status Form.

## ORDER OF GO

All classes in the main ring will have set orders of go. Unless specified, Ring 2 and the Hunter Ring will run by check in, which can be done at the in-gate or through the app. Orders of Go are produced in accordance with JP 112. Orders of Go are available at the Show Office, at the Ring, and on the App. Orders for certain classes may be available at the entrance of the Hospitality Tent.

## SALUTE

Upon entrance into the arena for each class, all riders must salute the Class Sponsor (if applicable).



## PRIZE CEREMONY

All riders and horses receiving ribbons 1st-8th place are Required to be present and participate in all prize ceremonies. This applies to National Jumper and FEI classes. Grooms for the top three(3) placing horses of each class will accompany the competitor/horse onto the field to be present to hold the horse during the rider podium portion of the ceremony. Please note: for the safety of

all horses, competitors, and spectators, plan for an alternate mount if your placing horse is unsuitable to participate in ceremonies and victory gallops. Top 3 placing Hunter horses and riders must be available for award ceremonies. See specs for special Hunter classes regarding riding for ribbons.

## LEASH LAW

Dogs must be on a leash and under control at all times. Dog owners who fail to comply with the USEF rules regarding dogs may be subject to penalty, including \$100 fine per incident, and/or warning cards issued. Dog owners are solely responsible for any damages, claims, losses, or actions resulting from their dog's behavior.

## MOTORIZED VEHICLES

Golf carts must stay off horse path. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.

Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

## LIABILITY

Under Colorado law, a farm animal activity sponsor, farm animal professional, or other person does not have the duty to eliminate all risks of injury of participation in farm animal activities. Split Rock Jumping Tour, its owner, employees, agents and sponsors shall not be liable or responsible for loss or damage to any animal, person, or property which occurs for any reason during the show. Each exhibitor holds the SRJT Show Management, its owners, agents, employees, as well as the USEF blameless for any accident or loss which may occur.

## VETERINARY & HEALTH REQUIREMENTS

A negative Coggins dated within 1 year and a veterinary health cert within 30 days are required for entry onto the Colorado Horse Park grounds. Proof of vaccination for Equine Influenza and EHV 1/4 within 180 days must be presented. Horses may not have shown symptoms, been treated for, or been at a facility under quarantine for or exposed to horses showing symptoms of EHV 1/4 in the last 28 days. Paperwork must be in the horse's Show Name.



## HORSE HEALTH INFORMATION

We strongly recommend all horses stabling on the Colorado Horse Park Grounds arrive between 8:00 a.m. and 5:00 p.m. If it is necessary to arrive at any other time you must make arrangements prior to arrival.

Exhibitors, especially those traveling long distances, can contribute to that healthy environment by adhering to the following requirements for entry to facility:

- 1.** A current negative Coggins test is required for all horses entering the facility. Please renew before it expires, and not just before it is necessary to leave the state.
- 2.** Statement of Health/Veterinary Health Certificate signed by a licensed veterinarian within 30 days of arrival at CHP, documenting that the horse has:
  - A.** Received regular and consistent vaccination against Equine Influenza and EHV 1 & 4 with the most recent booster being within 180 days. Written Statements from Vet explaining reasons for being bolstered within 180 Days MAY be accepted. IN NO CASES MAY THE BOOSTER BE OUTSIDE OF 180 DAYS. Horses not in compliance with this rule may be denied entry to the competition grounds upon request by Management.
  - B.** Not shown symptoms of or been treated for EHV-4/1 within the past 28 days.
  - C.** Not been at a facility under quarantine for EHV-4/1 or exposed to any horses showing symptoms of EHV-4/1 within the past 28 days.
- 3.** Current vaccination against WNV, EEE, WEE, Tetanus. Rabies is strongly recommended.
- 4.** You should be able to document your horse's normal temperature before arrival. Please do not ship horses with elevated temperatures. It is recommended that you establish a log of temperatures taken at least twice daily. Any horse on the show grounds with a fever of unknown origin or of suspicious origin must be reported to LEG Horse Shows and Events Management and the Official Veterinarian. It is always better to err on the side of safety. Isolation stalls will be available on the grounds and/or at a local veterinary practice if the need arises.
- 5.** Every effort should be made to minimize stress and commingling of horses shipped long distances. Extra horses on a horse van, or moving from stable to stable is the fastest way to compromise your horse's and your neighbor's horse's health.
- 6.** Please take the time to review equine good hygiene practices and impress its importance to your groom in everyday care.
- 7.** All paperwork must be in the horse's show name.

When doing online entries at [entries.equestrian.digital](http://entries.equestrian.digital), there are two options. You can create a trainer account here to reserve tack stalls, or enter horses. The online system will automatically run all horse deposits on the credit card(s) entered. A credit card is required for trainer account reservations, but it will not be run.

A third option is the following Stable Request Form. This can be mailed or emailed in to Kaitlin. An open check or card must accompany the form. You must still send in horse entry blanks separately, before the close of entries, but they can be at a later date. You can fill in slots (Horse 1, Slot 2, etc) or simply put the total number of stalls, horse stalls or tack stalls. Care should be taken that the same stall is not reserved multiple times, and stall counts will be confirmed prior to the closing date of entries. This form is binding after the closing date of entries, and stalls will be charged accordingly unless adjustments are made prior to July 12.

Stalls are non-refundable after the closing date of entries (July 12, 2021). Horses may be substituted until the Monday of the show at no additional charge.

# DIRECTIONS TO THE PARK

**FROM INTERSTATE 25:** Turn east on Colorado 470 (tolls) or Lincoln Avenue (no tolls) about 4 miles to Route 83, also known as Parker Road. Go South, through the town of Parker. Continue to Bayou Gulch Road. Turn left, pass Ponderosa High School, and you will see the show entrance on your left.

**FROM INTERSTATE 70, EASTBOUND:** Take Colorado 470 (tolls) (this exit occurs just as you have almost ended your descent through the foothills) until you reach Route 83 or Parker Road. Then follow directions listed above.

**FROM INTERSTATE 70, WESTBOUND:** Turn west on Route 86, just west of Limon. Go to Franktown intersection and turn north (right) at Route 83 or Parker Road. Travel approximately three miles and turn right on Bayou Gulch Road. The Horse Park will be on your left.



# RULES & REGULATIONS

## ORGANIZING COMMITTEE DECISIONS

It is important to understand that interpretations of existing rules and regulations and the invoking of additional rules and regulations to cover unforeseen circumstances are the sole responsibility and authority with, and with the approval of the Ground Jury and that all owner, trainer, chiefs, competitors, and grooms agree to the acceptance of these interpretations and additional rulings by virtue of your participation. Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to cancel any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the the time schedule or as competition warrants, or make any changes management deems is in the best interest of the show and its exhibitors.

## USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides.

A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

## USEF

Every class offered herein, which is covered by the rules and specifications of the current United States Equestrian rule book will be conducted and judged in accordance therewith. Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy,

and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org).

Each horse will be charged a USEF fee of \$23 per competition (\$15 Drugs and Medication, \$8 USEF) and \$7 fee for USHJA. Anyone who is not a member of USEF and/or USHJA will be charged a \$45 show pass fee by USEF and a \$30 Show Pass Fee by USHJA. Owners, riders, and trainers must be Active Competing members of the USEF and USHJA, join at the show, or pay the listed Show Pass Fees. Farms, Partnerships (etc.) owning a horse competing in USEF licensed competition must be Recorded with USEF, and one recorded owner of the entity must have a current USHJA competing membership. Foreign owners, riders, and trainers must provide a copy in English that they are a member in good standing of their national federation. Riders showing in classes restricted to Junior, Amateur, or Adults must present their membership card or other documentation indicating their Junior or Amateur status. Foreign Amateurs must join USEF and sign for Amateur status. Members of EC must sign for Amateur status but are not required to join USEF. The Exhibitor has the ultimate responsibility for proper registration of horse, owner, rider, and trainer with USEF/USHJA and for entering the horse under proper ownership where points are concerned. All horses competing in any USEF Computer Ranked Grand Prix are subject to the USEF International High-Performance fee in accordance with GR207 at \$35.

Horse must be recorded with USEF annually or in Life in order to be eligible for HOTY Awards and/or Zone Awards. All horses competing in the USEF licensed Hunter/Jumper/Eq competitions must have a Registration number from USHJA. All horses are required to have a microchip recorded with USEF/USHJA.

## **FARRIER**

No farrier other than the official show farrier will be permitted on the grounds unless pre-approved by the SRJT show management.

## **COMBINING, DIVIDING, OR CANCELLING DIVISIONS OR CLASSES**

The Decision to Combine, Cancel or Divide classes will be made at the discretion of the Show Management. The update will be reflected on the App and on the How Many schedule.

**Combining** - Once a class/classic/division has been combined due to insufficient entries, it will not be re-divided for additional entries the day of the class.

**Dividing** - A class/classic/division that has been offered as split may be combined on the day of if scratched entries warrant. Management has the right to run all sections of the class/classic/division in their entirety before pinning if insufficient entries seem likely.

**Cancelling** - A class/classic/division that has been cancelled due to insufficient entries will not be reinstated for additional entries on the day of the class.

Every horse entered for competition will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each

exhibitor shall hold the Horse Show, its members, directors, and employees, contractors, sponsoring entities and facility harmless for any loss or accident to horse, horses or equipment which may occur from sickness, fire or otherwise.

## **ANIMAL WELFARE**

Manual poling or the use of bamboo off-sets is prohibited while on the property. Violators will be subject to penalty with the automatic elimination of the horse involved from the class it is competing in and/or the succeeding class in which it was entered and will forfeit all entry fees for that class. Riders/trainers who, in the opinion of the Judges or Committee, use a whip or spurs in a cruel or excessive manner will be immediately eliminated from the current and/or succeeding class in which that horse/rider is entered and will forfeit all entry fees for that class. All incidents may be reported by the USEF steward and to the USEF for possible further investigation.

## **FORMAL ATTIRE**

Formal attire is required in all jumper classes. This includes all National and FEI classes. ALL COMPETITORS ARE REQUIRED TO WEAR FORMAL ATTIRE DURING ALL JUMPING COMPETITION CLASSES. White breeches only. JP111.9 - Formal Attire. Dark, muted or similar colored or red (scarlet) are required; white or fawn breeches; a white tie, choker or hunting stock, and a white or lightly colored shirt must be worn. Shirts must have a white collar and white cuffs.

## **PROTECTIVE HEADGEAR**

It is compulsory for all persons at Federation licensed hunter/jumper competitions when

mounted anywhere on the competition grounds to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is the responsibility of the rider, or the parents, guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards and is properly fitted and in good condition.

## **ACCIDENTS INVOLVING COMPETITORS**

GR1317. In the event of a head injury due to a fall/accident at a licensed competition, the competitor may be prohibited from further competition until released by medical personnel. In some cases, the competitor may not return to competition without a signed release from a licensed medical professional. The competitor may be placed on suspension by USEF until a release is provided. Competitors are advised to familiarize themselves with this rule.

## **MARTINGALE**

1.30m or below - no martingale restriction when used in a conventional manner. Classes above 1.30m and all young horse classes may only have running martingales used in a conventional manner. Irish martingales permitted in all classes. Draw reins and German martingales only allowed when schooling or classes 1.20m and below with no prize money, and are not permitted in age restricted classes. Ponies may not be ridden by a junior in draw reins or German martingale at any time.



## **STALLS**

Stalls are permanent with wood walls and dirt floors, or tented with vinyl walls. Tents are 10x10, and Permanent are 10x12.

## **SHARPS**

Anyone found discarding sharps in any other manner than the provided sharps containers will be fined up to \$250 per instance and held responsible for any fines or expenses incurred by management.

## **ENTRIES**

Last date for substitutions is Monday before the show. Exhibitors are responsible for the fees of all horses entered by them or their agents.

Failure to check out will incur a \$50 late check out fee. All statements become final at the close of business on Sunday. Disputes will not be allowed after this time. Management has permission to close out any outstanding balances with payment information provided. Trainers will be held financially responsible for any clients who do not submit viable payment in a timely manner, including late fees.

Trainers may split miscellaneous items to their clients. Splits will be accepted until noon on the Friday of the show week. Splits will revert back to the trainer for payment if uncollected.

The prices in this catalogue reflect a Discount for paying by Cash, Check or other means not involving a credit card. A Retail Price catalogue is available upon request.

All foreign competitor balances must be paid in cash, check drawn on a US bank, or credit card using US funds. Checks returned by the bank and credit card chargebacks will sustain a 10% or \$50 penalty, whichever is greater. If not sufficiently paid in 10 days, accounts will be turned over to the USEF.

A new W-9 form is required for each calendar year. As per FEI regulations, Split Rock Jumping Tour is required to issue all tax forms to the owner, regardless as to whom the prize money is paid. Foreign competitors must provide a US Tax ID Number, W-9 or their applicable W-8BEN/W-8BEN-E.

## **SCHOOLING AND WARM UP**

The designated schooling arena for the competition will be restricted to only horses warming up to compete in said classes. Horses wishing to school at times other than their designated competition warm up time must use the arena(s) posted for open flatting/schooling. SRJT management reserves the right to change schooling locations and times to best suit competition arenas due to conditions/weather/schedule.

## **TIES**

All ties in jumper competition will be broken on the basis of time in accordance with the FEI and USEF rules. Hunter and Equitation ties will be kept or left in accordance with the applicable USEF, USHJA or Zone rules.

## **EQUITATION**

Equitation riders must ride the horse and wear the number of the horse they have entered to

ride. There is no penalty for the rider to scratch an equitation class from one horse and add it on another horse. Exhibitors who enter an equitation class on one horse and ride or wear another horse's number will be charged on both horses.

## **FEI INSPECTIONS & STABLING**

All horses must be on grounds by 10 am (EST) Wednesday. The FEI Inspection will be held at 4:00 pm (EST) on Wednesday. If necessary, any re-inspections will be held at 7 am (EST) on Thursday.

## **FEI FEES FOR HORSES & RIDERS**

As approved at the 2006 General Assembly, an annual FEI registration is now mandatory for all riders and horses competing in FEI events. The fee requirement took effect January 1, 2006 and must be renewed annually. All horses and riders must be registered with the FEI before competing in any 2019 FEI competition.

## **FEI HORSE PASSPORTS**

Every horse entered for any competition at CSNs or CSI\*/\*\* in a foreign country, all horses entered for other CSI\*\*/\*\*\*\*/\*\*\*\*\*, CSIOs, Championships, Regional, and Olympic Games whether at home or in foreign countries must have an official, valid, FEI passport, or a National passport approved by the FEI accompanied by a FEI Recognition Card, as a means of identification and to establish ownership.

# FEI RULES AND REGULATIONS

## ALL SECTIONS WILL ADHERE TO FEI RULES & REGULATIONS

**1.** The Santa Fe International will be conducted in accordance with: FEI Statutes (23rd Edition, effective November 7, 2013); FEI General Regulations (23rd Edition, effective January 1, 2014); FEI Veterinary Regulations (13th Edition, effective January 1, 2014); FEI Rules for Jumping Events and its Annexes (24th Edition, effective January 1, 2014); FEI Anti-Doping Rules for Human Athletes (3rd Edition, effective January 1, 2014); and all subsequent revisions to the above Rules and Regulations which will take precedence. An arbitration procedure is provided for the FEI statutes and General Regulations as referred above. In accordance with this procedure, any appeal against a decision rendered by the FEI or its official bodies must be settled exclusively by the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland.

**2.** Horses which lose a shoe prior to starting in the initial round of a one round competition with a jump-off will be given a later starting position. In a jump-off, a horse that loses a shoe prior to starting will be given a new starting place three positions later. If the horse in question has not had its shoe replaced by that time, the Ground Jury will decide whether, at its discretion, the horse in question should receive a later starting place or be eliminated (Article 245.5).

**3.** Ownership information listed in the passport (and therefore registered with the appropriate Federation) is considered correct. If there are any issues with, or corrections to, the address/ownership shown in your horse's passport, you must bring these to the attention of the Show Secretary for a ruling by the organizing Committee by 5pm of the day prior to the start of the tournament to exempt you from Withholding Tax.

**4.** Competitors may carry the logo of their personal sponsor on the saddle cloth. The Chief Steward is responsible for ensuring the FEI regulations relating to Article 135 are respected by riders before entering the arena. Competitors not complying with Article 135 will not be permitted to enter the arena during competition.

**5.** In exceptional circumstances, together with the approval of the Chefs d'Equipe and the Ground Jury, the Organizing Committee reserves the right to modify the show schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all Competitors and Officials as soon as possible and they must be reported to the Secretary General by the Foreign Judge.

**6.** Competitors are responsible for saluting to the Ground Jury and Sponsors upon entering the competitive ring.

- The safety and effectiveness of *Restylane*<sup>®</sup> *Silk* for areas other than the lips and perioral area have not been evaluated in clinical studies.

- Tell your doctor if you have any history of scarring, particularly thick and stiff scars, or any pigmentation (skin color disorders). These side effects can occur with hyaluronic acid fillers in general.
- Tell your doctor if you are planning other laser treatments or a chemical peel, as there is a possible risk of inflammation at the treatment site if these procedures are performed after treatment
- Patients who experience skin injury near the site of injection with these products may be at a higher risk for side effects
- Tell your doctor if you are on any medications to decrease your body's immune response (immunosuppressive therapy). Using these medications may increase your risk of bruising or bleeding at the gel injection site.
- Tell your doctor if you are using any "blood thinners" such as aspirin, warfarin, or any other medications that affect bleeding. Using these medications may increase your risk of bruising or bleeding at the gel injection site.
- The use of these products on gel injection sites with skin sores, pimples, rashes, hives, cysts, or infections should be postponed until healing is complete. Use of product in these areas could delay healing or make your skin problems worse.
- Tell your doctor if you have diseases, injuries, or disabilities of the hand.

#### What are the possible side effects?

The most commonly observed side effects are swelling, redness, pain, bruising, headache, tenderness, lump formation, itching at the injection site, and impaired hand function. These are typically mild in severity and typically resolve in less than 7 days in nasolabial folds and less than 14 days in lips. Serious but rare side effects include delayed onset infections, recurrence of herpetic eruptions, and superficial necrosis at the injection site.

One of the risks with using this product is unintentional injection into a blood vessel. The chances of this happening are very small, but if it does happen, the complications can be serious, and may be permanent. These complications, which have been reported for facial injections, can include vision abnormalities, blindness, stroke, temporary scabs, or permanent scarring of the skin.

As with all skin injection procedures, there is a risk of infection.

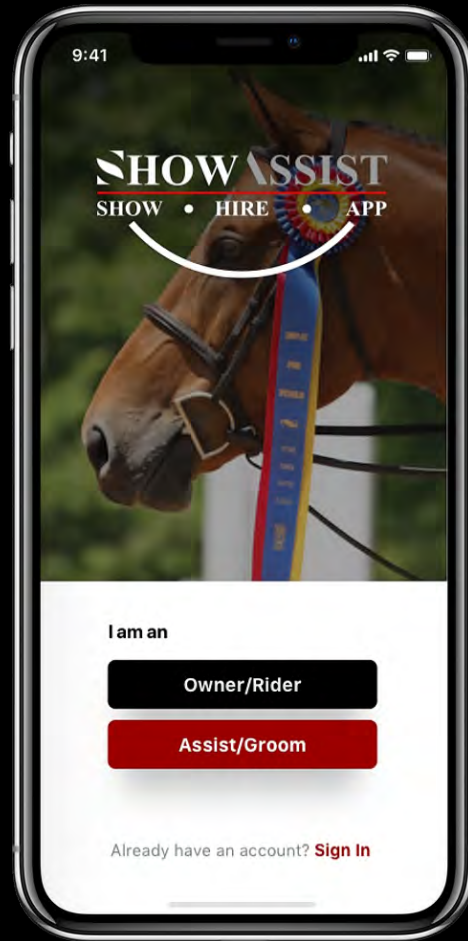
