Debbie Gardner presented the MACOG Financial Reports for December 2019 and January 2020. She explained that the reports are cumulative with the exception of the monthly disbursements report; she reviewed the disbursement amounts for each month. Gardner then reviewed the fiscal year-to-date total expenses and the cash balance at the end of January 2020. She asked if there were any questions. Hearing none, Gardner requested the Policy Board's approval of the December and January Financial Reports.

A MOTION WAS MADE BY SUZANNE WEIRICK AND SECONDED BY DEBORAH FLEMING TO APPROVE THE DECEMBER 2019 AND JANUARY 2020 FINANCIAL REPORTS. THE MOTION CARRIED.

James Turnwald made the Policy Board aware that the State Board of Accounts has started the MACOG Fiscal Year 2019 audit.

A MOTION WAS MADE BY JOSEPH THALLEMER AND SECONDED BY DEBORAH FLEMING TO APPROVE RESOLUTIONS 07-20, 08-20, IN ADDITION, 09-20, ENDORSED ELECTRONICALLY IN FEBRUARY. THE MOTION CARRIED.

NEW BUSINESS

Amendments to the State Fiscal Year (SFY) 2020-2024 Transportation Improvement Program (TIP)

Transit

Resolution 10-20 – Bus / Rail Apportionment – Urbanized Area Formula Program FY 2019 Bus / Rail Apportionment – FTA Section 5307 Funding Total Apportionment – \$4,324,169

NICTD Rail - \$1,340,492 Transpo - \$2,724,226 Niles DART - \$259,450

Jeremiah Cox presented Resolution 10-20. Section 5307 funds are provided by the Federal Transit Administration (FTA) to urbanized areas with a population of 50,000 or more for transit capital and operating assistance. Annually, MACOG facilitates a meeting with the three transit providers in the South Bend Urbanized Area, as well as the Southwest Michigan Planning Commission, to come to an agreement on how the funds will be distributed. Hearing no questions, Cox requested the Policy Boards approval.

A MOTION WAS MADE BY SUZANNE WEIRICK AND SECONDED BY MARK SENTER TO APPROVE RESOLUTION 10-20. THE MOTION CARRIED.

Joseph Thallemer was interested to know where funding for NICTD's double tracking project was coming from. Kelly Wenger explained NICTD is competing nationally for discretionary grants to

use on the double track project and the apportioned funding received from FTA is used for day-to-day operations and maintenance.

Resolution 11-20 - Rail Apportionment - State of Good Repair FY 2019 Rail Apportionment - FTA Section 5337 Funding Total Apportionment - \$2,846,677 NICTD Rail - \$2,846,677

Cox then presented Resolution 11-20. He explained 5337 funds provide financial assistance for the operation of rail fixed-guideway and high-intensity motorbus public transportation systems. NICTD receives all of the apportionment because they are the only rail provider in the urbanized area.

Hearing no questions regarding this resolution, the Policy Board Chair called for a motion to approve the resolution.

A MOTION WAS MADE BY DEBORAH FLEMING AND SECONDED BY PHIL JENKINS TO APPROVE RESOLUTION 11-20. THE MOTION CARRIED.

Resolution 12-20 - Bus Apportionment - Bus and Bus Facilities

FY 2019 Bus Apportionment – FTA Section 5339 Funding Total Apportionment -- \$ 347,984 Transpo – \$287,564 Niles DART – \$60,420

Section 5339 funding may be used to replace, rehabilitate, and purchase buses and related equipment, as well as bus-related facilities. After presenting Resolution 12-20, Cox asked the Policy Board for any questions. Hearing none, he asked for their endorsement of the resolution.

A MOTION WAS MADE BY MARK SENTER AND SECONDED BY DEBORAH FLEMING TO APPROVE RESOLUTION 12-20. THE MOTION CARRIED.

Resolution 13-20

James Turnwald explained that both certification items being considered for endorsement are annual action items requested from the Policy Board.

• Endorsement of the SFY 2021 Self Certification Statement

Turnwald indicated the Self Certification Statement is part the Unified Planning of Work Program (UPWP). It certifies that MACOG's transportation planning process addresses the major issues in the metropolitan planning area and is it conducted according to all federal requirements. Hearing no questions, Turnwald asked for the Policy Board's endorsement.

A MOTION WAS MADE BY SUZANNE WEIRICK AND SECONDED BY PHIL JENKINS TO ENDORSE THE SFY 2021 SELF CERTIFICATION STATEMENT. THE MOTION CARRIED.

• Endorsement of the Statement Regarding MPO Certification Review by FHWA and INDOT

Turnwald also stated the Statement Regarding Metropolitan Planning Organization (MPO) Certification Review refers to a planning process review conducted every four years by FHWA and INDOT. MACOG's last review was conducted on June 7 and 8, 2016. No corrective actions were identified during the review. MACOG's next review is scheduled to take place this calendar year (2020). Asking if there were any questing and hearing none, Turnwald asked for the Policy Board's endorsement.

A MOTION WAS MADE BY CARY GRONINGER AND SECONDED BY DEBORAH FLEMING TO ENDORSE THE STATEMENT REGARDING MPO CERTIFICAITON REVIEW. THE MOTION CARRIED.

Presentation

NARC Conference

Ernest Wiggins noted he had the opportunity to travel with James Turnwald to Washington DC for the National Association of Regional Councils (NARC) National Conference of Regions. Wiggins asked Turnwald to provide a brief update on the conference.

Turnwald informed the Policy Board that each year, in February, MACOG representatives attend the NARC National Conference of Regions. The Executive Director invites the Chair and First Vice-Chair to attend with him. Conference attendees include MPOs, Councils of Government (COG), their directors and board members, local and state elected officials, and other diverse professionals and peers.

Turnwald indicated the content of the conference begins on Sunday evening, runs through Tuesday, and includes key policy issues, legislative items, and matters affecting local governments, MPOs, and COGs. On Wednesday, attendees participate in meetings with their legislative representatives.

Rod Roberson wanted to know where information form the NARC conference could be found. He noted he would like a summary of key impact areas. Turnwald responded that he will provide information via email.

Ernest Wiggins stated an important item discussed at the conference was the September 30, 2020, expiration date of the FAST Act. (Fixing America's Surface Transportation) The Fast Act is the current federal legislation that provides funding for surface transportation infrastructure and investment including highway, highway and motor vehicle safety, public transportation, motor carrier safety, hazardous materials safety, rail, and research, technology, and statistics programs.

Staff Update

Beacon Community Impact Grant (League Cycling Instructor Seminar)

In partnership with Bike Michiana Coalition and Purdue Extension, MACOG was recently awarded funding through the Beacon Health System Community Impact. The funds will be used to bring the League Cycling Instructor Seminar to the region and offset costs associated with attendance to increase the capacity for teaching bicycle safety and skills classes to all ages.

Partner for Clean Air Luncheon - April 28

The annual Partners for Clean Air luncheon will be held on April 28, from 10:30 AM until 1:00 PM at the Matterhorn in Elkhart. Lunch will be provided.

PRIVILEGE OF THE FLOOR

Joseph Thallemer reported that he will be meeting with Governor Holcomb, together with Mayor Ryan Daniel from Columbia City and INDOT Commissioner, Joe McGuinness, to discuss the future of US 30.

PUBLIC COMMENT - There were no comments.
