Staff Update

State Road Funding Update

House Bill 1002, contains the recommendations from the FIRSST Task Force that was set up to find a long-term funding plan to fix the state's roads and bridges. In February, the State House passed the Bill with some modifications. The primary modification of the bill is to take a portion of the current gasoline sales tax from general operations and apply it entirely to road funding in FY 2018. However, that would leave a \$380 million deficit in the FY 2018 state budget. A cigarette tax was proposed to alleviate the deficit.

The Bill is currently in the Senate. Contrary to the House proposal, Senator McKinley is a large supporter of tolling, rather than using sales tax for funding roads and bridges. Sales tax has long been used as a general fund operation and in the future the House/Senate might deviate those sales tax funds back to general funds. Tolling would easily replenish the \$380 million deficit. The TTAC was encouraged to talk to their local officials concerning the importance of finding an agreeable solution to road funding in Indiana.

Ralph Booker asked what percentage, of the proposed 10 cent fuel tax increase, would go back to local governments. James said it would be roughly a 60-40% split between INDOT and the locals.

Federal Road Funding Update

It is anticipated that the federal government plans to invest one trillion dollars into infrastructure, but it is too early to predict. The initial focus for the new administration is the affordable care act and the budget.

Argos Comprehensive Plan Update

MACOG is entering the final stages of the Argos Comprehensive Plan. Last month the Steering Committee held a Public Meeting/Open House to present the draft Plan and hear public comments on the action strategies. The 30-day public engagement period will end on March 6th. Then the Steering Committee will present the Plan to the Town's Plan Commission for their endorsement and adoption on March 13th, followed by adoption by the Town Council.

Bourbon Comprehensive Plan Update

The Town of Bourbon held their second Steering Committee meeting in February. At the meeting, MACOG explained how Bourbon fared in the region based on OCRA's Community Vitality Indicators. Committee members also worked together on establishing a vision statement and strategize how to best engage the community through the planning process. The next Steering Committee meeting will be held in April to discuss the strengths and challenges, and begin developing the action strategies.

Purdue Road School

Purdue Road School will be held March 6 – 9th, 2017, at Purdue University in West Lafayette,

Indiana. It is a great opportunity to learn more about transportation issues in the State of Indiana. For more information, go to roadschool.purdue.edu.

Upcoming Policy Board Meeting Presentations

At the next Policy Board meeting, on March 15th, Ron Mangus will explain how the Indiana Bond Bank can assist local units of government in the process of issuing debt. Zach Hurst, with the Indiana Toll Road, will provide an update on the 80/90 PUSH Project at the April 12th Policy Board meeting. The TTAC was encouraged to attend both of the informative presentations.

Quarterly Tracking and Review

Forms for the next Quarterly Tracking Review will be due to MACOG by March 17, 2017, with the next Quarterly Tracking Review to be held April 5, 2017, following the TTAC meeting.

INDOT STIP (State Transportation Improvement Program) Public Meetings

INDOT is currently updating the State Transportation Improvement Program (STIP). They will offer a series of district meetings to review projects that have been accepted into the production schedule. The LaPorte District meeting will take place on April 11th. The Fort Wayne District will host an Open House on April 12th.

MACOG TIP (Transportation Improvement Program) Public Meeting

MACOG is currently updating its Transportation Improvement Program (TIP). The FY 2018-2021 TIP will be out for public comment from March 27th – April 26th. A TIP Open House is scheduled for April 20th from 10:00 am – 7:00 pm, at MACOG. If any comments are received, the information will be presented to the TTAC and Policy Board for review and consideration for approval in May.
