### **Resolution 36-23**

A Resolution to Support the Calendar Year 2024 Safety Performance Measure Targets for the State of Indiana.

### **Safety Target Performance Measures**

Number of fatalities – 876.3 Rate of fatalities per 100 million miles traveled – 1.072 Number of serious injuries – 3,281.1 Rate of serious injuries per 100 million miles traveled – 3.987 Number of non-motorist fatalities and serious injuries – 391.6

James presented Resolution 36-23. The Bipartisan Infrastructure Law requires the State to set performance targets that demonstrate constant or improved performance and cover a triennial period. MACOG has the option to either support the State target, which is developed in collaboration with MPOs, or develop their own target. Historically, MACOG has supported the State target. James said MACOG has resources available for anyone who would like to see transportation safety data for our region. David Harker briefly discussed the Vulnerable Road Users Crash Database. James noted that MACOG also has a Request for Proposals (RFP) out for a Regional Safety Action Plan, which will help determine systemic and systematic ways to improve safety.

A MOTION WAS MADE BY PATRICK MAC CARTHAIGH AND SECONDED BY TY ADLEY TO APPROVE RESOLUTION 36-23. THE MOTION CARRIED.

### **Staff Update**

## **Grants and Funding**

### **INDOT FTA Section 5310 Grant Applications**

Jeremiah Cox stated the INDOT FTA Section 5310 Rural Call for Projects is now open for the purchase of vehicles. Eligible agencies are those exclusively in Elkhart, Marshall and Kosciusko County. The Call for Projects for St. Joseph County will be out next summer. James noted the agency will need a resolution or letter of support for their project and to reach out to MACOG for assistance. The applications are due March 31, 2024.

### Energy Efficiency & Conservation Block Grants (EECBG) for Local Governments

Leah Thill said the EECBG grant is available again to states, local governments, and tribes for the purpose of improving energy efficiency and reducing energy consumption. The application deadline is February 2, 2024.

# Community Forestry (USDA and Indiana University)

Leah stated the Indiana Department of Natural Resources 2023 Urban and Community Forestry Grant is made possible by funds awarded by the USDA Forest Service from the Inflation Reduction Act. Funding requests can be made for six specific project types from a minimum of \$50,000 to a maximum

of \$250,000. Projects types are: tree inventory or urban tree canopy assessment, management/response plan, education/training, new tree planting, community education/awareness events, and other projects specific to urban forestry. The application deadline is December 22, 2023.

Leah also discussed Indiana University's Environmental Resilience Institute Community Forestry Program. It is similar to the DNR program, but Indiana University will manage the money. Indiana University also will hire professional tree planting services and provide maintenance and watering services for the first two years. Leah said eligible governments are those that are designated as a disadvantaged community. Applications for the Indiana University Forestry Program are due December 15, 2023. Please contact Leah Thill for more information.

## 2024-1 Community Crossings Matching Grant (CCMG)

Caitlin stated the Community Crossings Matching Grant will be opening with the first Call for Projects beginning on January 2, 2024 and closing on January 31, 2024. Communities will need to have awards that were made prior to 2022-1 closed out and an approved asset management plan. David Harker can be contacted if crash data is needed for the application. David Armstrong said crash data from the area of the project should be included.

2024 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant Program Caitlin said the RAISE Discretionary Grant Program opened last week. The program provides funding for capital investments in surface transportation that will have a significant local or regional impact with an emphasis on sustainability and equity. The application deadline is February 28, 2024.

# ProPEL U.S. 30 and U.S. 31 Draft Universe of Alternatives

Caitlin provided an update on the ProPEL U.S. 30 and U.S. 31 Draft Universe of Alternatives. The Universe of Alternatives Report includes possible improvements to the U.S. 30 and U.S. 31 corridors to improve regional mobility and safety along the corridors and preserve both as vital transportation corridors for moving people and goods. The Draft Universe of Alternatives will be open for public comment until December 22, 2023.

### Regional Safety Action Plan Request for Proposals

Caitlin said MACOG will be working on the Regional Safety Action Plan and there is a request for proposals (RFP) for services for the plan. MACOG will be seeking proposals until January 5, 2024 and should a selection by the end of January. If a Committee member would like the RFP sent to a particular consultant, please notify James or Caitlin.

#### <u>Interurban Trolley Services Request for Proposals</u>

James stated the Interurban Trolley Services RFP is out for the operation and maintenance of the Interurban Trolley. It also includes both the fixed route and ADA services. Proposals are due January 8, 2024.

AmeriCorps Program Serve Indiana Awards

James said the statewide Serve Indiana Awards for Excellence took place last month. Amber Werner received the Program Director of the Year award and Dr. Kate Barrett received the Outstanding AmeriCorps Alum award.
