# **Plans and Programs**

# Partners for Clean Air Award Luncheon

James announced the annual Partners for Clean Air Award Luncheon will be held on April 16, 2025, at the Matterhorn Conference Center. At the luncheon, Partners will learn about projects and programs being conducted in the region or throughout the State that work to improve air quality. James said it is a good opportunity to network and registration is open now.

# 2025 - 2029 Comprehensive Economic Development Strategy (CEDS)

Zach Dripps stated the 2025-2029 Comprehensive Economic Development Strategy (CEDS) review and comment period is March 5 through April 5, 2025. The CEDS is a plan to guide regional economic development over the next five years.

# SFY 2026 - 2030 Transportation Improvement Plan (TIP) Public Comment

Kelsey Triebold announced the review and public comment period for the SFY 2026-2030 Transportation Improvement Plan (TIP) is March 5 through April 4, 2025. There is an open house on March 25 at the Greater Elkhart Chamber of Commerce and on April 2 at the St. Joseph County Public Library Community Learning Center.

## 2024 Crash Data Review

David Harker reviewed the 2024 Crash Data which can also be found on the MACOG website. He noted that in the past ten years, Indiana has shown a slight increase in fatal and incapacitating crashes. The MACOG region as a whole is experiencing the same trend. The fatal serious injury values show a decrease from both 2022 and 2023. James noted that the decrease is most likely due to the clerical definition of what is considered incapacitating which changed what is considered serious injury. Crossway Trials Condition Report

Anton Getz provided an update on the condition of the Crossway Trails. In 2024, MACOG surveyed surface conditions of 123 miles within the Crossway Trails network. The information was compiled into a map which is available on the MACOG website. Local governments can use the data to develop maintenance plans for their trail networks.

Crossway Trails Map Update

Dustin New presented the data that was collected from the survey of trail conditions. He encouraged local governments to start including trail maintenance in the municipality budget. Dustin said new Crossway Trails maps will be printed using data Anton collected. He requested committee members to look at the new map and provide feedback before printing.

Purdue Road School

James stated Purdue Road School is March 18-19. He noted some of the MACOG staff will be attending and therefore out of the office on those days.

Quarterly Tracking and Review

Kelsey notified the Committee that Quarterly Tracking and Review is on April 15. The Fort Wayne district will meet in the morning and the LaPorte district will meet in the afternoon.

Calendar Year 2024 MACOG Annual Review

Zach stated the Calendar Year 2024 MACOG Annual Review will be available to the public soon. It will be emailed to Committee members and on the AMCOG website.

#### PRIVILEGE OF THE FLOOR

Bill Holder stated that aerial photography for the MACOG region was started last fall but was not finished due to weather conditions. Bill said there is a good opportunity for aerial photography from the State's 2025 aerial photography. He noted that the State was able to fund ¼ foot pixel and will also capture LiDAR elevation data at the same time.
