Dissertation

Title: Affective Qualities: What Makes Objects Pleasant

Advisor: Murat Aydede

Abstract: We attribute pleasantness to experiences and objects. This ‘duel attributional’ characteristic is not found in the standard sensible qualities. In this work, I focus on what makes objects pleasant; what type of property is an object-pleasantness property? I canvass two objectivist views—physicalism and primitivism—and find both wanting. Object pleasantness is not a physical or primitive property. I argue that one form of subjectivism—projectivism—is better but still unsatisfactory. I argue for a relational view. Object pleasantness is whichever object property causes the sensory-affective system to classify the stimulus information in a particular way. I thereby argue that object pleasantness is a sophisticated subjective property.
