




Asset Allocation 5/31/25



On September 27, 2017, the City Council approved a Design Professional Consultant Agreement with Michael Baker International, in the amount of \$334,500, to provide engineering design services for the Kanan Corridor Project, with the limits on Kanan Road, between Thousand Oaks Boulevard and Agoura Road. The original scope of work for the project was to complete the Project Initiation Document (PID) phase, which included evaluating capacity enhancement alternatives at the interchange on and off-ramps, lane re-configurations, as well as infrastructure modifications to ensure the safe transport of bicyclists and pedestrians is preserved.

A first amendment to the MBI agreement was approved in February 2018, to extend the Project limits from Agoura Road to Cornell Way and provide additional budget for extending the limits of the Project. In February 2020, the second amendment was approved to extend the term of the agreement to June 30, 2021, to allow for the inclusion of the final Kanan Road/Agoura Road Intersection alignment, which was approved in August 2020. In May 2021, the third amendment was approved to extend the term of the agreement to June 30, 2023, to further extend the limits of the Project to the northerly limits of Kanan Road, allowing the study and coordination of signals and fire circulation for the entire corridor, develop additional build alternatives, and provide additional studies required by the Caltrans process. The fourth amendment was approved in April 2023, which extended the term of the agreement to June 30, 2024, and to develop additional bicycle-focused alternative concepts. And the fifth amendment was approved in May 2024 which extended the term of the agreement to June 30, 2026, and provide additional engineering design services for Kanan Road Rehabilitation Improvements from Thousand Oaks Boulevard to East Canwood Street, and a Structures Crossing the US-101 Inventory and Assessment Report.

Over the last two years, staff has seen an increase in road repairs needed between East Canwood Street and the Caltrans right-of-way. In addition, the City's maintenance contractor has made numerous repairs to the westerly slope along Kanan Road due to the lack of drainage swales in certain sections of the hillside. Staff believes it would be advantageous for the City to extend the project limits for the Kanan Road Rehabilitation Improvements from Thousand Oaks Boulevard to the Caltrans right-of-way near West Canwood Street to address these deficiencies. In addition, it was determined that a section of failing block wall that will be reconstructed near Medea Creek will require a custom foundation and wall design due to poor soil conditions.

The proposed sixth amendment would have a total not-to-exceed amount of \$120,240. A detailed list of the services required can be found as Exhibit "A" on the attached amendment. The scope of work and all other terms and conditions of the agreement would remain the same as previously approved.

The proposed amendment has been reviewed by the City Attorney and approved as to form.

#### **FISCAL IMPACT**

Sufficient funding was appropriated in the Fiscal Year 2025-26 City Council Budget under the Public Works Department's Street Improvements account number 019-4640-6320.00 to fund the design of the Project through Measure M.

# SIXTH AMENDMENT TO AGREEMENT BETWEEN CITY OF AGOURA HILLS AND MICHAEL BAKER INTERNATIONAL Kanan Corridor Safety, Operations and Capacity Enhancement Project – PSR/PDS

THIS SIXTH AMENDMENT is made and entered into as of June 25, 2025, by and between the City of Agoura Hills, a municipal corporation (hereinafter referred to as "City"), and Michael Baker International, a Corporation (hereinafter referred to as "Contractor"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

1. This Amendment is made with respect to the following facts and purposes:

a. On September 27, 2017, the City and Consultant entered into that certain Agreement entitled "Agreement for Design Professional Consultant Services," in the amount of Three Hundred Thirty-Four Thousand Five Hundred Dollars and Zero Cents (\$334,500.00).

b. On March 16, 2018, the City and Consultant entered into the First Amendment to that certain Agreement entitled "Agreement for Design Professional Consultant Services," to add scope of work to extend the southerly project limits from Agoura Road to Cornell Way, and increase the payment in the amount of Nineteen Thousand Dollars and Zero Cents (\$19,000.00).

c. On February 12, 2020, the City and Consultant entered into the Second Amendment to that certain Agreement entitled "Agreement for Design Professional Consultant Services," to extend the term of the agreement to June 30, 2021.

d. On May 12, 2021, the City and Consultant entered into the Third Amendment to that certain Agreement entitled "Agreement for Design Professional Consultant Services," to add scope of work to extend the Project limits from Thousand Oaks Boulevard to the northerly project limits, develop one additional design alternative, and conduct traffic and hazardous assessment studies, extend the term of the agreement to June 30, 2023, increase the payment in the amount of Two Hundred Seventy-Five Thousand One Hundred Three Dollars and Zero Cents (\$275,103.00).

e. On April 26, 2023, the City and the Consultant entered into the Fourth Amendment to that certain Agreement entitled "Agreement for Design Professional Consultant Services," to add scope of work to develop additional bicycle-focused alternative concepts, extend the term of the agreement to June 30, 2024, and increase the payment in the amount of Eighty-Nine Thousand Two Hundred Ninety-Five Dollars and Zero Cents (\$89,295.00).

f. On May 8, 2024, the City and the Consultant entered into the Fifth Amendment to that certain Agreement entitled "Agreement for Design Professional Consultant Services," to add scope of work, extend the term of the agreement to June 30, 2026, and increase the payment in the amount of Five Hundred Twelve Thousand Thirty Dollars and Zero Cents (\$512,030.00)

g. The parties now desire to add scope of work to extend the Phase I Project limits to the Caltrans right-of-way limit, design new terrace drainage for the slope on the west side of Kanan Road, design customized structural block walls, and increase the payment in the amount of One Hundred Twenty Thousand, Two Hundred Forty Dollars and Zero Cents (\$120,240.00), and to amend the Agreement as set forth in this Amendment.

2. Section 4 of the Agreement entitled "**PAYMENT**" at paragraph "a" is hereby amended to read as follows:

"The City agrees to pay Contractor monthly, in accordance with the payment rates and schedules and terms set forth in Exhibit B, Payment Rates and Schedule, attached hereto and incorporated herein by this reference as though set forth in full, based upon actual time spent on the above tasks. Any terms in Exhibit B, other than the payment rates and schedule of payment, are null and void. The Sixth Amendment amount shall not exceed One Hundred Twenty Thousand, Two Hundred Forty Dollars and Zero Cents (\$120,240.00), for additional engineering design services for a total Agreement amount of One million, three hundred fifty thousand, one hundred sixty-eight dollars and zero cents (\$1,350,168.00)."

3. Exhibit "A" to the Agreement is hereby amended by adding thereto the items set forth on Attachment "A" to this Amendment, which is attached hereto and incorporated herein as though set forth in full.

4. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect.

# SUBJECT: SCOPE AND FEE PROPOSAL FOR: KANAN CORRIDOR – PAVEMENT REHAB PS&E PROJECT LIMITS EXTENSION FROM EAST CANWOOD STREET TO WEST CANWOOD STREET, TERRACE DRAIN DESIGN, CUSTOM WALL DESIGN

Dear Ms. Yambao,

Michael Baker International, Inc. (Michael Baker) is pleased to submit this scope and fee proposal for three additional elements:

- 1. extending the project limits of the Kanan Road Rehabilitation PS&E from East Canwood Street south to the Caltrans R/W line, close to West Canwood Street.
- 2. slope repair and terrace drain reconstruction will be designed for the slope on the west side of Kanan Road south of Hillrise Drive.
- 3. Custom structural design of the block wall on the east side of Kanan Road.

#### Scope of Work:

Michael Baker proposes to accomplish the above noted improvements by conducting the following tasks.

#### Task 1 – Extend southerly project limits

Michael Baker will extend the pavement grind and overlay limits from East Canwood Street south to the Caltrans R/W line, close to West Canwood Street, a distance of approximately 540 linear feet. There are no curb ramps in this, so the scope of the work will just be pavement grind and overlay. This will require the following additional sheets:

- 1 Street Layout sheet at 20 scale
- 1 Utility plan sheet
- 1 pavement delineation (striping) sheet.
- 1 Traffic Control plan sheet

These improvements will be included in the 90% PS&E submittal, and will be shown in the cost estimate and project specifications. The pavement delineation sheet will show restoration pavement striping and restoration of traffic signal loop detectors, since existing loops may be impacted by grind and overlay operations. Separate traffic signal modification plans are not included in this scope of work.

#### Task 2 – Include Terrace Drain Reconstruction design and slope repair

Michael Baker will design terrace drain reconstruction and slope repair for the slope on the west side of Kanan Road south of Hillrise Drive, according to the recommendations in the NMG Geotechnical Report dated January 15, 2025. The Terrance Drain system on the City's slope is approximately 600' in length. Two grading sheets will be prepared at 20 scale (1"=20'), and one construction detail sheet for V-ditch details. Improvements will be contained within City R/W. Michael Baker Survey Team will survey the existing V-ditch flowlines of the existing system, so that the new terrace drains and down drains will be placed in the best location both horizontally and vertically. No more than one day of Surveying is included in this scope of work. No drainage calculations will be prepared, but rather the V-ditches will be designed to meet or exceed their originally designed flow capacity. Re-grading of localized erosion areas will be included, per the geotechnical study recommendations.

These improvements will be included in the 90% PS&E submittal, and will be shown in the cost estimate and project specifications. Due to the additional soil disturbance related to the Terrace Drain reconstruction, the Categorical Exemption (CE) will not be prepared until the plans show these additional scope elements in this proposal.

#### Task 3 - Custom structural design of the block wall on the east side of Kanan Road

Due to poor soils along the three properties where the block wall along Kanan Road will be reconstructed as part of the project, a custom foundation and wall design needs to be developed by our structural engineers. Included in our original scope of work was to use a standard plan wall design, such as a Caltrans pile footing soundwall. However, after the geotechnical investigation was performed, it confirmed that the soil properties were not sufficient to use a standard plan wall. As a result our structural engineers will design a custom wall and footing. Please see their attached proposal.

#### **PS&E** Assumptions:

- It is assumed that roadway cross section dimensions will not change from the existing condition. In
  other words the roadway will not be widened, nor the curbed median be narrowed, or turn pockets
  extended.
- Traffic Signal Modification Plans are not included in this scope of work.
- Neither drainage plans nor a drainage report are included in this scope of work.
- No water quality (NPDES) permits or environmental permitting is included in this scope of work.

The City of Agoura Hills has been hosting the annual Reyes Adobe Days (RAD) festival for twenty-one years. This special Fall festival started shortly after the restoration and reopening of the Reyes Adobe Historical Site back in 2002. The purpose of the event is to celebrate the diverse culture and rich history that the Reyes Adobe Historical Site brings to the community.

The RAD festival takes place over four days each year beginning with the RAD Fiesta. The weekend of events starts Friday evening with Night at the Adobe. Activities on Saturday and Sunday include the RAD Parade, RAD Run, RAD Day in the Park, Adobe Tours, children's activities, live entertainment, RAD Artisans, RAD Beer Garden, and the RAD Ride. RAD could not be possible without the hundreds of volunteers, many sponsors, and local businesses that participate in the event.

This year, Reyes Adobe Days will be held on Friday, Saturday, and Sunday, October 3, 5, and 5, 2025. Most of the activities are held at the Reyes Adobe Park and Historical Site, located at 31400 Rainbow Crest Drive in Agoura Hills.

Over the years, the City has taken extra steps to provide liability coverage for the weekend of events by purchasing an additional insurance policy for the elevated attendance and activities that may increase risk exposure. City Staff also files for a Temporary Use Permit (TUP) to allow Reyes Adobe Days (RAD) to take place at Reyes Adobe Park and to monitor the activities, such as live entertainment, parade, hands-on activities, art vendors, special events, etc. In order to approve and process the TUP, the consumption of alcohol in a designated area in the park requires City Council approval (Agoura Hills Municipal Code, Chapter 9 – Park Rules and Regulations, Section 4913 - Alcoholic Beverages). This action will meet the requirements of the Special Event Insurance obtained.

The RAD event will also require several other permits to be completed including, City of Agoura Hills Building and Safety Permit, City of Westlake Village Ride Permit, Los Angeles County Fire Department Event Permit, and the City of Agoura Hills Parade, Race, Bike Ride (PRBR) Event Permit. All permits will be included in the complete TUP application.

Reyes Adobe Days events and activities have been reviewed and discussed with the Community Services Subcommittee.

There is no fiscal impact to the City Council approved FY 2025-26 budget.

#### RECOMMENDATION

Staff respectfully requests that City Council approve the consumption of alcohol in a designated area in the park in order to complete the process of the Temporary Use Permit authorizing the activities offered for Reyes Adobe Days.

### SUBJECT: ADOPT ORDINANCE NO. 25-479 DESIGNATING FIRE HAZARD SEVERITY ZONES

At the June 25, 2025, City Council meeting, the Council unanimously supported the introduction of Ordinance No. 25-479, which formally designates Fire Hazard Severity Zones (FHSZ) within the City of Agoura Hills, according to recommendations from the California Department of Forestry and Fire Protection (CAL FIRE). This ordinance is now being presented for second reading and adoption.

The updated FHSZ maps are developed by CAL FIRE under the authority of the State Fire Marshal and categorize areas into Moderate, High, or Very High Fire Hazard Severity Zones. These classifications are determined using a range of criteria, including vegetation, topography, fire history, and climate modeling. The last comprehensive update to these maps occurred in 2011, and the 2025 revision reflects significant advancements in fire science, including the use of satellite imagery and updated climate data.

The City of Agoura Hills received CAL FIRE's updated map recommendations on March 24, 2025, triggering the statutory 120-day period for local adoption in accordance with Government Code Section 51179(a). Ordinance No. 25-479 is intended to fulfill this legal requirement and ensure local consistency with state wildfire hazard mapping.

The ordinance was introduced following a presentation and public hearing at the June 25, 2025, meeting, during which staff reviewed the scientific basis for the maps, legislative mandates under Assembly Bill 211 (AB 211), and the implications for local land use, building regulations, emergency preparedness, and real estate disclosures under Assembly Bill 38 (AB 38).

The updated maps indicate that approximately 94% of the City's land area is now designated within a Fire Hazard Severity Zone, an increase from approximately 70% under the previous maps.

Specifically:

- Very High FHSZ: Increased from 3,516 acres to 3,890 acres (~78% of city)
- High FHSZ: Added 413 acres (~8%)
- Moderate FHSZ: Added 386 acres (~8%)

These changes will require properties within the designated zones to comply with defensible space requirements. The adoption also strengthens the City's ability to manage emergency response and fire mitigation strategies in coordination with Los Angeles County and regional agencies. The City conducted a public review and comment period on the proposed maps. While several comments were received, most were unrelated to the technical mapping process or its intended purpose. Staff has ensured compliance with public review procedures under state law.

This second reading and adoption of Ordinance No. 25-479 is the final step in implementing CAL FIRE's recommendations. Upon adoption, the ordinance will be submitted to the State Fire Marshal and will become effective in accordance with state and municipal law.

#### **FISCAL IMPACT**

There is no fiscal impact.

#### RECOMMENDATION

Staff recommend that the City Council adopt Ordinance No. 25-479, designating Fire Hazard Severity Zones, and approving a CEQA exemption determination.

#### ORDINANCE NO. 25-479

# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, DESIGNATING FIRE HAZARD SEVERITY ZONES, AND APPROVING A CEQA EXEMPTION DETERMINATION

WHEREAS, the Legislature has declared in Government Code Section 51175(a): "Wildfires are extremely costly, not only to property owners and residents, but also to local agencies. Wildfires pose a serious threat to the preservation of the public peace, health, or safety. The wildfire front is not the only source of risk since embers, or firebrands, travel far beyond the area impacted by the front and pose a risk of ignition to a structure or fuel on a site for a longer time. Since fires ignore civil boundaries, it is necessary that cities, counties, special districts, state agencies, and federal agencies work together to bring raging fires under control. Preventative measures are needed to ensure the preservation of the public peace, health and safety."

WHEREAS, California Government Code Section 51179 requires the City to adopt an ordinance designating Moderate, High, and Very High Hazard Severity Zones in the City, within 120 days of the identification of such areas by the State Fire Marshal; and

**WHEREAS**, the State Fire Marshal has now published its map identifying Moderate, High, and Very High Fire Hazard Severity Zones within the City; and

**WHEREAS**, the City Council has reviewed the State Fire Marshal's Fire Zone Map and believes it accurately represents the Moderate, High, and Very High Fire Hazard Severity Zones in the City; and

**WHEREAS,** the City has made information concerning the Fire Hazard Severity Zones identified in the City available for public review and comment as required by law.

### NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF AGOURA HILLS HEREBY FINDS AND ORDAINS AS FOLLOWS:

**SECTION 1.** The facts set forth in the foregoing recitals are true and correct.

**SECTION 2.** The City of Agoura Hills hereby designates the Moderate, High, and Very High Fire Hazard Severity Zones as those areas identified in attached Exhibit "A", which is incorporated herein by reference.

**SECTION 3.** Any and all provisions in any previously adopted City ordinances designating Fire Severity Zones within the City of Agoura Hills' jurisdiction, are superseded by the provisions of this Ordinance.

**SECTION 4.** The City Council has reviewed this Ordinance and hereby finds that it can be seen with certainty that there is no possibility that its adoption, and designation of the Fire Hazard Zones established hereby, may have a significant effect on the environment, since it will provide for greater fire protection. Therefore, it is exempt from review under the California Environmental Quality Act, and the Guidelines thereunder, pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

**SECTION 5.** If any provision of this Ordinance is for any reason held to be invalid by a court of competent jurisdiction, the City Council hereby declares that it would have passed each and every remaining provision irrespective of such holding in order to accomplish the intent of this Ordinance.

**SECTION 6.** The City Clerk shall certify to the passage of this Ordinance and shall cause a summary of same to be published at least once in the local newspaper of general circulation, circulated within the City of Agoura Hills. A copy of the full text of this Ordinance shall be on file in the Office of the City Clerk on and after the date following introduction and passage and shall be available to any member of the public.

This Ordinance shall go into effect on the 31<sup>st</sup> day after its adoption.




# Local Responsibility Area Fire Hazard Severity Zones

SUBJECT: DISCUSSION REGARDING OAK TREE ORDINANCE PLANNING PRINCIPLES

The purpose of this report is to discuss the proposed goals and objectives or "Planning Principles" of the Oak Tree Ordinance Amendment and for the City Council to provide staff with feedback. One of the Community Development Department's goals for the 2024-25 Fiscal Year, as adopted by the City Council, is to amend the City's Oak Tree Ordinance (Agoura Hills Municipal Code ("AHMC") Section 9657 et. Seq.). This Oak Tree Ordinance ("Ordinance") Amendment was prompted by a few key issues with our oak tree regulations, particularly pertaining to enforcement and the cost burden that oak trees have on single-family property owners throughout the City.

As our first step toward amending the Ordinance, staff would like to establish the overarching Planning Principles. Staff worked with our Oak Tree Consultant (Dudek) to create a list of issue areas with our current regulations, and based on those issue areas, staff has drafted some Planning Principles for the City Council to consider. A full description of the identified issue areas and the proposed Planning Principles are attached to this report.

Staff met with the Land Use/Economic Development Subcommittee (LUEDC) and discussed the proposed Planning Principles on June 10, 2025. The LUEDC was generally supportive of all Planning Principles as proposed, and in relation to Planning Principle No. 6, the LUEDC asked staff to research whether the Southern California black walnut and the California sycamore have similar fire resiliency properties as coast live oaks and valley oaks. Staff can confirm that walnuts and sycamores have similar properties to oak trees that make them good trees for high fire areas. All the scientific literature reviews and the Fire Department endorse them as trees that are good for a fire-wise landscape. The two species are allowed in Los Angeles County Fuel Modification Zone B, which is the fuel modification zone that extends 30-100 feet from structures.

#### **FISCAL IMPACT**

Staff anticipated the expenditure of funds related to the Oak Tree Ordinance Amendment and allocated funds to the Planning Division's contract services account for the 2024-25 and 2025-26 Fiscal Years related to the amendment. The project is currently on or under budget and there are no anticipated impacts to the 2025-26 Budget.

#### RECOMMENDATION

Staff respectfully recommends the City Council discuss the proposed Planning Principles and provide staff with general direction regarding the goals and objectives of the Oak Tree Ordinance Amendment.
