### **RECOMMENDATION:**

Staff recommends that the Beautification and Maintenance Commission review the proposed improvements and provide comments and recommendations.

### **BACKGROUND:**

The City of Artesia was recently awarded \$209,430 in Highway Safety Improvement Program funding in order to install a Rectangular Rapid Flashing Beacon at the northwest corner of 186<sup>th</sup> Street and Devlin Avenue, as well as enhanced crosswalks at eight (8) un-signalized intersections throughout the City. These improvements are prescribed by the City's Local Roadway Safety Plan, which analyzed crossroads collision data between 2015 and 2019 across the City's entire roadway network. Through this process a list of intersections and roadway segments with high incidences of collisions was developed. This process identified the need for signalized and un-signalized improvements Citywide.

### **ANALYSIS:**

The proposed Highway Safety Improvement Program improvements include:

- Installation of enhanced crosswalks at eight (8) locations:
  - o 166th Street and Alburtis Avenue
  - o 178th Street and Roseton Avenue
  - 178th Street and Jersev Avenue
  - Ashworth Street and Clarkdale Avenue
  - 183rd Street and Elaine Avenue
  - 186th Street and Elaine Avenue
  - 186th Street and Grayland Avenue
  - 186th Street and Horst Avenue

### **BACKGROUND:**

Per the Municipal Code, at the first meeting after the beginning of the terms of offices of its members, the Beautification and Maintenance Commission is to select its officers, Chairperson and Vice Chairperson. The Chairperson shall not be elected for more than two (2) consecutive one (1) year terms. The Chairperson shall preside over all meetings of the Commission. The Vice Chairperson shall preside over Commission meetings in the absence of the Chairperson.

### **ANALYSIS:**

After the 2024 elections of the Council, the newly elected Council members appointed members to all City Commissions at the February 10, 2025, Regular Council Meeting. The April 17, 2025 Regular Meeting of the Beautification and Maintenance Commission is the first meeting since the appointees have been sworn in to take their positions on the Commission.

### **RECOMMENDATION:**

Staff recommends that the 2025 Spring Beautification Awards Nominations submitted by Beautification and Maintenance Commissioners be received and filed.

## **BACKGROUND:**

The annual Spring Beautification Awards Program was created to recognize residents and business owners for outstanding maintenance, civic pride and community beautification in the City. With the support of the Beautification and Maintenance Commission, who promotes the City's efforts to maintain Artesia as an attractive city, awards are presented to community members who help beautify City neighborhoods. The Spring Beautification Awards nomination period began in January and nominations are due in April. The awards include the following categories:

## **Residential Entries**

**Landscape Beautification Award:** This award recognizes homes that exhibit exceptional pride of ownership through well-maintained and exceptional landscaping of their property. This includes an attractive landscaping design of the front yard and parkway, a clean and well-maintained exterior, and overall good curb appeal.

**Sustainable Landscape Beautification Award:** This award recognizes homes that exhibit exceptional pride of ownership through the use of water conservation practices as part of their landscaping design. This includes the use of drought-tolerant or native plants, water-friendly irrigation systems, and energy-efficient or solar lighting.

## **Business Entries**

**Storefront Beautification Award:** This award will recognize businesses that contribute to the overall beautification of the community by demonstrating exceptional pride of ownership through the outstanding maintenance of their property. This includes an attractive façade, storefront, a clean and well-maintained exterior, and an attractive landscaping design.

**Sustainable Landscape Beautification Award:** This award will recognize businesses that contribute to the overall beautification of the community by demonstrating exceptional pride of ownership through the use of water conservation practices as part of their landscaping design. This includes the use of drought-tolerant or native plants, water-friendly irrigation systems, and energy-efficient or solar lighting.
