#### **BACKGROUND:**

The City of Artesia has hosted several Golf Tournaments in the past to benefit a variety of Parks and Recreation Program offerings. The most recent tournament, Putting the Greens for Teens, held in 2021 at the Lakewood Country Club raised over \$10,000 for the Parks and Recreation Department.

#### **ANALYSIS:**

The City of Artesia Parks and Recreation Department will be hosting a Golf Tournament at the La Mirada Golf Course on Friday, April 4, 2025 beginning at 1pm. The tournament, held in a Shotgun 4-person scramble format, will benefit the City's Parks and Recreation Programming. The City will also host 2 contests withing the tournament for players to participate, including a Closest to the Pin and Longest Drive. Registration for the event will include green fees, golf cart usage, range balls, prizes, and a banquet buffet dinner.

The event sponsorship package will a variety of sponsorship levels, with an ability to enter up to 8 participants for playing spots. Our Sponsorship levels are as follows:

Title Sponsor: \$5,000 - includes 8 individual playing spots (2 teams of 4), logo on all printed materials for the event, banner at registration and dinner, and 3 Tee and Green signs
