1. General Session

1.A. Call to Order

Chair Rifilato called the meeting to order at 5:30 pm.

1.B. Pledge of Allegiance -

Chair Rifilato led the Pledge of Allegiance.

1.C. Invocation

Chair Rifilato asked for a moment of silence.

1.D. School Board Representative

Amber Duong Gonzalez, representing the Brea Olinda Unified School District, provided updates on ongoing and upcoming summer construction projects. Highlights included concrete work at the high schools and fencing upgrades across various campuses. She reported that a kickoff meeting was held for the Falcon MPR and kitchen renovation project. Additional summer improvements will include the installation of new classroom furniture and the replacement of library flooring at multiple school sites. Graduation planning was also discussed, with approximately 450 students expected to participate in the ceremonies.

1.E. Matters from the Audience

Danielle Jorgenson raised concerns about Country Hills Park, specifically a rusty corner and a worn-out playground.

2.B. FY 2025-2027 Community Services Budget Update & Proposed Fee Schedule

Senior Management Analyst Anthony Godoy provided an overview Community Services Department's annual budget timeline, beginning in January with economic updates and budget assumptions. In February, departments update forecasted revenues and expenditures, followed by executive-level budget reviews in March.

Anthony also discussed the process for setting fees, which involves conducting market surveys, analyzing service demand, and applying cost-of-living adjustments. Proposed fee increases include daily drop-in rates for fitness programs, youth user group maintenance fees, and after-school program costs. Increases to facility reservation fees for the Arts Garden and Birch Hills Golf Course were also proposed.

In addition, Anthony highlighted several capital improvement projects. The Curtis Theatre will receive upgrades, including the replacement of main drapes and the conversion of stage lighting to energy-efficient LED fixtures. He emphasized the importance of maintaining fire safety compliance and improving energy efficiency as part of the theater improvements. A roofing replacement project is also planned for the Senior Center and Pioneer Hall, with a combined budget nearing \$500,000, funded through the Capital Improvement Program (CIP).

3. Discussion

3.A. Preview of Community Services Summer Programs & Events

Community Services Supervisor Jaime Espitia introduced the Resource Center's summer Vounteen Program, which has engaged 19 volunteers across nine service areas. She also announced the *Bite of Reality* class scheduled for June 13, a hands-on financial literacy simulation that teaches teens real-life "adulting" skills with a focus on budgeting and money management.

Community Services Specialist Jovi Negos shared information on upcoming contracted summer classes, which include creative camps, science-based boot camps, and collaborative programs offered in partnership with local organizations.

Community Services Supervisor Nicole Andrews provided an update on the Community Center's facility rental program, noting a strong demand for space, including weddings, milestone birthday celebrations, and other private events. The Arts Garden and Community Hall are fully booked for the summer. She highlighted a unique upcoming event—a traditional Hindu *rice ceremony*, celebrating a baby's first introduction to solid food. Continued high interest in facility rentals reflects strong community engagement.

Community Services Specialist Jazmine Serna gave an overview of summer youth programming, including preschool and school-age programs. The annual Father-Daughter Dance is scheduled for June 13, with tickets available at the front counter or by phone. Summer activities for school-age children feature off-site excursions such as beach days and movie outings. She also noted the active involvement of the Student Advisory Board, whose members are contributing to community events and initiatives.

Community Services Supervisor DJ Alegre discussed the Community Center's fitness offerings, which include insurance-based programs, group fitness classes, and specialty workshops. The annual *Summer Challenge* will run from July 10 to August 14, with participants weighing in and competing for prizes. The *Health and Wellness Expo* is set for May 31 and will feature 60 local vendors along with exclusive promotions.

Community Services Supervisor Billy Hutchinson provided updates on summer youth sports, including baseball and mini soccer programs, as well as ongoing adult sports leagues. He also highlighted the summer aquatics program, which includes swim lessons, recreational swim

sessions, and pool rentals. The Plunge Open House was held on May 16, offering the public an opportunity to meet staff and complete swim assessments. Registration for swim lessons opened on May 19 and has seen strong demand from both residents and non-residents.

Community Services Supervisor Kristin Steyerman highlighted a variety of upcoming summer events aimed at promoting community fun and engagement. Events include *Family Films in the Park*, the *Home Beautification Contest*, the *Country Fair*, and *Brea Fest*, each providing opportunities for recreation, relaxation, and community celebration.

Tim Takahashi, Senior Center Supervisor, provided an overview of operations at the Senior Center, which he oversees alongside Program Manager Rebecca Matta and Case Manager Lani Gormsen. He acknowledged the challenges posed by ongoing construction but commended the staff's efforts to continue providing high-quality services and support for older adults during this period.

Rebecca Matta shared details about upcoming summer programming, which includes monthly themed parties, organized travel group excursions, and intergenerational events designed to foster connection between seniors and youth. She also announced a paper shredding event aimed at reducing the risk of mail fraud and identity theft, and a flu shot clinic to be held in partnership with Albertsons Pharmacy.

Lani Gormsen outlined the range of case management services offered to older adults, including assistance with utility bills, access to local resources, transportation coordination, and the provision of medical equipment. He emphasized the importance of maintaining partnerships with organizations such as North Hills Church and No Limits, which help provide financial assistance to low-income clients.

Lani also highlighted the home-delivered meals program, run in partnership with Meals on Wheels Orange County, and encouraged volunteer participation for meal delivery. He noted the ongoing success of the durable medical equipment loan program, which plays a vital role in helping older adults age in place safely and independently.

3.B. Brea Parks and Trails Updates

Community Services Manager Jenn Colacion provided an update on Arovista Park. She noted that while there are ongoing impacts and challenges at the Senior Center, progress at Arovista Park is moving forward. Much of the above-ground work is underway, including installation of the sound wall. Commissioner Higgins inquired about the duration of the impact on the Senior Center. Manager Colacion responded that construction is expected to be completed in the fall.

Community Services Manager Jenn Colacion reported that there were two submissions that were recently approved at the April 28 meeting.

4.D. User Groups

Commissioner Higgins reported that the Girls Softball organization requested to display a banner at one of the parks. Deputy Director Matlock recommended they resubmit the request to ensure it aligns with city guidelines, noting that the banner may not be displayed year-round.

Commissioner Higgins also shared that Brea Little League is interested in hosting a movie fundraiser at a park. However, the proposed event does not currently meet the city's noise ordinance requirements and poses other operational and equity challenges.

4.E. General Plan Steering Committee

5. Informational

5.A. Correspondence

Commissioner Son inquired about the flag football letter included in the correspondence packet. Deputy Director Matlock explained the process for the group to become an official user group.

Chair Rifilato commented on the complimentary letter recognizing staff at the Brea Community Center. Deputy Director Matlock noted that such letters of appreciation are always welcome and confirmed it had been shared with the staff.

Commissioner Realon requested the aggregate totals of the proposed budget. Community Services Manager Jenn Colacion reported that the proposed expenditures total approximately \$9 million, with projected revenues at \$3.5 million.

Commissioner Higgins complimented the Community Services staff for their hard work and dedication.

I have served as the PTO president at Country Hills for the past three years and am a former Country Hills student myself. I have stayed in Brea for the sense of safety and community that the small city brings. The Country Hills community is lucky to be close knit and supportive of one another and is continuing to grow. I. GENERAL

Park Development Fund (Fund 250) Update

The Park Development Fund has a current balance of \$404,023. There are two projects that have been approved by the Planning Commission on March 11, 2025, and the City Council on April 1, 2025. Brea Plaza would add a 120-unit apartment building and the project at Greenbriar would add 179 single-family units yielding \$673,320 and \$1,757,422 in park development fees respectively. In addition, we have two projects under construction: the Brea Mall Housing project of 380 apartments (\$2,132,180) and the South Brea Townhome project consists of 32 single-family units (\$221,552). The future anticipated park development fees total \$5,188,497.

Olinda Oil Museum and Trail

During open hours for the museum, visitors totaled 90, which was a steady month with weekend visitors from Orange County and the Inland Empire. There were two special groups tours during May.

The trail's popularity remains constant with it being a favorite for walkers and hikers in and around Brea. The weather remains a key factor in volume using the trail. With the rainy season upon us, the water drainage run off issue is increasing with more potential damage to the trail and historic buildings. Several critical areas have been identified. Museum staff have been addressing this problem by constructing temporary berms to divert rain run off until the city can develop a permanent fix in the future which is currently included in the City's Capital Improvement Program (CIP).

The site's historic landmark *Olinda Well # 1*, which was drilled in 1897, was shut down due to an oil company, Bridgeland Energy having a dispute with the CA Environmental Agency. The docents and City staff have explored our various contacts without resolution.

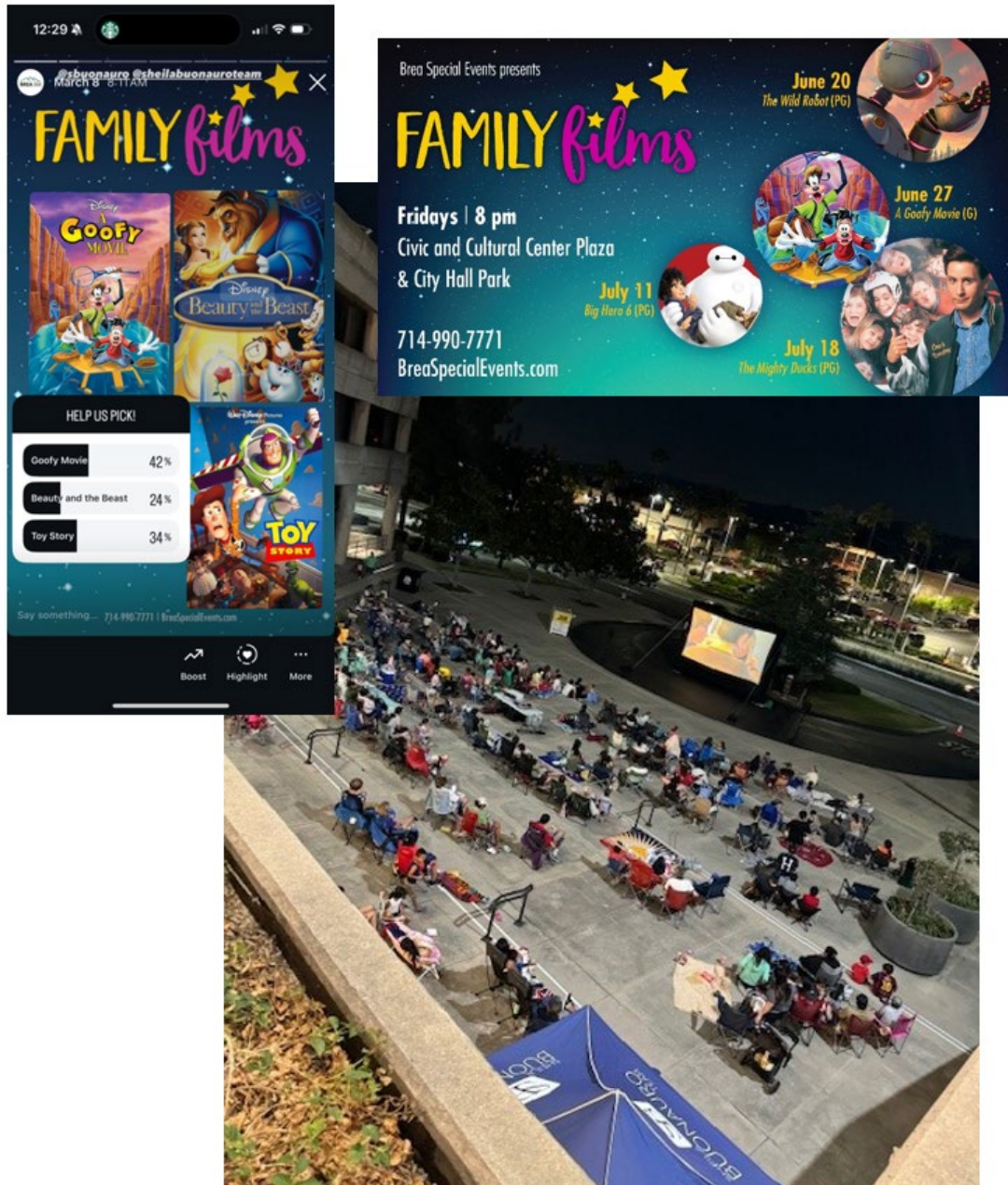

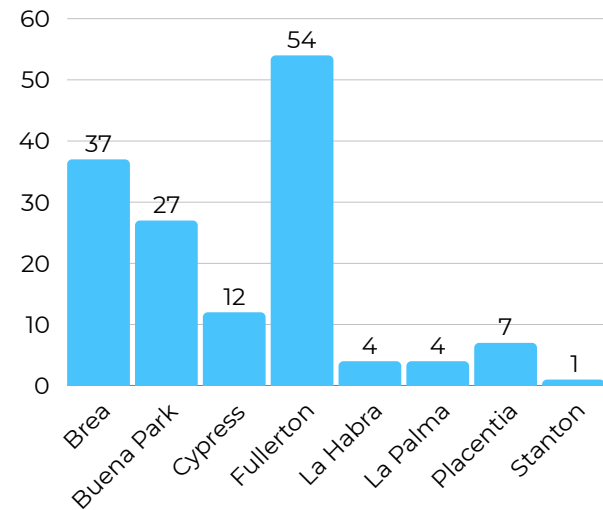

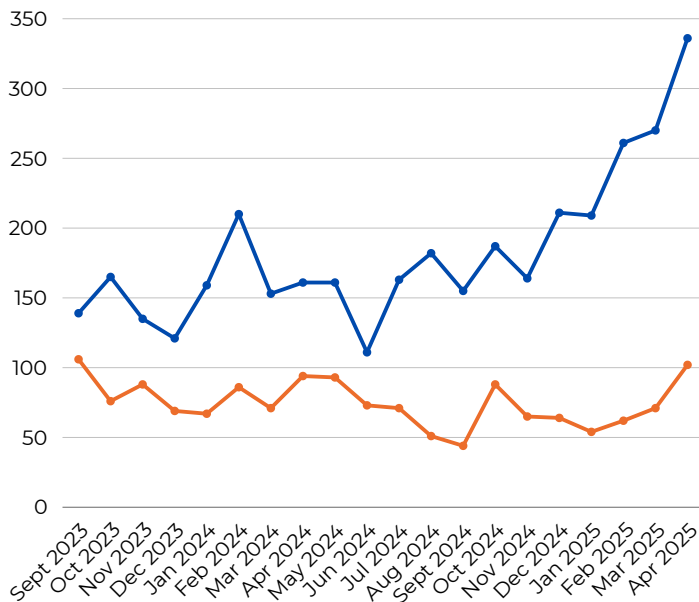

Dispatch Incidents by City

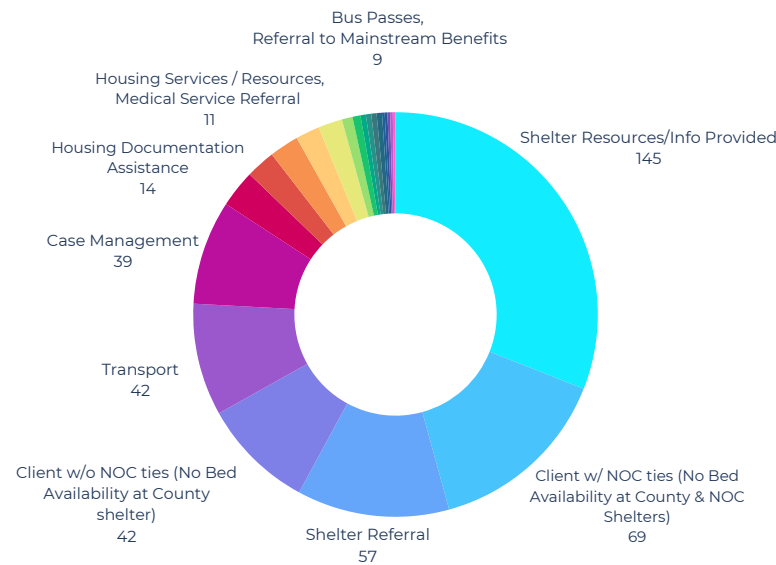
