# **TRAFFIC COMMITTEE MINUTES – January 16, 2025**

TIME: 5:30 P.M.

- LOCATION: Executive Conference Room
- ATTENDEES: Citizen Representatives: Darlene Chandler, Erik Zambon, and Scott Fujioka
- ABSENT: Fahd Jamil, Rachel Hickenbottom

**Staff Representatives**: David Roseman, T.E., Ryan Chapman, C.E., Corporal Nguyen, Corrine Marino, and Yvonne Lopez

- Call to Order/Introductions The meeting was called to order at 5:30 P.M. by Vice Chair Fujioka.
- Approve Minutes of the November 21, 2024 Regular Meeting Motion to approve by Committee member Zambon, seconded by Committee Member Chandler. Receive and File.
- Matters from the Audience (Item #1) Colin McGrahey, Managing Agent for Country Road HOA and Thomas Wheat, Traffic Engineer (TJW Engineering) hired by the HOA, presented a traffic study that was prepared to address traffic safety and parking concerns within the Country Road neighborhood. The study contains recommendations for both the private roads and parking facilities controlled by the HOA and the City's right-of-way. Mr. McGrahey requested the City's review of the study, consideration of the recommendations, and to schedule a discussion of the topic at a future Traffic Committee meeting. City staff agreed to review the report and coordinate with the HOA to agendize the item for a future Traffic Committee meeting in March or April.
- Matters from the Audience (Item #2) Resident, Greg Milledge, spoke regarding safety concerns due to an increase of traffic on Elm Street that was most likely a result of traffic congestion on Imperial Hwy. The resident also noted speeding issues on Elm Street and noted that he felt that this was caused by Elm St. being used as a cut-through for traffic. The resident requested increased police presence on Elm St., consideration of traffic calming measures on Elm St. between Brea Blvd. and State College Blvd., and the installation of a stop sign at Orange Ave.
- **Traffic Collision and Citations Report** Corporal Nguyen outlined the top five accident prone intersections in 2024:
  - 1. Lambert & State College (8 crashes)
  - 2. Lambert & Kraemer (7 crashes)
  - 3. Brea & Central (6 crashes)

- 4. Imperial Hwy & State College (6 crashes)
- 5. Lambert & Berry (4 crashes)
- **Discussion Item: Blackstone Traffic Safety Requests** City Traffic Engineer noted that the data for the study was not yet available for discussion, and that this topic would be brought back for discussion at a future Traffic Committee meeting.
- Discussion Item: Crossing Guard Request for Tamarack Avenue and Mariposa Drive Pedestrian counts were collected and re-confirmed by the vendor. The City Traffic Engineer noted that he was unable to connect with the resident who had requested this item, nor the school Principal prior to the meeting. Since neither was in attendance, this topic will be brought back for consideration at the next Traffic Committee meeting.
- **Project Updates** The City Traffic Engineer and staff reported on the following items:
  - <u>SB1216</u> Item pertains to changes in designation of Class III bike lanes & sharrows. It was noted that this item would be reviewed further and the General Plan would be updated with the appropriate modifications as part of the General Plan Update.
  - <u>Puente Ave. & Whittier:</u> City staff has coordinated with the City of La Habra and requested increased enforcement of truck traffic restrictions on Whittier Ave.
  - <u>Caltrans Speed Study update on Imperial Hwy</u> Staff has reviewed the study and will bring the item to a future Traffic Committee meeting on the proposed speed limit revisions within the Caltrans right-of-way.
  - <u>Puente Street Speed Hump Request</u> City staff has scheduled a site visit with a resident to review the functionality of the installed speed humps and to gain further information regarding a request for traffic calming measures on Northwood Ave.
  - <u>CIP 7329 Birch Street Paving/Waterline Project</u> Project has been awarded and initial phases of construction are anticipated to start in February.

## Committee Member Comments

## o <u>Committee Member</u> Zambon:

Reported that there was a car accident at the intersection of Northwood & Berry, at the new roundabout. The Police Department identified that the accident was a single vehicle crash by a person that was incapacitated at the time.

### Committee member Fujioka:

Asked if the Traffic Committee needs to be involved in red curb requests for daylighting. The City Traffic Engineer indicated that based on the Committee's previous discussions and actions, only those requests that are unique or that staff felt that Committee input is needed would be brought forward to the Committee for discussion and concurrence. All other daylight red zone requests would be investigated by staff and administratively approved.
