#### **RECOMMENDED ACTION**

Staff is seeking a recommendation from the Commission regarding the future of the Community Chorus. The following options are presented for consideration:

1. Continue the program in its current form.

- 2. Reinstate the \$10 monthly participation fee to help offset costs though this may risk further reducing membership. Fees would return to General Fund to help offset cost for the programs Director, Accompanist and program related fees.
- 3. Conclude the program due to ongoing declining enrollment and lack of sustained participation.

#### **DISCUSSION**

The Buena Park Community Chorus has been an active part of the community for the past 55 years, originally formed with the mission of fostering interest in choral singing. However, participation in the program has steadily declined since the COVID-19 pandemic. Currently, the chorus consists of only six members - down from a peak of over 65 participants. Despite efforts by staff to promote the chorus and attract new members, participation has not improved.

The chorus meets Wednesday evenings from 7:00 to 9:00 p.m. at the Ehlers Event Center, running from September through June. In an effort to encourage new membership, participation fees have been waived since 2022. Previously, members paid \$10 per month, with the fees going to the now-dissolved Buena Park Community Chorus Inc., a registered 501 (c)(3) nonprofit organization.

The City continues to support the program by contracting a director and accompanist, providing rehearsal and performance space at City facilities, and offering staff support. The current annual budget allocated for the director and accompanist is \$3,780.

The chorus's most recent performance was at the 2024 Memorial Day Service. Unfortunately, scheduled performances at Silverado Days, the annual Christmas Concert, and the Summer Concert had to be canceled due to low participation. The group has expressed interest in hosting a sing-along event on October 11 at Ruth Walp Hall.
