Assistant Engineer Tran provided a report regarding the Caballero Boulevard Pavement Rehabilitation Project which includes a grind, overlay, and dig-outs of asphalt pavement from Valley View Street to Regio Avenue. Additional improvements will include utility lid adjustments, curb drain replacements, catch basin repairs, and new traffic signing and striping. Construction is anticipated to begin in May 2024, and be completed by July 2024. The City received and publicly opened five (5) bids on March 21, 2024. The lowest, responsible bid was submitted by Hardy & Harper Inc. of Lake Forest, CA, in the amount of \$659,000. Staff recommended that the City Council award a contract to Hardy & Harper, Inc. in the amount of \$659,000 for the Caballero Boulevard Pavement Rehabilitation Project.

Police Captain Geyer provided a report regarding the upgrade to the Police Department training room/Emergency Operations Center (EOC) A/V system. Technology has continued to evolve since the building was built but the Training Room A/V suite has barely changed. Broken equipment has been replaced by the closest comparable models or simply left in place. As a result, the system no longer supports the room's training efforts or EOC missions and is unable to make use of new technologies to support remote training, teleconferencing, streaming video, and multi-source integration. The proposed project will comprehensively replace nearly all outdated wiring and equipment in the Training Room. The entire A/V system will be rewired and reinstalled to simplify the maintenance and troubleshooting when issues arise in the future. Additionally, the existing control system will be replaced due to loss of some components. The upgrades will fulfill the present training and EOC needs and position the room for future uses. The upgrade is anticipated to begin on July 10, 2024 and will take about three weeks to complete.

ADOPT AN ORDINANCE APPROVING TEXT AMENDMENT TO TITLE 19 ZONING OF THE BUENA PARK MUNICIPAL CODE TO CHANGE THE FENCE SETBACKS IN COMMERCIAL AND INDUSTRIAL ZONES

Mayor Sonne stated that this was the time and place for a public hearing to consider an Ordinance approving Text Amendment No. C-24-3 and find that the proposed Zoning Code Text Amendment is exempt from CEQA pursuant to State CEQA Guidelines Section 15061(b)(3) and Section 15303(e).

Planning Manager Meshram provided a report regarding a change to the fence setbacks in commercial and industrial zones. The City's Planning Division received multiply inquiries from property owners and businesses proposing to install a six-foot high fence within the parking setback area to better secure parking areas overnight or during other periods of inactivity. However, existing setback requirements only allow a 2-foot high solid fence or 3.5-feet high for a non-view-obscuring fence within the required parking setback. Fences higher than that along a street are permitted at the building setback line, but would result to a loss of existing parking spaces. The proposed amendment to Title 19 of the Buena Park Municipal Code will allow a 6foot high decorative and non-view-obscuring fence up to the parking setback. The review process will require zoning compliance review by the Planning Division and may require a building permit from the Building Division depending on factors specific to each site. Additionally, Planning Manager Meshram noted that the Zoning Text Amendment is exempt from CEQA pursuant to CEQA Guidelines Section 15061 (b)(3), which only applies to projects that have the potential for causing a significant effect on the environment and does not apply where it can be seen with certainty that there is no possibility of a significant effect. The proposed ordinance is also categorically exempt from CEQA under the Class 3 exemption set forth in State CEQA Guidelines section 15303(e), which specifically lists the construction of appurtenant accessory structures and fences as examples of activity that expressly falls within this exemption.

Mayor Sonne opened the public hearing and inquired if anyone present desired to speak. There being no requests to speak, Mayor Sonne closed the public hearing.

Council Member Castañeda asked about the text amendment's applicability to a daycare facility in District 2.

Planning Manager Meshram explained that the applicability of the ordinance would depend on the zoning of the property. Pursuant to the ordinance, commercial and industrial zone applicants could apply for a fence permit at a location that matches their parking setback line, is decorative in nature and non-view obscuring, through a zoning compliance review.

Council Member Traut reported attending the March 28, 2024 OCFA Board of Directors meeting wherein the Board received an update regarding the OCFA's Joint Powers Agreement. - 9. STUDY SESSION (9A 9C)
- 9A. DISCUSS AND PROVIDE DIRECTION REGARDING THE SECURITY UPGRADES FOR THE WHITAKER-JAYNES ESTATE & BACON HOUSE

Assistant City Engineer Arabolu and Police Captain Nguyen provided a report regarding the proposed security upgrades for the Whitaker-Jaynes Estate and Bacon House. Since January 2023, there has been some serious security incidents at the premises, including graffiti on the exterior of the building, damage to the water fountain, unauthorized access to the service hatch located beneath the Bacon House that led to a fire, damage to the air conditioning unit, attempted glass breakage on both east and west sides of the building, and instances of transients sleeping in the garden area of the building. Staff conducted a thorough field investigation to identify the building's vulnerabilities and has taken action against the threat of unauthorized users, one of which is a lack of complete enclosure of the property. Staff presented options for City Council consideration regarding physical changes to the property to enhance and heighten security, and sought direction on how to proceed with such proposed security upgrades.

The City Council asked about considering a high pitch noise machine to deter intruders; front fencing options; and, the difference in cost of gate options.

Assistant City Engineer Arabolu indicated that a high pitch noise machine used in security systems has not been explored. The alarm system being considered is one that includes fire and burglary monitoring. As for the front fencing, Assistant City Engineer Arabolu explained that the fencing will be exactly where it is now. There may be an obstruction on the new signage. Nevertheless, the sign would either be relocated or its configuration would need to be changed. Moreover, there is no significant difference in costs on the gate options, but staff indicated that the 6-ft. high single swing gates would be a better option so the existing plaque would not need to be relocated.

Director of Government and Community Relations/City Clerk Jimenez acknowledged an email correspondence in support of the security upgrades for the Whitaker-Jaynes Estate and Bacon House from North Orange County Chamber CEO Andrew W. Gregson.

Council Member Brown provided examples of serious security incidents that occurred at the Whitaker-Jaynes Estate and Bacon House, and encouraged the City Council to proceed with the security upgrades at the premises.

Following the discussion, the City Council directed staff to immediately upgrade the fence, gates, CCTV system, and alarm system at the Whitaker-Jaynes Estate and Bacon House.

# 9B. DISCUSS AND PROVIDE DIRECTION REGARDING NORTH SERVICE PLANNING AREA (NSPA) FUNDING OPTIONS

City Manager France provided a report regarding funding options for the North Service Planning Area (NSPA). In 2020, the NSPA opened two navigation centers for the unhoused in the cities of Placentia and Buena Park. The NSPA agreement was approved and signed by all the cities, except Anaheim, details the legal arrangement between the cities who belong to the north service planning area, and binds the group to operate the navigation centers, collectively. Moreover, the original NSPA agreement included a funding formula for the two navigation centers. The formula was based on a variety of factors and each city in the NSPA is allocated a cost annually to fund maintenance and operations of the two navigation centers. Buena Park funds its portion of the maintenance and operation of the navigation centers from Permanent Local Housing Allocation (PLHA)/Senate Bill 2 (SB 2) funding. City Manager France explained the source of the PLHA/SB 2 funding, and presented a breakdown of the total PLHA/SB 2 funding the City is anticipated to receive and Buena Park's portion of maintenance and operations costs for the two shelters for Fiscal Years 2019-2020 (Year 1), 2020-2021 (Year 2), 2021-2022 (Year 3), 2022-2023 (Year 4). It was noted that the City only received PLHA/SB 2 funding for Year 1. The City applied for Years 2 and 3 funding. However, no funding has been received at this time. Staff sought City Council direction on whether or not to continue utilizing PLHA/SB 2 funding for the navigation center maintenance and operations; other funding sources the City Council desires to utilize; and, potential uses of uncommitted balance of approximately \$700,000 following the disbursement for Year 4.

Vice Mayor Ahn suggested staff to ensure other cities are contributing to their share of the maintenance and operations expenses at the navigation center. Additionally, Vice Mayor Ahn suggested to utilize the uncommitted balance of approximately \$700,000 for affordable housing development in the City.

Council Member Castañeda spoke in support of Vice Mayor Ahn's suggestion to utilize the uncommitted balance of approximately \$700,000 for affordable housing development in the City. Also, Council Member Castañeda asked about the probability of Prop 1 implementation to cause a change to the formula of PLHA/SB 2 funding in the future, and the probability to allocate a certain amount of General Fund money to fund a new affordable housing or low to moderate income housing project.

Council Member Traut asked about senior affordable housing in the City. Moreover, Council Member Traut spoke in support of utilizing the uncommitted balance for some type of homelessness continuum of care.

Director of Community and Economic Development Foulkes explained that the \$2 million allocated for the Orchard View Gardens Senior Housing Project came from the Low and Moderate Income Housing Asset Fund, and there is no real funding left in that category.

Mayor Sonne Asked about the conditions for use of the uncommitted balance of approximately \$700,000 of PLHA/SB 2 funding; amount the City would receive if another funding source is utilized; flexibility in the PLHA/SB 2 funding to incentivize for an affordable housing project; and, possibility of increase in the uncommitted balance.

City Manager France indicated that the City would have to backfill funding the City is anticipated to receive from Years 2, 3, and 4 from the General Fund or CDBG Fund. City Manager France also explained that the use of PLHA/SB 2 funding is more restrictive compare to other funding sources. There is, however, a possibility for the uncommitted balance to increase depending on real estate transaction. Staff will bring an item at the May City Council meeting pertaining to development fees.

Director of Finance Hyun explained that the City Council has the most discretion on General Fund dollars to fund public activities. Moreover, the City is dependent on sales tax revenues. With the suggested moderate income housing efforts, there is a possibility that there would be no flexibility to balance the budget every year.

Vice Mayor Ahn spoke about her intentions to incentivize developers to come to Buena Park to build affordable housing, healthcare facility, or assisted living for seniors in the community. Vice Mayor Ahn noted that she desires for the City to continue with existing programs, and at the same time, be able to put aside funds for other substantial programs to address the needs of the members of the community.

Following further discussion, the City Council directed staff to continue paying for the navigation center maintenance and operations with PLHA/SB 2 funds; continue saving the uncommitted fund balance until the City is able to finance an affordable housing project; and, look for other possible funding options for incentivizing affordable housing.

# 9C. DISCUSS AND PROVIDE DIRECTION REGARDING THE CITY COUNCIL MEETING CALENDAR

Director of Government and Community Relations/City Clerk Jimenez informed the City Council about Council Member Castañeda and Traut's absence at the April 23, 2024 City Council meeting, and inquired if other Council Members will be present in person to establish a quorum. There is a public hearing and City Selection Committee appointment schedule for the said meeting date. Additionally, Director Jimenez sought City Council direction on whether or not to designate the second meeting in August as a Legislative Recess. Director Jimenez indicated that at last year's legislative recess, staff used the time to focus on projects, and hold staff and Commission/Committee Member trainings, to which staff was grateful.

The City Council confirmed a quorum for the April 23, 2024, City Council meeting, and directed staff to designate the second meeting in August as a legislative recess.

#### 10. CITY MANAGER REPORT

City Manager France announced the Volunteer Recognition: Viva Las Volunteers event on Wednesday, April 17, 2024, 1:00 p.m., at the Ehlers Event Center.

## 11. COMMISSION & COMMITTEE UPDATES

Director of Government and Community Relations/City Clerk discussed that the last session of the Buena Park Community Academy ended on Thursday, April, 4, 2024. The group will have their bus tour around the City on Thursday, April 11, 2024, and is scheduled to be recognized at the April 23, 2024 Regular City Council meeting.

## 12. ADJOURNMENT

There being no further business, Mayor Sonne adjourned the meeting at 7:31 p.m. The meeting was adjourned in memory of former Buena Park Police Department Corporal Mike Cook.
