5A. RESOLUTION APPROVING PLANS, SPECIFICATIONS, AND APPROVAL OF CONTRACT WITH R.J. NOBLE COMPANY FOR THE 2023-2024 ANNUAL PAVEMENT REHABILITATION PROJECT

Recommended Action: 1) Adopt a resolution approving the plans and specifications for the 2023-2024 Annual Pavement Rehabilitation Project; 2) Award a contract to R.J. Noble Company in the amount of \$1,363,330; 3) Authorize contingency funds in the amount of \$140,000 in the same purchase order; 4) Authorize construction engineering in the amount of \$30,000; 5) Authorize the purchase of manhole lids in the amount of \$30,745; 6) Authorize a purchase order for the Solis Group in the amount of \$4,860 for administration of the Community Workforce Agreement (CWA); 7) Authorize contingency funds in the amount of \$1,620 for the CWA administration; 8) Authorize the City Manager and City Attorney to make any necessary, non-monetary changes to the

contract; and, 9) Authorize the City Manager and City Clerk to execute the contract.

Associate Engineer Alqam provided a report regarding an approval of contract with R.J. Noble Company for the 2023-2024 Annual Pavement Rehabilitation Project. The City performs annual pavement rehabilitation projects to ensure the safety, functionality, and longevity of road infrastructure. The 2023-2024 Annual Pavement Rehabilitation Project will include removing and replacing street pavement, sidewalks, curbs and gutters, cross gutters, curb ramps, striping, and traffic loops in the area north of Artesia Boulevard and south of Pacific Avenue between Rostrata Avenue and Beach Boulevard. Academy Drive, Campus Drive, and Faculty Circle will also receive treatment and rehabilitation. Academy Drive will be evaluated for new striping layouts to be implemented as part of this project. Project construction is scheduled to begin on June 2024 and completed in August 2024. The project was advertised for competitive bid on April 17, 2024. The City received and publicly opened five bids on May 1, 2024. The lowest, responsible bid was submitted by R.J. Noble Company of Orange, CA in the amount of \$1,363,330. Staff recommended that the City Council award a contract to R.J. Noble Company and approve contingency funds in the amount of \$140,000.

Council Member Traut requested for staff clarification on comments made by the public pertaining to the work on Academy Drive and their request to address lights and signage concerns.

Director of Public Works/City Engineer Mikhael explained that Assistant City Engineer Arabolu met with the FIT Committee and school staff to discuss their traffic and safety concerns on Academy Drive. Stakeholders, including residents and school staff, provided recommendations to treat and rehabilitate Academy Drive and areas surrounding the Buena Park High School. The Traffic and Transportation Commission reviewed the options, and then voted to proceed with one of the options including additional angled parking on the street. Director Mikhael also discussed that Public Works have done work such as refreshed the crosswalks, added signs, and built a new ADA curb ramp until the approval of the 2023-2024 Annual Pavement Rehabilitation Project. As for lighting, staff is currently working with SCE to construct new lighting in the area.

Council Member Castañeda asked about holding a community meeting to receive input on the design phase of the project from residents.

Associate Engineer Alqam advised that there is a possible risk of increase in cost associated with the changes made after the approval of the 2023-2024 Annual Pavement Rehabilitation Project.

Jacqueline Murillo, Buena Park resident, spoke regarding advocating for the Spanish speaking community and their participation in making decisions for the City. Ms. Murrillo requested the City Council to move forward with the improvements as discussed.

5B. RESOLUTION ESTABLISHING NEW RATES FOR THE COLLECTION, RECYCLING, AND DISPOSAL OF REFUSE AND APPROVAL OF A UTILITY BILL INSERT REGARDING THE NEW RESIDENTIAL REFUSE RATES

Recommended Action: 1) Adopt a Resolution establishing new rates for the collection, recycling, and disposal of refuse; and, 2) Approve a utility bill insert notifying residential customers of the new rates.

Public Works Manager Hunt provided a report regarding the new rates for the collection, recycling, and disposal of refuse. The City Council may increase the rates due to inflation and in reference to the annual percentage increase in the Los Angeles-Riverside-Orange County Consumer Price Index (CPI). EDCO has seen increases to the Consumer Price Index (CPI) that impact their costs to collect, recycle, and dispose of refuse at County landfills. Cost increases include tipping fees at county landfills increasing \$1.34/ton, increased cost of fuel for vehicles, compensation for employees, and price of trucks and other equipment necessary to operate. Public Works Manager Hunt also explained the increases as it affects both the commercial and residential rates. It was noted that as the proposed fee increases are limited to the CPI, a public hearing and extended notice period are not required for implementation. Staff also recommended that the City Council approve a utility bill insert regarding the new residential refuse rates prior to the fee being implemented. Customers will not see fee increases on their bills until August.

Director of Community and Economic Development Foulkes provided a report regarding the purchase and sale agreement of a City-owned land for the development of a multi-tenant commercial center and electric vehicle charging facility at 7232, 7236, 7242 Artesia Boulevard and 6011 Botryoides Avenue. The project site is currently divided into eleven parcels. Director Foulkes explained that, as part of the project, a parcel map is proposed to reconfigure the property into three parcels for uses as indicated in the agenda report. On April 10, 2024, the Planning Commission considered and unanimously approved a Conditional Use Permit, Tentative Parcel Map, and Sign Program for the project as well as found the project Categorically Exempt from CEQA. Moreover, Director Foulkes discussed the Purchase and Sale Agreement with a purchase price of \$1,000,000 and an initial deposit of \$50,000; the Purchase Price Loan in the amount of \$950,000; the Surplus Lands Act; and, the California Environmental Quality Act (CEQA) exemption.

- 9A. DISCUSS AND PROVIDE DIRECTION REGARDING THE DEVELOPMENT IMPACT FEE DRAFT REPORT

This Item is to discuss the methodologies and recommendations from the Development Impact Fee Study conducted by Willdan Financial Services.

Director of Public Works/City Engineer Mikhael provided a report regarding the development impact fee draft report. The City Council awarded a contract with Willdan Financial Services to conduct a comprehensive Development Impact Fee Study (DIF) for the City. The objective of the development impact fee study is to identify the financial impact future developments will have on public services and infrastructure and ensure new developments pay the proportional costs associated with the City's growth. The report calculates and presents recommended amendments and additions to development impact fees that will enable the City to expand its inventory of public facilities as new developments create more demands for service.

James Edison, Willdan Managing Principal, discussed the study conducted by Willdan and provided recommendations on other eligible development impact fees that the City should consider. The new development impact fees include an affordable housing in-lieu fee, water impact fee, and sewer impact fee. Furthermore, Mr. Edison discussed the major planned facilities for the parks, transportation, sewer, and water categories; explained the current and proposed fees for each; and, illustrated the affordable housing in-lieu fee schedule. Furthermore, implementation options were provided for City Council consideration.

Council Member Castañeda asked about the rates used for mixed-use development; and, likelihood of industrial developments in Buena Park and applying fees accordingly to such.

Council Traut asked about the account to which the two new development impact fees would be going; the letter received from the BIA; and, best practices from other cities regarding implementing development impact fees.

Mr. Edison explained that the rate would depend on the individual elements and size of the development. As for best practices, Mr. Edison indicated that it is a case by case basis.

Director of Community and Economic Development Foulkes explained that there is a section within the City primarily dedicated to industrial developments. Even though, it is not the City's primary area of growth, there is definitely a demand in industrial development. Director Foulkes also explained the impact a development produces on the community. There is a possibility to push to the maximum allowable rates, but staff and Willdan would not recommend going higher than the maximum justifiable. Moreover, Director Foulkes discussed the letter received from the BIA and the agency's concerns on additional development impact fees.

Director of Public Works/City Engineer Mikhael indicated that the water and sewer development impact fees would be reserved for capacity enhancing projects, such as building new water wells for more capacity to upsize sewer or water lines.

Council Member Castañeda asked about the feasibility of a fee deferral program, and suggested for the City Council to consider a policy to lower the maximum allowable rates for residential sites as well was to waive or defer the park-in-lieu fee. Council Member Castañeda also requested for staff provide information comprehendible to the residents.

Council Member Brown spoke in support of increasing the development impact fees as presented. This effort would allow for future updates on parks, sewers, transportation, and water in the City.

Vice Mayor Ahn asked about the proposed new development impact fees impact on already approved projects.

Director Foulkes explained that some cities offer a fee deferral wherein fees are typically due upon permit issuance. The City could also allow to defer payment of impact fees until certificate of occupancy. Moreover, as an implementation measure, staff would recommend that all projects that already received their entitlements would be subject to the fees in place at the time of that approved entitlement.

Following the discussion, the City Council directed staff to proceed with the fee adoption, including the new water and sewer facilities and affordable housing impact fees, at a future public meeting.

9B. DISCUSS AND PROVIDE DIRECTION REGARDING RESPONSES TO THE ENERGY CONSERVATION AND EFFICIENCY PROJECT (ESCO) REQUEST FOR PROPOSALS

Director of Public Works/City Engineer Mikhael provided a brief explanation of the Energy Conservation and Efficiency Project (ESCO) and its approach to minimize public agencies carbon footprint while simultaneously reducing energy costs by utilizing sustainable designs and improvements. Director Mikhael introduced NV5 Executive Director of Business Development Aldo Mazzaferro to provide a report regarding the ESPC Programs.

Aldo Mazzaferro, NV5 Executive Director of Business Development, provided a report regarding the ESPC Programs; ESPC benefits, Five Phases of an ESPC; Activity to Date; NORESCO Proposal Highlights; and, Next Steps.

Following the discussion, the City Council directed staff to negotiate the agreement with NORESCO to perform the investment grade audit and design work, and return with a list of proposed projects.

9C. DISCUSS AND PROVIDE DIRECTION ON AMENDMENTS TO THE BUENA PARK MUNICIPAL CODE PERTAINING TO URBAN HOMESTEADING

Director of Community and Economic Development Foulkes provided a report regarding the potential amendments to the Buena Park Municipal Code (BPMC) pertaining to urban homesteading. Currently, the BPMC only allows horticultural production, the keeping of small animals, and beekeeping, on properties located within the Agricultural (A) Overlay zone. There are 15 parcels in the City with this overlay zone, all located on one street: Haldor Place. The City Council directed staff to seek the Climate Action Commission's review and recommendation on the said matter. Director Foulkes discussed the Climate Action Commission's recommendations regarding regulations for the keeping of bees and keeping of chickens within single-family residential zones. Moreover, it was noted that the recommended regulations balance the needs of the urban homesteader while minimizing impacts to adjacent properties. An online survey was made available regarding urban homesteading activities, which received 874 responses. 66.8% of which voted in favor and 33.2% voted against urban homesteading. Staff sought City Council direction to proceed with amendments to Title 19 (Zoning) with recommendations from the Planning Commission, and for the City Council to review the Municipal Code Amendment at a future meeting.

Mayor Sonne asked about the maximum number of chickens that could be kept on a property.

Director Foulkes discussed the chicken pecking order and the recommended minimum number of chickens per property. Director Foulkes, however, noted that there was no discussion or recommendation regarding establishing a minimum number per property.

Kathy Crutchfield, Buena Park resident, spoke regarding her concerns of farm animal keeping nuisance.

Council Members Traut and Castañeda spoke in support of urban homesteading activities in Buena Park. Council Member Traut also acknowledged newly appointed Climate Action Commissioner Brandon Schooner for sharing his expertise on the topic.

Following the discussion, the City Council (Brown dissented) directed the Planning Commission to consider and make recommendations for text amendment to Title 19 of the Buena Park Municipal Code prior to returning to the City Council for formal adoption at a future public hearing.

9D. DISCUSS AND PROVIDE DIRECTION REGARDING THE PLACEMENT OF A DOG PARK AT THE CIVIC CENTER

Director of Community Services Box provided a report regarding the proposed placement of a dog park at the Civic Center. After assessing potential locations within the Civic Center property, it was determined that the only feasible area to host a dog park would be the quarter-acre space in the far east end, adjacent to the Ganahl Lumber and Community Center parking lots, north of Pinchot Court. Currently, the space houses City vehicles and trailers, including two Star Transportation buses, two City street sweepers, and various large storage containers for Community Services, Police, and Public Works. Director Box also discussed the various modifications that would need to be done in order to support the practicality and viability of constructing a dog park at the site. It was noted that there is no funding budgeted for this project at this time. Staff sought City Council direction on whether or not to proceed with the project and engage a consultant to analyze the project feasibility and/or design. Additionally, staff recommended that the City Council direct the Community Services Commission to review and provide input on the said feasibility study prior to the City Council's consideration at a subsequent City Council meeting.

Council Member Castañeda sought the City Council's support to proceed with placement of a dog park at the Civic Center as well as to direct the Community Services Commission for additional input.

Council Member Brown spoke against the idea of placing a dog park at Civic Center property. Instead, a dog park could be built at other parks in the City.

Council Member Traut suggested to review other dog park locations in the City and find a funding source for such project.

Vice Mayor Ahn indicated her concerns about constructing a dog park on Civic Center property.

Mayor Sonne spoke in support of Council Member Traut's suggestion to consider other potential dog park locations in the City.

Following the discussion, the City Council directed staff to direct the Community Services Commission to discuss the potential location for a dog park in the City.
