5A. CONTRACTS WITH AYALA ENGINEERING, INC., BIG BEN ENGINEERING, MIKE PRLICH AND SONS, INC., AND W.A. RASIC CONSTRUCTION FOR ON-CALL EMERGENCY SEWER REPAIR SERVICES

Recommended Action: 1) Approve a contract with Ayala Engineering, Inc. to provide on-call emergency sewer repair services without a guaranteed minimum and a not-to-exceed amount of \$300,000; 2) Approve a contract with Big Ben Engineering to provide on-call emergency sewer repair services without a guaranteed minimum and a not-to-exceed amount of \$300,000; 3) Approve a contract with Mike Prlich and Sons, Inc. to provide on-call emergency sewer repair services without a guaranteed minimum and a not-to-exceed amount of \$300,000; 4) Approve a contract with W.A. Rasic Construction to provide on-call emergency sewer repair services without a guaranteed minimum and a not-to-exceed amount of \$300,000; 5) Authorize the City Manager and City Attorney to make any necessary, nonmonetary changes to the contracts; and, 6) Authorize the City Manager and City Clerk to execute the contracts.

Associate Engineer Miller provided a report regarding the approval of contracts for on-call emergency sewer repair services. The City of Buena Park Sewer Services Division operates and maintains more than 168 miles of sanitary sewer mains as well as around 3,400 manholes each year. Other than the routine maintenance performed by the City's sewer staff, there are instances when sewer mains or manholes fail and require emergency repairs. In some cases, the scope of these repairs exceeds the capabilities of City staff. Therefore, a contractor is hired to complete the repairs and prevent further damage to the sewer facilities. Under the previous on-call emergency repair sewer contract, nine emergency sewer failures were addressed, totaling to repair costs of approximately \$290,000. Associate Engineer Miller emphasized that maintaining on-call contracts for emergency sewer repairs ensures that the City can promptly address failing sewer facilities while minimizing repair costs. Staff issued an RFP on February 20, 2025, and received four bids on March 12, 2025 from Ayala Engineering, Inc., Big Ben Engineering, Mike Prlich and Sons, Inc., and W.A. Rasic Construction. All contractors possess the required licenses and the necessary experience to perform the emergency repair services. It was noted, on the other hand, that when a service is required, the City will still request a proposal from the approved contractors. A letter proposal will then be agreed upon by the City and the Contractor before a Notice-to-Proceed is issued for each event. Nevertheless, due to the on-call nature of this agreement, work is not guaranteed to any contractor. Within the City's Community Workforce agreement (CWA) under exclusions, the City Council has made a determination to forego competitive bidding in awarding of Contracts for any work that is urgent or emergency in nature. Furthermore, it was recommended that the City Council approve a twoyear contract without a guaranteed minimum and not-to-exceed amount of \$300,000 for each contractor.

Mayor Ahn thanked Director Box, Community Services Supervisors Hurtado, Sauceda, and Kurata, and Community Services Department staff for their assistance in making the April 5, 2025 Korean Resource Fair a success. Additionally, Mayor Ahn thanked Senior Management Analyst Fewer, Video Services Technician Ayala, and Marketing Specialist Englebrecht for their assistance in the Wyland National Mayor's Challenge for Water Conservation video. Mayor Ahn encouraged residents to make a pledge to be "water-wise" by conserving water, energy and other natural resources on behalf of the City.

- 9. STUDY SESSION (9A 9C)
- 9A. DISCUSS AND PROVIDE DIRECTION REGARDING VETERANS HONOR CELEBRATION ENHANCEMENTS

Community Services Supervisor Hurtado provided a report regarding options for the Veterans Honor Celebration enhancements. The City hosts an Annual Veteran's Honor Lunch Celebration in November to honor local heroes. Council Member Hoque suggested two supplementary programs to enhance the event to include a Veterans Resource Fair and a Veterans Flag Distribution. Community Services Supervisor Hurtado explained the plans for the two additions. For the Veterans Resource Fair, veterans and their families will have access to essential services and information, fostering better integration into community resources. Participants will have the opportunity to obtain crucial resources spanning various areas, including healthcare assess, financial literacy, legal assistance, mental health services, and more. Moreover, the resource fair would aim to serve as a vital networking platform, enabling veterans to connect with representatives from organizations that can cater to their specific needs. On the other hand, the Veterans Flag Distribution will honor and show appreciation for Buena Park veterans through personalized flags recognizing their service. Community Services Supervisor Hurtado discussed the process and criteria of being selected to receive a flag. Furthermore, the addition of the Veterans Resource Fair and the Veterans Flag Distribution programs could significantly enhance the Annual Veteran's Honor Lunch Celebration by providing meaningful support to our local veterans. Staff sought City Council direction to begin the necessary preparations for the resource fair and flag distribution, including outreach to potential partners and veterans organizations, application development, and logistical planning for the events.

Council Member Hoque discussed her reasons for bringing the item forward, and sought the City Council's support to proceed with the proposed Veterans Honor Celebration enhancements.

Council Member Sonne, Council Member Franco, and Vice Mayor Traut spoke in support of the Veterans Honor Celebration enhancements.

Mayor Ahn asked about the number of war veteran Buena Park residents; plans for veterans flag delivery; and plans for advertising the veterans flag distribution.

Council Member Hoque volunteered to assist with the delivery of the veteran flags in the event that a Council Member is unavailable.

Community Services Supervisor Hurtado explained that the veterans flag distribution would serve as an enhancement to the Annual Veteran's Honor Lunch Celebration held in November; and, the selection criteria for such program.

Following the discussion, the City Council directed staff to proceed with the necessary preparations for the Veterans Honor Celebration addition of a resource fair and flag distribution such as outreach to potential partners and veterans organizations, application development, and logistical planning for the events.

# 9B. DISCUSS AND PROVIDE DIRECTION ON THE DEVELOPMENT OF AN ARTS AND CULTURE MASTER PLAN FOR THE CITY OF BUENA PARK

Community Services Supervisor Sauceda provided a report regarding the development of an Arts and Culture Master Plan for the City of Buena Park. An Arts and Culture Master Plan's purpose is to provide a five-to-ten-year strategic plan that defines the role of the City supporting arts and culture and the role of arts and culture in accomplishing the City's broader goals; and, a solid foundation with both short-term and long-term goals as well as a clear and impactful vision for the future. The Master Plan will focus specifically on how arts contribute to Buena Park's culture and identity; outline key goals, provide recommendations, and establish strategies for engaging the community through arts programming; and, help identify opportunities to grow the City's cultural offerings, encourage partnerships with arts-minded businesses, and enhance arts education programs. Moreover, Community Services Supervisor Sauceda discussed the goals of the Arts and Culture Master Plan and the existing Arts and Cultural Programs in the City. Staff sought City Council direction to issue a Request for Proposal (RFP) to guide the development of the Master Plan and approval of a budget appropriation to support its creation.

Council Member Hoque spoke regarding the importance of developing an Arts and Culture Master Plan; and, asked about the possibility of encouraging future developers in Buena Park to incorporate art into their projects and the feasibility of modifying the scope of work to reduce the cost of the Master Plan.

Vice Mayor Traut spoke in support of the development of an Arts and Culture Master Plan for the City of Buena Park, and about the possibility of relaying the discussion to the Cultural Engagement Commission.

Council Member Sonne spoke regarding the benefits of arts to people, and her concerns on the impact of such project to the current economic environment. Also, Council Member Sonne asked about the budget allocation for moving forward with the Arts and Culture Master Plan, and suggested to conduct further research to better understand the fiscal impact of such project.

City Manager France indicated that the budget allocation depends on the timeline of the City Council's approval to create an Arts and Culture Master Plan

Council Member Franco spoke in support of the development of an Arts and Culture Master Plan.

Mayor Ahn spoke in support of the development of an Arts and Culture Master Plan. Nevertheless, Mayor Ahn stated that there is no critical need of allocating a budget for such project at this time, and suggested to table the item and return at a City Council meeting in September or October.

Vice Mayor Traut sought City Council consideration to have the Cultural Engagement Commission review potential costs and make recommendations on elements that are necessary to be incorporated in the City's Arts and Culture Master Plan.

Council Member Sonne expressed interest in knowing the details of the development of an Arts and Cultural Master Plan, and requested a "menu" style presentation of plans developed by Arts OC.

Community Services Supervisor Sauceda clarified that staff is seeking City Council direction on elements to be included in the Master Plan. Additionally, Community Services Supervisor Sauceda indicated that there are aspects of the Parks and Recreation Master Plan that could be integrated into the Arts and Culture Master Plan to help reduce costs.

Richard Stein, President and CEO of Arts OC, explained the work of Arts OC; the purpose of an Arts and Culture Master Plan and its various elements; and, the community benefits of arts in public spaces. Mr. Stein offered to share previous plans Alerts OC has developed for the City Council to review.

City Manager France offered for staff to review the Master Plans available with each Council Member.

Following the discussion, the City Council referred the discussion of the development of the Master Plan to the Cultural Engagement Commission, and requested staff to meet with each Council Member to review and discuss their preference on elements to be included in the City's Arts and Culture Master Plan.

# 9C. DISCUSS AND PROVIDE DIRECTION REGARDING DEVELOPMENT AND CONSTRUCTION PROCESS IMPROVEMENTS

Director of Community and Economic Development Foulkes provided a report regarding development and construction process improvements. The Community and Economic Development Department (CEDD) consists of five divisions: Planning, Building, Code Enforcement, Economic Development/Housing and Sustainability. Most construction projects are reviewed by both the Planning and Building Divisions, ultimately leading to building permit issuance and construction inspections. Director Foulkes discussed the Department's current staffing level, specifically that of the Planning and Building Divisions; workload and performance metrics; difference of discretionary and ministerial approval; common challenges such as misunderstanding, miscommunication, misrepresentation of the project, inaccurate or incomplete plans, and underperforming contractor/communication breakdown; and, opportunities for improvement. Director Foulkes indicated that the Planning Division is working on updating the Zoning Code to address new trends in the commercial and entertainment sectors. These updates aim to revise parking requirements, reduce the need for parking variances, and simplify the review process by allowing certain projects to be reviewed 'by-right' instead of requiring discretionary action. The goal is to streamline development and business activities in Buena Park while ensuring quality, health, and safety. Nevertheless, changes to the Zoning Code will need approval from the Planning Commission, the City Council, and a public meeting.

Mayor Ahn asked about the possibility of expediting the turn-around time for planning review and approval of certain projects by the Planning Commission; and, timeline regarding filling in staff vacancies.

Council Member Sonne, Vice Mayor Traut, Council Member Franco, and Council Member Hoque commended Director Foulkes for the planned improvements in the Department.

Director Foulkes discussed the Department's improvement priorities and recommendations brought forward for City Council consideration; planning approval by the Planning Commission and a Zoning Administrator; noticing requirements for a public hearing; and, ongoing plans to fill vacancies;

# 10. CITY MANAGER REPORT

City Manager France reported the following:
