RECOMMENDED ACTION

Approval of up to \$400 for the Cupid Connections Senior Valentine's Event from the Interior Development Fund.

PREVIOUS CITY COUNCIL ACTION

The Senior Citizens Commission established a City fund entitled the Interior Development Fund (IDF) for monies received from fundraising events, gift shop revenues, and donations at the Senior Center. Requests for expenditures from this fund are to be submitted to the Commission for a majority vote approval.

At the May 14, 2024 Council meeting, the Council approved the amendment to City Council Policy No. 24 increasing City Council approval threshold of Commission Enterprise Fund Expenditures from \$1,000 to \$5,000. The disbursement of funds remains the responsibility of the respective commissions. Requests for expenditure must be submitted to the Commission for a majority vote approval.

Senior services is under the umbrella of the Community Services Commission. As such, staff will seek the Community Services Commission approval for the expenditures of the IDF. The funds requested by staff can be used for senior event support such as food purchases, decorations or event supplies. It can also be used for facility enhancement such as the purchase of senior center equipment or supplies benefiting center participants.

DISCUSSION

This year's valentine's celebration is themed "Cupid Connections" where we will be introducing an exciting speed dating opportunity for seniors seeking meaningful connections. We hope our seniors will come ready to mingle, dance and celebrate the spirit of Valentine's Day. Whether they are looking for romance or friendship, this evening promises to be filled with joy, laughter and wonderful connections. This event is scheduled for Wednesday, February 12, 2025 at 4:00 PM. Attendees can look forward to a 30 minute speed dating session for those interested, sip on a little bit of wine sponsored by Right at Home, enjoy a charcuterie sponsored by Alignment and dance the evening away with DJ Drew! 100 seniors are expected to attend, dressed in their holiday attire to join in on the fun.

Staff is seeking approval from the Community Services Commission for up to \$400 from the IDF (11-2248) to purchase 2 glass water jugs, serving trays for the charcuterie and decorations needed for the event. These items will enhance the event. The current balance of the Interior Development Fund is \$20,159.18.

BUDGET IMPACT

None. The Commission Enterprise Funds are separate from the City's General Fund.
