#### **DISCUSSION**

At the January 23, 2025 meeting, Vice Chair Frutos requested this item be calendared for discussion.

This discussion will explore current landscape maintenance practices, potential turf improvements, maintenance strategies, and security measures to better preserve city parks and enhance their usability.

Vice Chair Frutos has raised concerns regarding the overall condition of turf areas, including sports fields, which appear worn down and in need of upgrades. Specific issues include:

- Uneven surfaces and hidden low spots
- · Gopher activity causing instability
- Brown spots and deteriorating turf quality

Improving the look and feel of all turf areas is seen as an opportunity to enhance property values and align with the city's recent additions and developments.

City parks face challenges related to overuse and vandalism:

- Sports field usage is heavily limited, particularly for soccer, to prevent overuse and maintain turf quality.
- Despite restrictions, parks still attract significant drop-in, non-permitted use.
- Unauthorized vehicles have caused vandalism, with some intentionally damaging turf areas by performing "donuts".

To help address the vandalism, security cameras have been installed at several city parks, providing the Buena Park Police Department with video surveillance for general park supervision.

Public Works oversees landscape maintenance at city parks. Their current landscape maintenance programs include:

- Contract with Merchants, Inc. For landscaping services since 2013; contract renewed through end of 2025.
- Weekly mowing, edging, and weeding by Merchants.
- City facilities are irrigated by Calsense irrigation controllers.
- City staff aerates, seeds, and topdresses ballfields typically in preseason. This year did Bellis Park fields 3, 4, and 5 and some areas of fields 1 and 2. Requires approx. 3 weeks of field closure.

- Applied fertilizer at Boisseranc Park fields earlier this year.
- Backfilling as necessary at Bellis and Boisseranc by City staff.

#### Future possible turf improvements include:

- More frequent servicing by City staff is possible pending staffing and field availability.
- Potential to adjust scope of contractor services beginning in 2026.
- Staff requested proposals from Merchants for complete turf renovation of ballfields:
  - Includes dethatching/verticutting, aeration, overseeding with Grand Slam FS, fertilizationm and topdressing
  - Bellis Park \$22,770
  - o Boisseranc Park \$32,044
- Considering a compost-spreading trailer to aid in distributing compost onto fields/turf annually.



#### **DISCUSSION**

Each fall, usually September, since 1984, the Community Services Commission sponsors the annual Memorial Grove Ceremony in Boisseranc Park. The ceremony honors an individual who made a significant contribution of time and/or service to the community during his/her lifetime.

The City Council protocol on selection is as follows:

- Nominees must be deceased for at least three years to be selected. In 2022, City Council upheld the Commission's protocol to abide by its current three year waiting period before honoring a person in the Memorial Grove.
- 2. If the Commission wants to waive the three year waiting period for any individual, it would require City Council approval.
- 3. If the Commission wants to forgo a year because there isn't a strong enough candidate for selection, City Council will be notified.

A typical Memorial Grove Ceremony is as follows:

- Call to order by the Chairperson of the Community Services Commission who serves as the event emcee. All other Commissioners are introduced and are seated behind the podium.
- Invocation
- Presentation of Colors and the Pledge of Allegiance
- · Remarks by family and friends
- Presentation of City Council Resolution to family members
- Presentations by representatives of elected officials, if any, to family members
- Vocalists
- Ceremonial tree planting with photo opportunities

In addition, sometimes the family will display memorabilia and the city will provide a sign-in book and light refreshments.

Nomination forms are available on the city's website under the Community Services Department at buenapark.com.

Staff requests the Commission select the 2025 recipient. If more time is needed, staff can bring this item back to a future meeting. The Commission may also select the 2026 recipient as well.


