DISCUSSION

The Cultural Engagement Commission has been actively working to enhance the Art in Public Places program across the City Council districts with artwork on utility boxes. Currently, district 2 remains the only district lacking this form of public art. Historically the locations selected are near busy intersections and the design tries to reflect the surrounding area. Staff has identified the northwest corner of Beach Blvd and Orangethorpe as an ideal site. This is one of the major arteries in the city with high visibility. There are two utility boxes on this corner. This corner sits opposite The Source where the first Koreatown sign was installed. The conceptual drawings are inspired by Korean culture.

RECOMMENDED ACTION

Tonight, staff is seeking approval from the Commission to approve the location and design for the utility boxes at Beach Blvd and Orangethorpe Ave.
