BACKGROUND/DISCUSSION:

To comply with the Truth-in-Taxation requirements, the City Council must take a record vote on the proposed tax rate. The rate and record vote will be published in the newspaper and on the City website. A draft notice will be distributed when available.

FINANCIAL IMPACT:

This item will have a financial impact, as tax revenue is a primary funding source of the budget, but the purpose of tonight's action is to satisfy State law and Truth-in-Taxation procedures.
