2.A. Traffic Safety Advisory Board Training, Responsibilities, & Functions of the Board-- Lee Howell, Asst. City Manager

Asst. City Manager Howell presented to the board.

#### 3. Business

3.A. Discussion Regarding Traffic Safety Concerns at Basswood/High Country Trail Intersection--Crystal Philp, Chairman

Chairman Philp discussed the concerns about the intersection needing lighted stop sign, staff gave an update on signs and discussed rumble strips

3.B. Discussion Regarding Traffic Safety Concern at Bar C Ranch Community, No Left Turn on East Bailey Boswell at Prairie Moon-- Paul Felegy, Mayor Pro-Tem

Mayor Pro-tem Felegy introduced accident issues at the intersection and asked City Engineer Trenton Tidwell to give an update on traffic signal funded grant in 2028. Mayor Pro-tem and Trenton discussed left turns at the intersection and signs that could be placed to prohibit it. Member Clayton Ray suggested no left turns from Jarvis on to Bailey Boswell and no left from Bailey Boswell to Prairie Moon. Member Burgdorf asked about finding sources. The Board heard public comments from Kelly Shilling, resident from Bar C Ranch.

3.C. Discussion Regarding Traffic Safety Concerns at Cattleman & Prairie moon--Paul Felegy, Mayor Pro-Tem

Board heard comments from Kelly Schilling, resident of Bar C Ranch concerning vehicles speeding on Prairie Moon and asked for a four way stop with flashing lights at the intersection.

3.D. Discussion Regarding Traffic Safety Concerns at (ILT) International Leadership of Texas School on N. Old Decatur Rd in Saginaw--Paul Felegy, Mayor Pro-Tem

Mayor Pro-tem Felegy and Member Burgdorf stated that issues with people exiting the International Leadership of Texas (ILT) north bound and making U turns. Discussion led to suggestions about "No U Turns" signs at W. J. Boaz road and other intersection breaks.

3.E. Discussion Regarding Traffic Safety Concern, School Zone Lights not functioning at proper times at Highland Station--Paul Felegy, Mayor Pro-Tem

Mayor Pro-tem Felegy started the discussion. Operations Manager Wrzesinski explained the equipment was old and had been fixed and was now functioning properly. Member Burgdorf asked if Eagle Mountain Independent School District shared any responsibility in maintenance. Mr. Wrzesinski responded to question with a "no", only the city.

3.F. Discussion Regarding Traffic Safety Concerns on Bailey Boswell Road--Kelly Schilling, Saginaw Resident

Saginaw resident Kelly Schilling covered response on previous item, 3B.

3.G. Discussion Regarding Traffic Safety Concern at Commanche Springs--Kelly Schilling, Saginaw Resident

Saginaw resident Kelly Schilling requested a three way stop at Cattleman's Dr. and Commanche Creek. Ms. Schilling added another concern that future Ft. Worth development would bog down roadway. City Engineer Mr. Tidwell stated that he would take a look into the Ms. Schilling concern.

Mr. Burgdorf asked about the "do not block intersection" sign. City Engineer stated it might help for the north bound traffic and would look into south bound solution.
