On Tuesday, December 5, 2023, the City Council received information in Executive Session pertaining to the specifics of a Building Improvement Grant (BIG) Program application submitted by Del Mar Property LP/King Laundry LP in regards to their property located at 416 Belmont St. The Council determined in that session to award an amount not to exceed \$5,000 in reimbursable and matching dollars for the anticipated improvements as proposed on their application. The agreement being considered tonight is the realization of that intention.

2D. Action regarding approval of Requests for Payment Under Beltmill PID Reimbursement Agreement--Kim Quin, Finance Director

** Item was Removed from Consent

The Beltmill Public Improvement District (PID) was created by the City Council on March 6, 2021 and a reimbursement agreement with Beltmill Saginaw, LLC was approved on December 7, 2021. Collections of assessments began in February of 2022. All assessments collected for the PID must be used for improvements within the PID. Only property owners within the PID are assessed. There are no tax revenues or other fees paid by Saginaw citizens that contribute toward the improvements within the PID. To date the only expenditures from the Beltmill PID have been monthly administrative fees. The first payment request of \$472,041.66 has been made by Beltmill Saginaw, LLC for authorized improvements made within the district. The improvements include

roads, water and sewer, and storm drainage infrastructure. These improvements total \$1,511,730.92 The requested reimbursement payment of \$472,041.66 will be paid from the Beltmill PID Fund Balance (previously collected assessments) and the anticipated 2024 request for \$472,341.66 will be paid from the 2024 assessment collections.

Motion was made by Mayor Pro-Tem Junkersfeld with a second by Councilmember Bighorse to approve Item 2D as presented. Motion carried unanimously. 7-0-0-0

4A. PUBLIC HEARING--Consideration and Action Regarding Approval to Consider an Ordinance Amending the Zoning Ordinance of the City of Saginaw regarding a Change to the Development Plan for the Square Planned Development (the Shoppes) on approximately 4.9 acres out of the Benjamin Thomas Survey, Abstract 14971, Tract 3B03A (per TAD) (Ordinance No. 2024-02)--Susy Victor-Trevino, Planning Manager

Public Hearing was opened at 6:08 PM and closed at 6:17 PM

Mayor Flippo opened the public hearing for this item at 6:08 p.m. Mr. Sagar Hamani requested approval of an amendment to the Development Plan of The Square Planned Development. He is requesting the plan be altered to change the layout of the building from two separate buildings to one building with a parking variation. The Planning and Zoning Commission considered this request at their meeting on December 12, 2023 and voted to recommend approval to the City Council.

Mayor Flippo called for public input. There was none. Mayor Flippo closed the public hearing at 6:17 p.m.

Motion was made by Councilmember Copeland with a second by Councilmember Lawson to approve Ordinance No. 2024-02 amending the Development Plan for the Square Planned Development. Motion carried unanimously. 7-0-0-0

5A. Consideration and Action regarding Consolidating Emergency Dispatch Services with Lake Worth--Russell Ragsdale, Police Chief

The proposed Interlocal Cooperation Agreement approves consolidated dispatch services with the City of Lake Worth into the Northwest Emergency Call Center (NWECC). The term of the agreement is two 1-year terms with the first being January 1, 2024 to September 30, 2024, and the second being October 1, 2024 to September 30, 2025. The cost for the first term will be \$429,653.

The cost for the second term will be \$601,511. The agreement contains a clause to terminate the agreement by either party with 180 days advance written notice.

Motion was made by Councilmember Edwards with a second by Councilmember Felegy to approve the Interlocal Agreement with Lake Worth consolidating emergency dispatch services. Motion carried. 5-2-0-0 (Bighorse and Junkersfeld against).

5B. Consideration and Action regarding Resolution 2024-01, Revisions to the City of Saginaw Personnel Policies--Melanie McManus, HR Director

Director of Human Resources McManus explained that Resolution No. 2024-01 revises the Personnel Policies Manual. The revision will replace the two floating holidays with two federal holidays: Martin Luther King Jr. Day and President's Day.

Motion was made by Mayor Pro-Tem Junkersfeld with a second by Councilmember Copeland to approve Resolution No. 2024-01 as presented. Motion carried unanimously. 7-0-0-0

5C. Consideration and Action regarding Award of Bid for Saginaw Switchyard Expansion--Laura Presley, City Engineer

On December 13, 2023, bids were received for the Saginaw Switchyard Expansion Project. A total of six bids were received. Kimley-Horn and Associates, Inc. has reviewed the lowest bidder's qualifications and has verified the contractor's bonding company is licensed in the State of Texas. Based on their review, it appears that MHB Construction is the lowest responsive bidder with a bid in the amount of \$246,774.25.

Motion was made by Councilmember Felegy with a second by Councilmember Edwards to award the bid for the Saginaw Switchyard Expansion to MHB Construction in the amount of \$246,774.25. Motion carried unanimously. 7-0-0-0

5D. Update on Pedestrian Bridge/Crossing in Highland Station Park--Trenton Tidwell, City Engineer, & Randy Newsom, Director of Public Works

Director of Public Works Newsom gave an update and recommendation for the crossing in Highland Station Park. He explained the purpose is to provide a crossing for residents in that area of Highland Station. He recommended that a culvert box be put in place and then a crossing be constructed across the culvert box rather than build a structure across the creek at this time. He added that this option will be less expensive and will expedite the improvements. He also recommended the City purchase the culvert box and bid out the construction portion. Additional improvements will be identified and added to the Capital Improvements Plan. City Engineer Tidwell briefly explained the recommendation includes 240' linear feet of 6' wide concrete

sidewalk including rails as it crosses the channel. He added that the project should be completed prior to the start of the 2024-2025 school year. The total estimated cost is \$220,000.

Motion was made by Councilmember Lawson with a second by Mayor Pro-Tem Junkersfeld to approve Item 5D as presented with the understanding that it will be completed before the 2024-2025 school year starts. Motion carried unanimously, 7-0-0-0

5E. Consideration and Action regarding Employee Survey Participation Results--Melanie McManus, HR Director

Director of Human Resources McManus stated that this item is for approval of the token of appreciation to employees for participating in the employee survey. At the September 6, 2023 City Council Meeting, the Council discussed awarding employees with one half day off work if total participation was over 80%. The final participation was 88%.

Motion was made by Mayor Pro-Tem Junkersfeld with a second by Councilmember Lawson to approve a half-day off work for employees for participation in the employee survey and the half-day be based on each employee's hourly work schedule. Motion carried unanimously. 7-0-0-0

BACKGROUND/DISCUSSION:

In January 2012, a Municipal Court of Record was established by the City Council and Attorney Lorraine Irby was appointed Judge. Judge Irby has been reappointed since the Municipal Court of Record was established. Associate Judges Wendy Cooper and Stewart Bass are appointed in conjunction with the Judge's appointment. Their terms of office expire on January 31, 2024. Ordinance No. 2024-1 appoints the Judge and Associate Judges for a one year term. The proposed Municipal Judge Agreement is the same as the current agreement with the only change being a \$50 increase in training expenses.

FINANCIAL IMPACT:

The annual cost of the Judge's services is \$45,360 and up to \$350 for training expenses. The cost of the contract is included in the FY2023/2024 Adopted Budget.

RECOMMENDATION:

Staff recommends approval of Ordinance No. 2024-1, appointment of Lorraine Irby as Municipal Court Judge, and Wendy Cooper and Stewart Bass as Associate Judges for one year beginning February 1, 2024; and approval of the Municipal Court Judge Agreement.

ORDINANCE NO. 2024-01

AN ORDINANCE OF THE CITY OF SAGINAW, TEXAS APPOINTING THE JUDGE AND ASSOCIATE JUDGES OF THE MUNICIPAL COURT OF RECORD IN THE CITY OF SAGINAW; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

- **WHEREAS,** the City of Saginaw, Texas, is a home rule city acting under its charter adopted by the electorate pursuant to article XI, section 5 of the Texas Constitution and chapter 9 of the Texas Local Government Code; and
- **WHEREAS**, the City Council has created a municipal court of record pursuant to Chapter 30 of the Texas Government Code; and
- **WHEREAS,** Chapter 30 of the Texas Government Code relating to municipal courts of record provides that the judge of the municipal court of record shall be appointed by the City Council by ordinance; and
- **WHEREAS,** the workload of the Saginaw Municipal Court is not large enough to support a full time Municipal Court Judge; and
- **WHEREAS,** it is of great benefit to the City of Saginaw to have an experienced municipal court judge sit on the bench of the municipal court of the City of Saginaw; and
- **WHEREAS,** Section 574.001, Texas Government Code requires that a finding be made to the effect that a person who serves as an officer in more than one appointed position obtain a finding from the governing body that such officer has satisfied Article XVI, Section 40, of the Texas Constitution; and
- **WHEREAS,** there is no conflict between the office of municipal judge of the City of Saginaw and the office of municipal court judge in any other municipality in the State of Texas; and
- **WHEREAS,** the City Council desires to appoint Lorraine Irby as municipal judge and Wendy Cooper and Stewart Bass as associate judges for the Municipal Court of Record in the City of Saginaw.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAGINAW, TEXAS:

SECTION 1.

It is hereby found that the office of municipal court judge of the City of Saginaw is of benefit to the State of Texas and to the City of Saginaw and that there is no conflict between the office of municipal judge of Saginaw and the office of municipal judge in any other city.

SECTION 2.

Lorraine Irby is hereby appointed as the Municipal Judge of the municipal court of record in the City of Saginaw, Texas for a one year term beginning February 1, 2024. At the expiration of said term, in accordance with Article 16, Section 17 of the Texas Constitution, Judge Irby shall continue to serve until her successor shall be duly qualified.

SECTION 3.

Wendy Cooper and Stewart Bass are hereby appointed as the associate judges to serve when the Municipal Judge is temporarily absent or unable to serve.

SECTION 4.

This ordinance shall be cumulative of all provisions of ordinances and of the Code of Ordinances of the City of Saginaw, Texas, as amended, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances and such Code, in which event the conflicting provisions of such ordinances and such Code are hereby repealed.

SECTION 5.

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

SECTION 6.

This ordinance shall be in full force and effect from and after its passage and it is so ordained.

MUNICIPAL JUDGE AGREEMENT

This Agreement is made by and between the City of Saginaw, Texas ("City") and Lorraine Irby ("Irby"), for the purpose of documenting the terms and conditions under which Irby will serve as municipal court judge for the City. It shall be performed in and is enforceable in Tarrant County, Texas.

Recitations:

- 1. Irby desires to contract with the City to serve as municipal court judge.
- 2. City desires to contract with Irby as an independent contractor to provide services as a municipal court judge.

Agreements:

- 1. Irby, while serving as municipal judge, has all the powers and shall discharge all the duties of a municipal judge, and shall serve at the pleasure of the City Council. Irby is expected To work the hours necessary to fulfill the obligations of the municipal judge in order to operate the *Municipal Court of Record of the City of Saginaw* in an efficient manner. The essential functions of the municipal judge include, but are not limited to:
 - a. presiding over trials and other court proceedings (including bench and jury trials);
 - b. accepting pleas;
 - c. processing appeals;
 - d. supervising the maintenance of official records of proceedings and the court;
 - e. conducting arraignments and performing the duties of magistrate under State law;
 - f. signing of warrants and issuance of subpoenas;
 - g. administering juvenile warnings; and
 - h. other functions established in the City's job description for the municipal judge.
- 2. City agrees to pay Irby \$45,360 per year for such services, payable in monthly installments on the first day of each month following a month of service, and annual Judicial Training expenses not to exceed \$350.
 - 3. Irby agrees that she is an independent contractor and is not entitled to any City

benefits, such as health insurance, vacation, or retirements.

- 4. The term of this agreement shall be effective on the date of mutual execution hereof and shall terminate on the one year anniversary of Irby's appointment by the City Council, which is January 31, 2025, unless sooner terminated by either party.
- 5. This agreement may be terminated by either party without cause upon fifteen (15) days written notice to the other party, and in the case of termination by the City upon compliance with Section 6.08(1) of the City Charter. Upon termination, neither party shall have any further obligation to the other under such agreement or for the termination thereof. It shall terminate immediately should Irby become permanent disabled or disqualified from performing such services.
 - 6. This agreement is made contingent upon appropriations for the funding hereof.
- 7. This agreement supersedes all other agreements, whether oral or written, between the parties with respect to the engagement of the municipal judge.
- 8. If any provision, or any portion thereof, contained in this agreement is held unconstitutional, invalid or unenforceable, the remainder of this agreement, or portion thereof, shall be deemed severable, shall not be affected and shall remain in full force and effect.

BACKGROUND/DISCUSSION:

The Advisory Recreation and Parks Board approved the funding to install a new restroom facility at Highland Station Park. This required a new electrical service to be installed by Oncor. When the install crew from Oncor came out to put in the new service, they informed us that they are no longer allowed to bore under a creek. This resulted in them setting a pole on each side of the creek and running the power line to the new restroom facility overhead. They told us if we wanted the new service line put under the creek that we'd have to do the bore ourselves. I have obtained a quote from Tudor Electrical Service, Inc. to do the work. Due to the holidays, I haven't been able to get any additional quotes from other vendors yet.

The total amount of the quote received is \$13,500. This is from an electrical contract the City has used in the past.

FINANCIAL IMPACT:

The total financial impact will be \$13,500 which will come from the General Fund Balance.

Staff recommends approval not to exceed \$13,500 for the bore and lowering of the power line under the creek. Staff will obtain two more quotes and use the lowest of the three.

BACKGROUND/DISCUSSION:

Resolution No. 2024-02 calls the City's General Election for Mayor and Council Place 2. It also calls a Special Election for the unexpired term of office in Council Place 4. The date of the General Election and Special Election will be May 4, 2024. The deadline for candidate applications for is Friday, February 16, 2024 at 5:00 p.m. (Note: City Hall will be open from 11:30 a.m. to 5:00 p.m. on February 16th only to accept candidate applications. No other business will be handled during these hours.) The proposed resolution was prepared by the City Attorney.

Note: On page 4 of the Resolution you will notice that the early voting location listed as number 1 is highlighted. EMS-ISD is preparing for demolition of that particular building so it will not be used for voting. Tarrant County is still in the process of determining early voting locations.

RESOLUTION NO. 2024-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAGINAW, TEXAS, CALLING FOR A GENERAL ELECTION TO ELECT THE OFFICES OF MAYOR, AND CITY COUNCIL PLACE 2 TO BE HELD ON MAY 4, 2024; CALLING FOR A SPECIAL ELECTION TO FILL THE UNEXPIRED TERM IN THE OFFICE OF CITY COUNCIL PLACE 4; APPROVING A JOINT ELECTION WITH TARRANT COUNTY; AND ESTABLISHING PROCEDURES FOR THAT ELECTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Saginaw, Texas (the "City"), is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, the regular election for City Council members of the City is required to be held on May 4, 2024, at which time the voters will elect persons to fill the offices of Mayor, and City Council Place 2;

WHEREAS, the election will be held as a joint election, conducted under the authority of Chapter 271 of the Texas Election Code ("Code"); and

WHEREAS, Section 5.06, "Vacancies" of Article V, "City Council," of the City Charter, as amended, requires the City to hold a special election to fill a vacancy that occurs with more than 12 months remaining in the unexpired term; and

WHEREAS, one vacancy exists on the City Council due to one voluntary resignation of Place 4, whose term expires May, 2026; and

WHEREAS, Section 11(c), Article XI, of the Texas Constitution requires that any vacancies occurring on the City Council shall not be filled by appointment, but must be filled by majority vote of the qualified voters at a special election called for such purpose within 120 days after such vacancy; and

WHEREAS, Section 201.052 of the Texas Election Code ("Code") provides that a special election to fill a vacancy shall be held on the first authorized uniform election date

occurring on or after the 46th day after the election is ordered; and

WHEREAS, the May 4, 2024 uniform election date falls within 120 days of vacancy; and

WHEREAS, in light of the foregoing, the City Council has elected to call a special election to fill the unexpired term of the office of City Council Place 4 for on the May 4, 2024 uniform election date; and

WHEREAS, by this Resolution, it is the intention of the City Council to designate a polling place for the election, to appoint the necessary election officers to establish and set forth procedures for conducting the election, and authorize the Mayor to execute a contract with Tarrant County for conducting the election.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAGINAW, TEXAS, THAT:

Section 1. General Election Called. An election is hereby called to elect the offices of Mayor, and City Council Place 2 to serve from May of 2024 until May of 2027 or until their successors are duly elected and qualified. The election shall be held on May 4, 2024, between the hours of 7:00 a.m. and 7:00 p.m., at the location(s) designated in the Joint Election Agreement.

Section 2. Special Election Called. A special election is hereby called to fil the unexpired term of the office of City Council Place 4, to serve until May of 2026, or until their successor is duly elected and qualified. The election shall be held on May 4, 2024, between the hours of 7:00 a.m. and 7:00 p.m., at the location(s) designated in the Joint Election Agreement.

Section 3. <u>Joint Election Agreement Approved.</u> The Mayor is authorized to execute the Joint Election Agreement for Tarrant County and the City of Saginaw (the "Agreement"). In the event of conflict between this Resolution and the Agreement, the Agreement shall control.

Section 4. Application for Place on Ballot. Qualified persons may file as candidates by filing applications in the office of the City Secretary from 7:30 a.m. to 5:30 p.m., Monday through Thursday, from January 17, 2024 through February 16, 2024; and 7:30 a.m. to 11:30 a.m., on Fridays, January 19 and 26, 2024, and February 2 and 9, 2024; and from 7:30 a.m. to 5:00 p.m. on Friday, February 16, 2024.

Section 5. <u>Early Voting.</u>

- a. Early voting by personal appearance. Early voting by personal appearance shall commence April 22, 2024, and shall continue daily until April 30, 2024, at the location(s) designated in the Agreement for joint election. Hours for early voting by personal appearance shall be from 8:00 a.m. to 5:00 p.m., from April 22, 2024 through April 26, 2024; from 7:00 a.m. to 7:00 p.m. on each of April 27, 2024, April 29, 2024, and April 30, 2024; and from 10:00 a.m. to 4:00 p.m. on April 28, 2024.
- b. Early voting by mail. Clint Ludwig, the Tarrant County Elections Administrator ("Elections Administrator") or his successor is hereby designated as Early Voting Clerk for the general election. Applications for early voting by mail may be delivered to the Elections Administrator or his successor at the following address: P.O. Box 961011, 2700 Premier Street, Fort Worth, Texas 76161, FAX: 817-850-2344, Email: votebymail@tarrantcounty.com, not later than close of business on April 23, 2024. Early voting by mail ballots shall be mailed to the Elections Administrator or his successor at

- P.O. Box 961011, Fort Worth, Texas 76161-0011.
- c. Early voting by Ballot Board. Early voting, both by personal appearance and by mail, shall be canvassed by the Early Voting Ballot Board established by Tarrant County under the terms of the Agreement.
- d. Recommended Branch Early Voting Polling Places. The Council finds that the following locations can most adequately and conveniently serve the voters in this election, and that these early voting locations will facilitate the orderly conduct of the election:
 - Former Eagle Mountain-Saginaw ISD Administration Building
 1200 N. Old Decatur Road, Saginaw, Texas 76179
 - Tarrant County Elections Center
 2700 Premier Street, Fort Worth, Texas, 76111

Section 6. Appointment of Election Judge and Alternate Election Judge.

The Presiding Election Judge and Alternate Presiding Judge shall be appointed by Tarrant County as authorized by Chapter 271 of the Code.

Section 7. <u>Method of Voting.</u> Tarrant County's Hart InterCivic Verity Voting System (Version 2.4) shall be used for absentee voting by mail; early voting by personal appearance; regular voting on election day and provisional voting. All expenditures necessary for the conduct of the election, the purchase of materials therefore, and the employment of all election officials are hereby authorized, and shall be conducted in accordance with the Code.

Section 8. Governing Law and Qualified Voters. The election shall be held in accordance with the Constitution of the State of Texas and the Code, and all resident

qualified voters of the City shall be eligible to vote at the election.

Section 9. Publication and Posting of Notice of Election. Notice of the election shall be given as required by Chapter 4 of the Code.

Section 10. <u>Necessary Actions.</u> The Mayor and the City Secretary of the City, in consultation with the City Attorney, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Code in carrying out and conducting the election, whether or not expressly authorized herein.

Section 11. Effective Date. This resolution shall be effective upon its adoption.
