The challenges

Since the implementation and entry into force of ICAO PANS-AIM back in 2018, together with the requirement of implementation of the digital data sets, as well as with the updates in the latest versions of Annex 15 and Doc 8126, a wide number of States are heavily struggling when it comes to implement and demonstrate the required compliance with the applicable mandatory standards, but also with the associated recommended practices.

About the solution

This consultancy service product has been developed as a tool to enable Aeronautical Information Service Providers to check and measure the actual compliance levels with respect to ICAO documentation related to Aeronautical Information Management. Once the gaps are identified, a roadmap for compliance is depicted to define the mitigation measures and steps for achieving a full SARPs compliance.

OUR MISSION

An initial workshop is conducted aimed to detect those areas where the compliance is not achieved or partially achieved. This initial feedback is then assessed in a later stage.

A very detailed e-Questionnaire is prowided to the State so as to assess the overall status of compliance.

Once the answers are provided, a comprehensive Gap Analysis is fulfilled, showcasing those topics where the compliance level is below the necessary threshold. Additionally, a Roadmap for Compliance can also be considered to advice on how to guarantee the required levels.

METHODOLOGY

What to assess.

A data-driven and results-driven approach is applied by ass those mandatory/standard requirements defined in both ICAO 15 and ICAO Doc 10066 (PANS-AIM). For that purpose, a tota requirements are considered for Annex 15, and a set of 130 re ments are assessed for PANS-AIM. An e-Questionnaire classi topic and subtopic is provided, containing diverse questions for of the groups describing these topics.



Once all the topics and subtopics previously grouped by Chapters have been assigned a compliance level according to the answer provided together with the evidences delivered, a global compliance level can be obtained, as well as broken down by both Chapter and topics.
