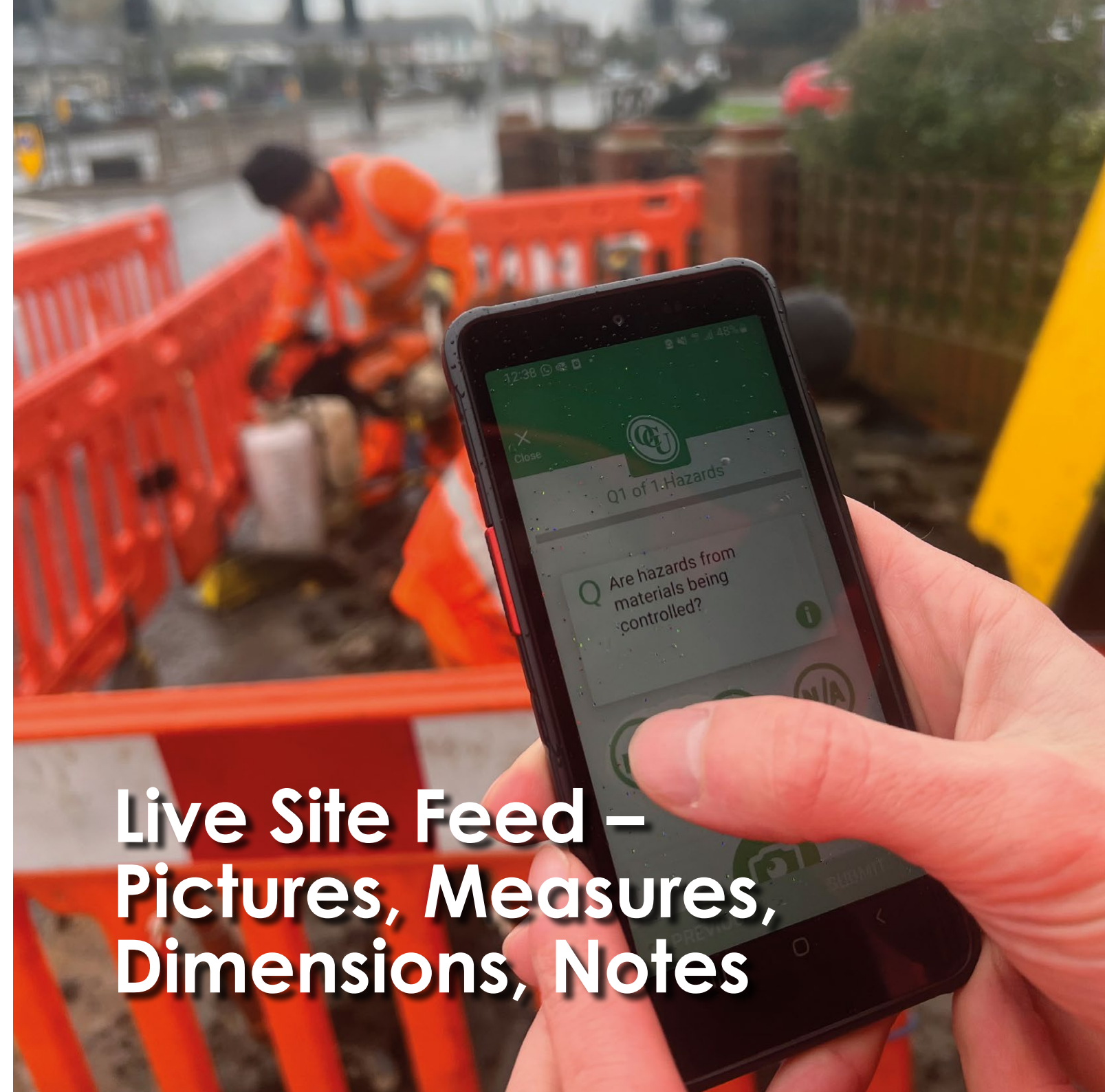

Targets/ Regimes

Defects

Full interface to administer outstanding defects; these will be defects that have failed on site and not been rectified at the time of failure

- Dashboard view on all defects, age and status.
- Drill-down view to interrogate types of defect.
- Defect data fully exportable
- Function to review defect, rectify and change status/ marked as closed
- Add photos to rectified defects
- Ability to schedule Defects/ Actions to certain users to rectify

Dashboard/ Reporting

Inspections Dashboard enabling high-level view of HSEQ data.

Full suite of reports, all of which are exportable, to include the following:

- Inspections Scheduled/ Completed
- Open/ Closed Defects

Risk Assessment

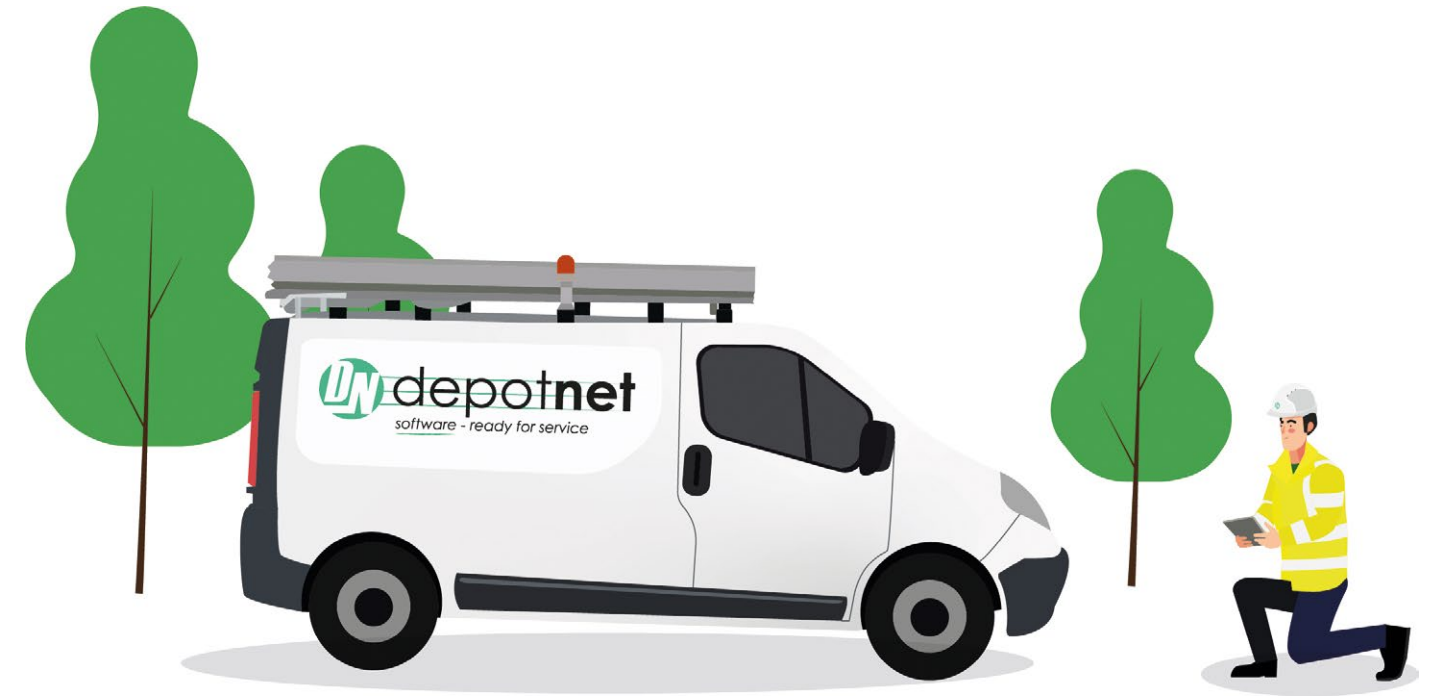

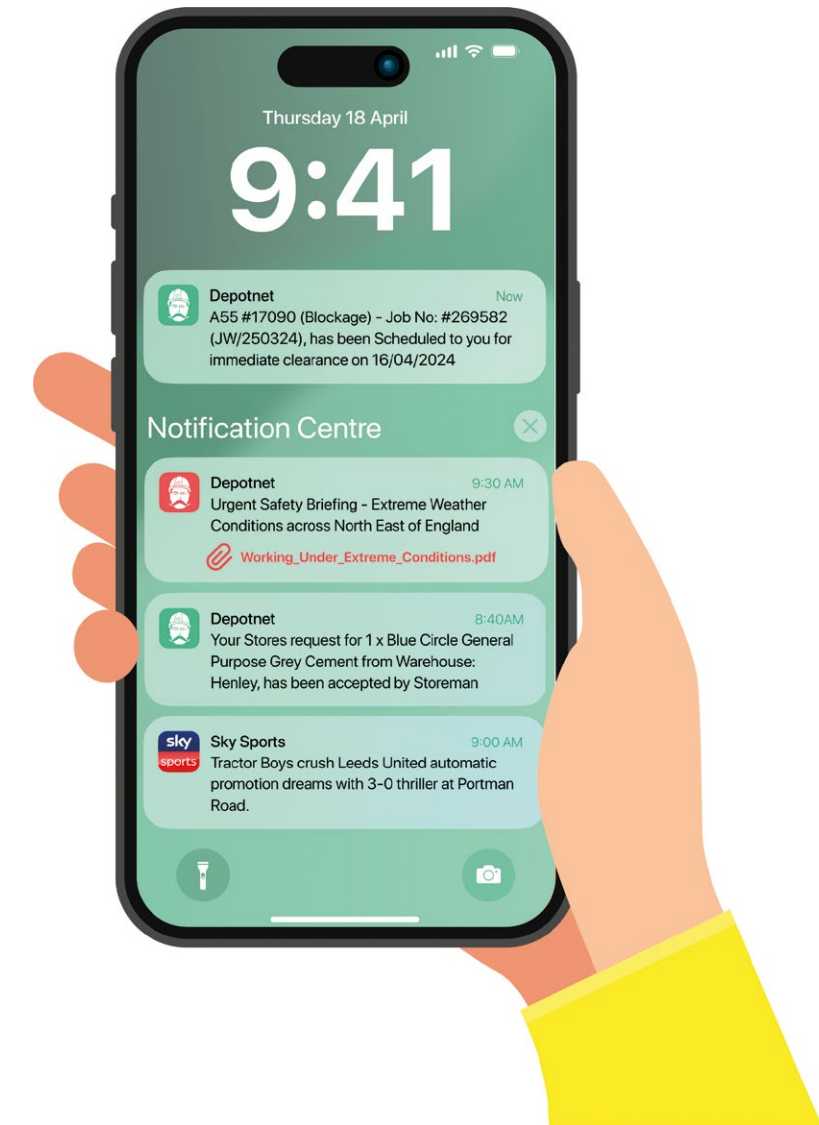
