PRIVACY POLICY

Your privacy is important to us so we have developed this Privacy Policy in order to show you that you do not need to worry about your personal data when using GETITDONE.

GETITDONE enables you to create, delete and mark as 'done' different actions and use it as a To-do wallpaper on your device's screen. In order to do this the application only needs access to your device's Gallery, where it shall create a separate folder named GETITDONE and store the picture of your To-do list.

Based on your consent, the outdated pictures of To-do lists shall be removed from the folder in order to not consume excessive amount of storage on your device's memory.

What is personal data?

Personal data means any information relating to a natural person such as a name, an identification number, location data, IP address or physical, physiological, genetic, mental, economic, cultural or social information about that natural person.

What is personal data processing?

Processing means any operation which is performed on personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction.

Do we process your personal data?

GETITDONE does not process your personal data. We do not have your personal data, as you do not have to register an account and sign in, we also do not collect your IP address or location information, the information is stored only on your device without online traffic.

We may receive your personal data if you directly and voluntarily give it to us when contacting us by e-mail, phone or other means. This information may include your name, e-mail address, phone number and it may be processed by us for the purposes of responding to you and keeping record of those communications.

Do we transmit your personal data to third parties?

GETITDONE application does not collect your personal data and does not have connection or use any third party service providers.

When you are installing the GETITDONE application, the Apple store may collect some of your personal data, regarding this please see their privacy policy.

If you need to communicate with us by e-mail, then Google as our mail service provider may have access to your personal data given in the e-mails, regarding this please see their privacy policy.

How long do we store your data (if we have any)?

GETITDONE application does not collect and therefore also store your personal data.

If you have directly and voluntarily provided to us your personal data, we will keep it for no longer than necessary, we will keep your data only as long as to respond and complete your enquiry. In order to ensure the legal interests of GETITDONE in the event of disputes, we may store such data within the limitation period for claims provided in law or until the term for storing the data provided by law.

When the term for storage of the personal data has expired, the data are destroyed using the best practices.

You have the right

- to contact GETITDONE by e-mail with questions, requests and complaints relating to the personal data processing and this policy;
- to request information which personal data has been collected about you and ask for correction or deletion;
- to file a complaint to GETITDONE, the Estonian Data Protection Inspectorate or a court if you find that your rights are violated in the personal data processing.
