

PRIVACY POLICY

Welcome to Golden Bills!

Golden Bills is owned and operated by Golden Bills LLC.

Golden Bills values your privacy and the protection of your personal data. This privacy policy describes what information we collect from you, how we collect it, how we use it, how we obtain your consent, how long we retain it in our databases and, if necessary, with whom we share it.

By registering as a user and using the platform, you are accepting the practices described in this privacy policy. Your use of the platform is also subject to our terms and conditions. In this privacy policy, the word "platform" refers to the Golden Bills App and website together, "we", "us", "our" and "Golden Bills" refer to Golden Bills and "you" and "user" refer to you, the Golden Bills user.

This privacy policy may change from time to time. Your continued use of the platform after we make changes is deemed acceptance of those changes, so please check the policy periodically for updates. This privacy policy has been prepared and is maintained in accordance with all applicable national and international laws and regulations and, specifically, with the California Consumer Privacy Act (CCPA) and the General Data Protection Regulation (GDPR - European Regulations).

1. GENERAL INFORMATION

2. TYPES OF INFORMATION GATHERED

The information we collect from our users helps us to deliver our services effectively and to personalize and continually improve the user's experience on the platform. These are the types of information we collect:

Information You Give Us. You provide information when you provide, search, read and view content through the platform, register as a user (partners and users), post

products, services and content on the platform, provide a receipt, withdraw rewards and/or communicate with us through our contact information or contact forms. As a result of those actions, you might supply us with the following information:

- First and last name
- Email address
- Phone number
- Address
- User content
- Payment Information
- Any additional information relating to you that you provide to us directly or indirectly through our platform or online presence such as 'cookies'.

Golden Bills will not collect any personally identifiable information about you, unless you provide it.

Information Collected Automatically: By accessing and using the platform you automatically provide us with the following information:

- The device and usage information you use to access the platform
- Your IP address
- Browser and device characteristics
- Operating system
- Referring URLs

If you access the platform through a mobile phone, we will collect the following information:

- Mobile device ID
- Model and manufacturer
- Operating system
- Version information
- IP address

Location: We store real-time information about the location of users registered on the platform when they use some of the functionalities available on the platform, by accessing the GPS function built into the mobile devices of each user. This information is stored to facilitate the correct use of the platform and to provide specific services based on the user's location. However, this information does not identify or individualize the person, it is completely anonymous. The user can request the removal of such information but certain functionalities of the platform would not be available.

Location information collected through the platform will be treated in accordance with this privacy policy.

GOOGLE Analytics. We use Google Analytics provided by Google, Inc., USA (“Google”). These tool and technologies collect and analyze certain types of information, including IP addresses, device and software identifiers, referring and exit URLs, feature use metrics and statistics, usage and purchase history, media access control address (MAC Address), mobile unique device identifiers, and other similar information via the use of cookies. The information generated by Google Analytics (including your IP address) may be transmitted to and stored by Google on servers in the United States. We use the GOOGLE Analytics collection of data to enhance the platform and improve our service.

Facebook Pixel: Our platform uses the Facebook Pixel. Through the Facebook Pixel we can collect user information for different purposes. We use the Facebook Pixel for the following purposes:

- Collect statistics about our platform (for example, the number of users who visited a page).
- Collect information about how you interact with our platform (for example, whether you opened or followed links contained in them).
- Personalize online services and marketing communications.
- Tailor advertisements to users and optimize advertising campaigns.

The information collected through the Facebook Pixel will be collected and stored by Facebook and will be treated in accordance with its privacy policy. The information we collect through the Facebook Pixel does not personally identify the user and will never be used for purposes other than those contained in this privacy policy and Facebook's privacy policy.

3. HOW LONG WE KEEP YOUR DATA

Personal data provided by users through the platform will be retained for as long as necessary to provide the platform and the functionalities available on the platform or until the user retains the user account on the platform or decides to close it or until Golden Bills closes and deletes the user account. Golden Bills may retain personal data for a longer period where the user has given consent to such processing, provided that such consent is not withdrawn. In addition, Golden Bills may be obliged to retain personal data for a longer period if this is necessary for compliance with a legal obligation or by order of an authority. Once the retention period expires, the personal data will be deleted. Therefore, the right of access, the right of erasure, the right of rectification and the right to data portability cannot be asserted once the retention period has expired.

4. HOW WE USE YOUR INFORMATION.

In general, we use the information we collect primarily to provide, maintain, protect and improve our platform and services. We use personal information collected through our platform as described below:

- Provide the platform (Available on Google Play and App store).
- Identify you as a user in our system.
- User registration (partners and users).
- Publish products, services and partner's content.
- Verify receipts and credit rewards.
- Process transactions within the platform.
- Facilitate communications between users.
- Improve our services, platform, and how we operate our business.
- Understand and enhance your experience using our platform and services.
- Respond to your comments or questions through our support team.
- Send you related information, including confirmations, invoices, technical notices, updates, security alerts and support and administrative messages.
- Communicate with you about upcoming events, offers and news about products and services offered by Golden Bills and our selected partners.
- Marketing purposes of Golden Bills.

- Link or combine your information with other information we get from third parties to help understand your needs and provide you with better service.
- Protect, investigate and deter against fraudulent, unauthorized or illegal activity.

5. HOW DO YOU GET MY CONSENT?

By registering as a user (partners or users), posting products, services and content on the platform, providing a receipt through the platform, requesting a withdrawal of rewards, communicating with us through our contact forms or our contact information, and providing us with personal information to communicate with you, you consent to our use of cookies, you consent to our collection, storage and use of your information on the terms contained in this privacy policy. You may withdraw your consent by sending us your request via the contact information or contact page.

6. HOW WE SHARE INFORMATION

The personal information of our users is an important and fundamental part of our business. Under no circumstances will we sell or share information with third parties that has not been previously authorized by the user or owner of the personal data. We share user information solely and exclusively as described below.

Third-Party Service Providers. We use third-party services to perform certain functions on our behalf and through our platform and services. Examples include payment and withdrawal processing, email delivery, data analysis (Google Analytics), ad creation (Facebook, Google), marketing assistance, and search results delivery.

These third-party services and tools may have access to personal information needed to perform their functions, but may not use that information for other purposes. Information shared with these third-party services will be treated and stored in accordance with their respective privacy policies and our privacy policy.

Email marketing: We use the information provided by users to conduct marketing campaigns and send relevant information to our users. By registering as a user on the platform, you authorize us to use your information for email marketing. We will use third party services to perform email marketing, so we may share certain information with some of these third parties for the sole and exclusive purpose of sending emails through email marketing and in accordance with our privacy policy.

Business Transfers. In the event that Golden Bills creates, merges with, or is acquired by another entity, your information will most likely be transferred. Golden Bills will email you or place a prominent notice on our platform before your information becomes subject to another privacy policy.

Protection of Golden Bills and others. We release personal information when we believe release is appropriate to comply with the law, enforce or apply our Terms and

conditions and other agreements, or protect the rights, property, or safety of Golden Bills, our users or others. This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction.

With Your Consent. Other than as set out above, you will receive notice when personally identifiable information about you might go to third parties, and you will have an opportunity to choose not to share the information.

Anonymous Information. Golden Bills uses the anonymous browsing information collected automatically by our servers primarily to help us administer and improve the platform. We may also use aggregated anonymous information to provide information about the platform to potential business partners and other unaffiliated entities. This information is not personally identifiable.

Email Address. The email address that you supply to us for purposes of receiving our email communications will never be rented or sold to a third party.

7. PROTECTING YOUR INFORMATION

We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you provide or share through the platform. If transactions are processed on the platform, transaction information is transmitted to and from the platform in encrypted form using industry-standard SSL connections to help protect such information from interception. We restrict authorized access to your personal information to those persons who have a legitimate need to know such information to provide certain functions and to those persons you have authorized to have access to such information. Golden Bills follows generally accepted industry standards for data security to protect the personal information you provide and share through the platform, both during transmission and once Golden Bills receives it. No method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, while Golden Bills strives to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security. We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so.

8. RIGHTS

Users who provide information through our platform, as data subjects and data owners, have the right to access, rectify, download or delete their information, as well as to restrict and object to certain processing of their information. While some of these rights apply generally, others apply only in certain limited circumstances. We describe these rights below:

- **Access and portability:** to access and know what information is stored in our servers, you can send us your request through our contact information.

- **Rectify, Restrict, Limit and/or Delete:** You can also rectify, restrict, limit or delete much of your information.
- **Right to be informed:** Users of our platform will be informed, upon request, about what data we collect, how it is used, how long it is retained and whether it is shared with third parties.
- **Object:** When we process your information based on our legitimate interests as explained above, or in the public interest, you may object to this processing in certain circumstances. In such cases, we will stop processing your information unless we have compelling legitimate reasons to continue processing it or where it is necessary for legal reasons.
- **Revoke consent:** Where you have previously given your consent, such as to allow us to process and store your personal information, you have the right to revoke your consent to the processing and storage of your information at any time. For example, you may withdraw your consent by updating your settings. In certain cases, we may continue to process your information after you have withdrawn your consent if we have a legal basis for doing so or if your withdrawal of consent was limited to certain processing activities.
- **Complaint:** If you wish to file a complaint about our use of your information (and without prejudice to any other rights you may have), you have the right to do so with your local supervisory authority. Users can exercise all these rights by contacting us through the contact information or the contact page.
- **Rights related to automated decision-making, including profiling:** platform users may request that we provide a copy of the automated processing activities we conduct if they believe that data is being unlawfully processed.

Users or owners of the personal information they provide through the platform may exercise these rights over their personal information at any time and without any limitation by sending us their request through our contact information.

9. CHILDREN'S ONLINE PRIVACY PROTECTION

We comply with the requirements of the California Consumer Privacy Act (CCPA) and the General Data Protection Regulation (GDPR - European Regulations), regarding the protection of personal data of minors. We do not collect information from children under the age of 13. In the event that a child under the age of 13 provides us with personal information, we will take immediate steps to delete such information.

10. THIRD PARTIES

Except as otherwise expressly included in this Privacy Policy, this document addresses only the use and disclosure of information Golden Bills collects from you. If you disclose your information to others, whether other Golden Bills users or vendors, different rules may apply to their use or disclosure of the information you disclose to them. Golden Bills does not control the privacy policies of third parties, and you are subject to the privacy policies of those third parties where applicable. Golden Bills is not responsible for the privacy or security practices of other platforms, including those that are linked to from Golden Bills.
