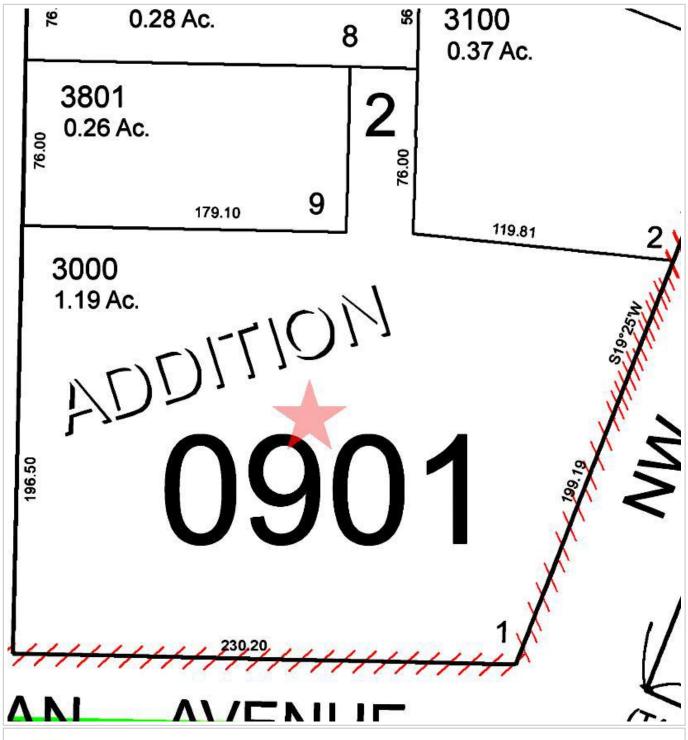

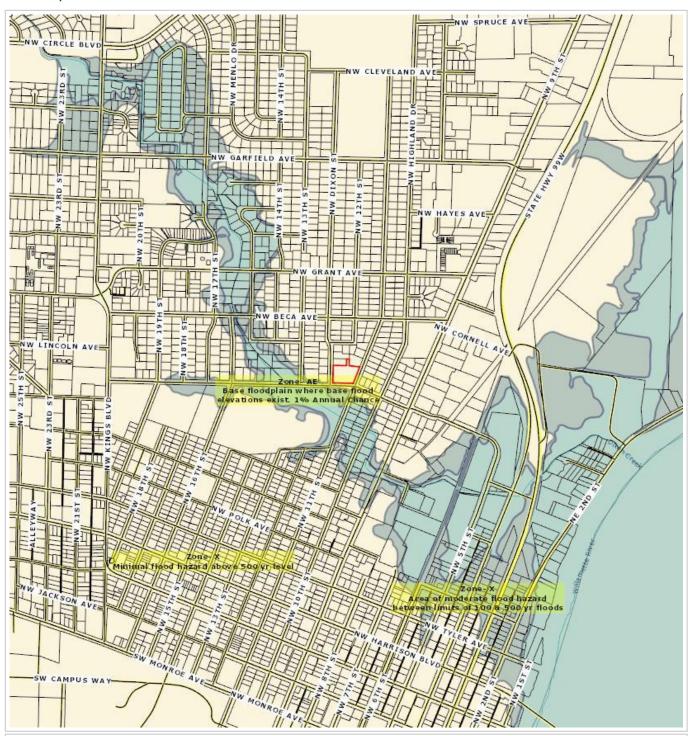

Zoning Map

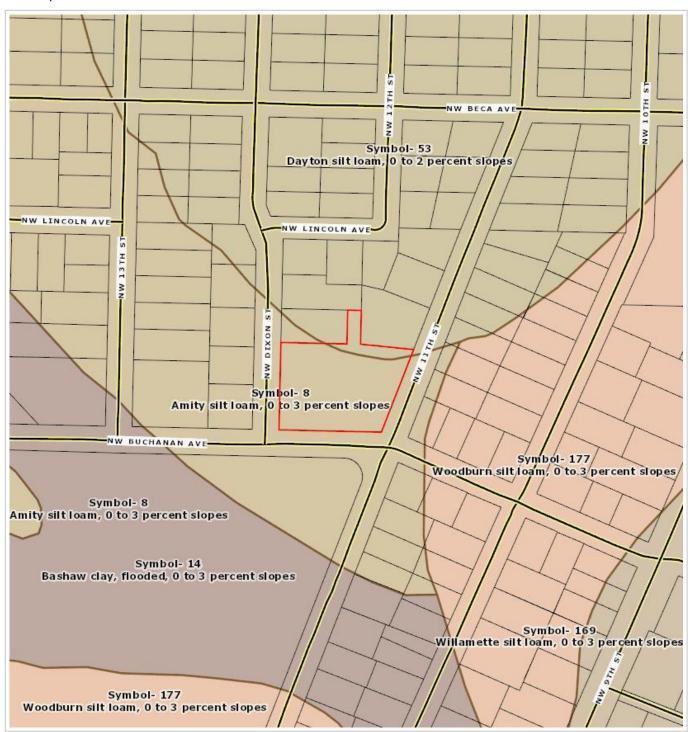
