# **Terms and Conditions: JEEP GLADIATOR 2025 PROMOTION**

## 1. INTRODUCTION

- 1.1 This Hennie's "JEEP GLADIATOR" 2025 Promotion ("Competition"), brought to you by Stellantis (Pty) LTD ("Stellantis") and Hennie's Sports Bar (Pty) LTD (Hennies), is offered subject to the terms and conditions as set out below and any terms and conditions as may be stipulated by Stellantis Pty Ltd on their official website / otherwise stipulated in Social Media / other advertisements.
- 1.2 This competition is valid in SA only.
- 1.3 Any reference to a Jeep Gladiator or the Hennies-branded Jeep can include any other model available at that time.
- 1.4 Participation by the entrants in the Competition constitutes an agreement to abide by all the terms and conditions set out below / otherwise advertised. Hennie's and Stellantis ("Promoters") reserve the right to disqualify any entrant who breaches any provision(s) of the terms and conditions set out below.
- 1.5 Where it is referred to as the "Winner" as it relates to prize 1 and 2 outlined below.

# 2. COMPETITION DATES

2.1 The Competition run as stipulated in relevant marketing material and is subject to change ("the Competition Period"). Entries received outside of the Competition Period will not be eligible.

#### 3. WHO CAN ENTER

Entry is only available to Winners who meet the following criteria:

Amongst others all individuals must:

- 3.1 Be a resident of South Africa with a valid ID.
- 3.2 Be aged minimum 20 years and older upon entry (see point 3.3 below).
- 3.3 Hold in their possession a valid, current and unendorsed South African driver's license and have held such license for at least two years (temporary or still in print licenses will not be considered or accepted. In addition, no unendorsed driver's license or license's that has been revoked, suspended or restricted in any way in the last 12 (twelve) months before commencement date of the competition will be accepted).
- 3.4 Be able to take enough days of leave from work to be able to attend the trip as advertised for prize 1 and2. (Unforeseen circumstances could possibly lead to more days required).

- 4.2 This entry card will firstly, provide entrants with an opportunity to stand a chance to win an in-house instant redemption prize (listed below, subject to change) as well as one of three other main prizes (see details on main prizes below, subject to change).
- 4.3 To qualify for any of the three main prizes, entrants need to go further and complete their entry cards fully and correctly (regardless if he/she won an instant redemption prize or not). Hennie's will not take responsibility for incorrect completion of cards with illegible/false/incorrect details/information.

#### **5. COMPETITION TIMELINES**

#### 9. PRIZE DETAILS AND CONDITIONS -

#### **BETWEEN THE WINNER AND STELLANTIS:**

#### 9.1 ACCESS AND GENERAL USE OF VEHICLE

- 9.1.1 The winner will have access to a Jeep Gladiator\* ("the vehicle") for the either a weekend or a month, depending on the type of prize won;
- 9.1.2. The Jeep is only allowed to be driven by the authorised winner(s), who holds a valid, current and unendorsed driver's License and has held such License for at least 2 (two) years. The License must also not have been revoked, suspended or restricted in any way in the 12 (twelve) months before the Commencement Date of this competition;

In the event of Stellantis receiving notice of any road traffic or parking violations incurred during the Loan Period, as the case may be, Stellantis undertakes to provide the winner(s) with a copy of such notice and the winner(s) authorises Stellantis to provide the necessary information to the relevant authority for purposes of directing such notice directly to the winner(s), or Stellantis shall be entitled to settle the fine and reclaim it from the winner(s);

- 9.1.4 The vehicle must be returned in the same condition as it was provided. Any damages, theft, or loss of the vehicle during the prize period will be the sole responsibility of the winner(s);
- 9.1.5 Stellantis South Africa (Pty) Ltd shall provide comprehensive vehicle insurance coverage throughout the sponsorship period. In the event of theft or damage to the vehicle, the winner shall be liable for payment of the insurance excess.

#### 9.2 PROHIBITIONS

The winner(s) will under no circumstance:

- 9.2.1 Hire or lend the vehicle to any other person;
- 9.2.2 Permit the vehicle to be in the possession or control of anyone other than the winner(s);
- 9.2.3 Drive unlawfully or illegally or allow for the vehicle to be used for any unlawful purposes or in such a way as to increase the risk of it being damaged or lost or to be overloaded but ensure vehicle is used at all times in line with the manufacturer's specifications;
- 9.2.4 Carry any passengers or goods for reward or otherwise;
- 9.2.5 Be used in any motor sport or similar high risk activity;
- 9.2.6 Be exposed to the risk of damage in or by any civil or public disturbance or unrest or;
- 9.2.7 Be used for any political purpose whatsoever.

## 9.3 COMPLIANCE

The winner agrees to comply with the following requirements at all times whilst operating the Jeep vehicle:

- 9.3.1 Carry his or her valid driver's license with them;
- 9.3.2 Take all reasonable precautions to protect the vehicle from damage, theft or loss and

shall properly lock, secure and immobilise the vehicle at all times when the vehicle is not in use or occupied;

- 9.3.3 Ensure that the vehicle is parked at night undercover or in a locked garage;
- 9.3.4 Ensure that every reasonable precaution to safeguard the interest of Stellantis is taken if at any time the vehicle is damaged, stolen or lost, including but not limited to, the following where appropriate:
- 9.3.5 Notifying the police and the Stellantis within 24 (twenty-four) hours of the occurrence in question and furnishing Stellantis with an accident case number.
- 9.3.6 Notify Stellantis immediately, but in any event, by no later than 24 hours of the damage to, or theft or loss of, the vehicle using the contact details specified in the Notice clause.
- 9.3.7 Complete all documents, including claim forms, required by Stellantis's insurers and furnish all assistance required by Stellantis's insurer to deal with any matters arising from the damage to, or theft or loss of, the vehicle. Failure or refusal to sign the claim forms required by Stellantis's insurers does not absolve the winner(s) of his/her responsibility for the damage to, or theft or loss of, the Vehicle and such failure shall constitute a breach of this Agreement.
- 9.3.8 Comply fully with all applicable laws and regulations, including without limitation the anti-bribery laws and regulations in all relevant jurisdictions, in carrying out the obligations and described in this Agreement.
- 9.3.9 Use all reasonable endeavours not to do or omit to do, anything which may in Stellantis

And / or Hennie's view: (i) bring Stellantis and / or Hennie's into disrepute; (ii) disparage Stellantis and / or Hennie's; (iii) damage the goodwill of Stellantis and / or Hennie's; or (iv) be prejudicial to the image and/or reputation of Stellantis and or Hennie's

### 9.4 INDEMNIFICATION

- 9.4.1 The winner(s) hereby indemnifies Jeep and Stellantis and Hennies from any loss, liability, cost, damages, injury or death arising directly or indirectly from the use of the Sponsored Vehicle during the Loan Period and during any period in which the winner(s) have possession of the Sponsored Vehicle, regardless of whether such loss, liability, cost, damage, injury or death is suffered by winner(s) any passengers or third parties.
- 9.4.2 The Winner(s) herby waives any claim he/she may have related directly or indirectly to his or the authorised drivers use of the Sponsored Vehicle.
- 9.4.3 Providing the winner(s) with a replacement Vehicle after the Vehicle has been damaged, or stolen, is entirely at Stellantis's discretion and Stellantis reserves all rights in this regard,

## 9.5 RETURN OF VEHICLE

- 9.5.1 On the Termination Date, The winner(s) shall return the Sponsored Vehicle, together with the keys, spare wheel, tools and accessories to Stellantis.
- 9.5.2 Should the winner(s) fail to return the Sponsored Vehicle to Stellantis, the winner(s) will

  Be considered to be in unlawful possession of the Sponsored Vehicle and Stellantis shall

  be entitled to repossess the Sponsored Vehicle wherever it may be found and from

whomsoever is in possession thereof. Any costs incurred by Stellantis as a result of recovering the Sponsored Vehicle from winner(s), will be for the account of the winner(s). The Sponsored Vehicle may also be reported as stolen to the relevant authorities.

#### 9.6 RECOVERY OF VEHICLE

- 9.6.1 The winner(s) agrees to Stellantis removing the Vehicle from the winner(s) possession in circumstances where the:
  - Winner(s) is in breach of any term of this Agreement;
  - Vehicle is used to violate the law;
  - Vehicle is found to be illegally parked or appears to have been abandoned; and /or
  - Winner(s) has made any misrepresentation to the Lender in connection with the conclusion of this Agreement.

## 10. OTHER TERMS AND CONDITIONS

- 10.1 None of the above mentioned prizes are transferable, exchangeable or replaceable for cash or other forms of credit and no refunds will be issued for the value of the Prizes even if travel plans are cancelled or altered. The prizes can only be used as specified and can therefore also not be reinstated. - 10.2 The prizes will under no circumstances be handed over to a third party and will only be handed directly to the verified prize winner(s).

- 10.3 Please note: NO additional time will be afforded for the printing of a driver's license or ID or for obtaining a temporary (emergency) drivers license or to reapply for a new driver's license or ID.
- 10.4 All bookings are subject to availability at the time of booking and at the lodge's discretion depending on level of occupancy. All applicable booking terms and conditions of the Accommodation Supplier(s) and/or Stellantis apply.
- 10.5 Changes or Cancellation may incur charges from Airlines, Accommodation Suppliers and/or other General Suppliers. The Winner(s) is responsible to pay any such charges including any additional costs resulting from changes or cancellations to the original booking as requested by the Winner.

You acknowledge, agree and consent thereto that Hennie's may make media announcements, publish, reproduce or broadcast the Media for promotional purposes following your participation in the competition and without remuneration being made payable to you. You acknowledge and understand that you will have no proprietary rights in the Media.
