1. Program Overview and Payment Terms

By enrolling in the LAND Pro Program, the Client agrees to one of the following payment options (please check one):

3. Curriculum Modifications

Ascension Coaching reserves the right to modify the LAND curriculum and resources to ensure the program meets the evolving needs of its participants while maintaining the core value of the experience.

4. Right to Remove Participants

Ascension Coaching retains the right to remove any participant from the program at its sole discretion and at any time, without refund of any previously collected payments.

5. Commitment to Quality

Ascension Coaching is committed to delivering a high-quality coaching experience. While job placement is not guaranteed, the Coach will provide strategic guidance, tools, and support. Clients are encouraged to proactively communicate any concerns during the engagement.

6. Cancellation and Refund Policy

The Client may cancel their enrollment within 48 hours of purchase for a full refund, provided the program has not started. After this window or after the program begins, no refunds will be issued.

7. No Refunds After Program Start

Once the program has officially started, all payments made are final and non-refundable.

8. Referral Incentive

The Client is eligible to receive 20% off future coaching services for each new client they refer to the LAND program who enrolls. There is no limit to the number of referrals the Client may make.

9. Disclosure and Results Disclaimer
