PRIVACY

POLICY INVEST-TRACKER

This confidentiality agreement has been developed in accordance with the requirements of the Law of Ukraine "On the Protection of Personal Data" and other regulatory acts of Ukrainian legislation governing legal relations related to the collection, processing, storage of personal data, as well as the right of citizens to privacy and the right to self-expression.

INVEST-TRACKER, taking care of the development of relationships with customers, understanding the importance of ensuring the protection of your personal data, in order to resolve possible contradictions and misunderstandings, has prepared this Privacy Agreement (privacy policy), hereinafter referred to as the "Privacy Policy", and the terms of use of **INVEST-TRACKER**, hereinafter referred to as the "site". Please read this page carefully as the information contained on it is important for you as a user of the site.

1. DEFINITION OF TERMS

- 1.1 The following terms are used in this Privacy Policy:
- 1.1.1. "Administration of the site of the online store (hereinafter referred to as the Site Administration)" authorized employees to manage the site, acting on behalf of **INVEST-TRACKER**, who organize the processing of personal data, and also determines the purposes of processing personal data, the composition of personal data to be processed, actions or operations performed with personal data.
- 1.1.2. "Personal data" any information relating directly or indirectly to a specific or identifiable natural person (subject of personal data).

1.1.3. "Processing of personal data" - any action (operation) or a set of actions (operations) performed with or without the use of automation tools with personal data, including collection, recording, systematization, accumulation, storage, clarification (updating, changing), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.						
1.1.4. "Confidentiality of personal data" - a mandatory requirement for the Administrator or other person who has access to personal data to prevent their distribution without the consent of the subject of personal data or other legal grounds.						
1.1.5. "User of the INVEST-TRACKER is a person who has access to the Site via the Internet and uses the Site.						
1.1.6. A "cookie" is a small piece of data sent by a web server and stored on the user's computer, which the web client or web browser sends to the web server in an HTTP request each time it tries to open a page of the corresponding site.						
2. SUBJECT OF THE PRIVACY POLICY						
2.1. By using the site or purchasing a product offered on the site, as well as answering the necessary questions in the questionnaire when registering and / or making a purchase, the user confirms that he gives his consent to INVEST-TRACKER and persons authorized by him to process personal data, and that he is of legal age face.						
2.2. The user gives his consent to the Site Administration to process the information received, including the collection, systematization, accumulation, storage, clarification (updating, correction), use, distribution, depersonalization, blocking, destruction of personal data specified in the questionnaire, for the purpose of activities aimed at forming database of participants, compiling						

statistical reports, conducting market research, as well as interacting with the user, including via telecommunication networks, including sending SMS messages and emails, until such consent is withdrawn.
2.3. The User confirms his agreement that the Site Administration has the right to interact with the User by making direct contacts using various means of communication, including, but not limited to: mailing list, e-mail, the Internet, etc.
2.4. Personal data permitted to be processed under this Privacy Policy includes, but is not limited to, the following information:
2.4.1. Full name of the User;
2.4.2. email address (e-mail);
3. PURPOSE OF COLLECTION AND PROCESSING OF PERSONAL DATA
3.1.User's personal information INVEST-TRACKER for the following purposes:
3.1.1. identification of the User registered on the site.
3.1.2. providing the User with effective customer support;

3.1.3. providing the User with personalized Services;
3.1.4. communication with the User, including sending notifications, requests and information regarding the use of the Services, the provision of services, as well as the processing of requests and applications from the User;
3.1.5. improving the quality of the Services, the convenience of their use, the development of new Services and services;
4. CATEGORIES OF DATA
COLLECTED 4.1. The categories of Personal Data collected by the site (independently or through third parties) include: Cookies and Data on the use of network resources.
4.2. Personal data may be provided by the User independently or their collection may be automatically carried out by the site when using it
4.3. Users are responsible for the Personal Data of third parties that they receive, publish or provide to others using the site, and confirm that they have the consent of the third party to provide the Data to the Owner.
5. METHODS AND TERMS OF PERSONAL DATA PROCESSING

5.1. The processing of the User's personal data is carried out without time limit, in any legal way, including in personal data information systems using automation tools or without using such tools.							
6. USER RIGHTS							
6.1. Users have the right:							
6.1.1. find out if their Personal Data has been stored;							
6.1.2. contact the Site Administration to find out their content and origin;							
6.1.3. check their accuracy or ask them to supplement;							
6.1.4. delete, update or correct your Personal Data;							
6.1.5. turn into a format that provides anonymity;							
6.1.6. block any data stored in violation of the law;							
6.1.7 to oppose their processing for any and all legal grounds.							

6.2. Relevant requests should be sent to the site administration at the address indicated in the contact information on the site.						
7. COOKIE POLICY						
7.1. The site collects information about your visits to our websites in order to obtain statistics on visits and the effectiveness of their use, to form a personal approach and adapt to the interests of each user. We do this through various technologies, one of which is cookies. This is data that a website can send to your browser and will be stored on your computer so that it can be identified by the website.						

7.2. Cookies are used to measure the effectiveness of websites (for example, to measure the number of visitors and how long they stay on the site), to identify topics and pages that are most interesting and visited, and to ensure the convenience of navigating and using the site, without collecting any personal information. information. Also, cookies can be used to form a personal approach based on the user's existing experience of interacting with the site and his preferences. Over time, this information improves the user experience.

8. SECURITY OF PERSONAL DATA

- 8.1. **INVEST-TRACKER** takes the necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties.
- 8.2. This Privacy Policy applies only to the **INVEST-TRACKER** and application. If, using the links posted on the website of the latter, the User enters the resources of third parties, **INVEST-TRACKER** is not responsible for his actions.

8.3. The User's personal data may be used for legal purposes in court or in stages leading to possible legal action due to the site or services being misused.
The user is aware that the Site Administration may be forced to provide personal data at the request of public authorities.
9. ADDITIONAL INFORMATION ABOUT USER'S PERSONAL DATA
9.1. In addition to the information contained in this privacy policy, the site may provide the User, upon request, with additional and contextual information regarding specific services and services or the collection and processing of Personal Data.
10. ADDITIONAL TERMS
10.1. The site administration has the right to make changes to this Privacy Policy without the consent of the User.
10.2. The new Privacy Policy comes into force from the moment it is posted on the Website of the online store, unless otherwise provided by the new edition of the Privacy Policy.
10.3. In case of disagreement with any changes made to the Rules, the User must stop using the site and may require the Administration of the data site to delete his Personal Data.
