- ①事業主が給与から被保険者負担分を控除する場合、被保険者負担分の端数が50銭以下の場合には切捨てし、51銭以上の場合は切上げて1円となります。
 - ②被保険者が被保険者負担分を事業主へ現金で支払う場合、被保険者負担分の端数が50銭未満の場合には切捨てし、50銭以上の場合は、切上げて1円となります。

注) ①、②に関わらず、事業主と被保険者間で特約がある場合は、特約に基づき端数処理をすることができます。
