### 1. Account Registration

### C. Billing & Renewal

Subscriptions auto-renew at the end of each billing cycle. By subscribing, you authorize Labocine to charge your selected payment method at the applicable recurring rate.

#### D. Cancellation

You may cancel anytime via your account settings. Your plan will remain active until the end of the current billing cycle.

#### E. No Refunds

All payments are non-refundable. No credits will be issued for unused time or late cancellations.

### 3. Content Usage

Labocine provides a curated catalog of science-inspired films and series. Content may change over time as new works are added or rotated.

By using the platform, you agree to:

- Stream content only through the Labocine platform
- Not download, reproduce, redistribute, or exhibit works without explicit permission

**Your Lab** is your creative and curatorial space on Labocine. As a user, you can:

- Contribute films, scenes, or stills (provided you have all necessary rights and permissions)
- Add and publish **Field Notes**, essays, or annotations tied to your contributions
- Manage how your work is shared or featured on the platform, including toggling visibility and inclusion in Labocine PRO

Labocine will never feature or promote any submitted work without your prior approval.

### 5. Account Security

You are responsible for securing your password and payment information. Do not share your login or allow unauthorized use. Suspicious activity may result in your account being paused or reviewed.
