Privacy Policy

Mamino Histoires is an application that uses AI to generate stories by choosing a character, a place, and an adventure. Mamino Histoires is a service provided by Peakty (SASU).

We have written this policy to explain how Mamino Histoires ("we," "us," or "Mamino Histoires") uses the data you provide us through our site(s), including but not limited to Mamino Histoires.

What personal data does Mamino Histoires collect via the Website?

Mamino Histoires collects different information depending on how you use the Website and how you interact with us. 'Personal data' means any data that can be associated with you as an individual, either directly or indirectly.

The personal data we collect via the Website is likely to include (and depends solely on the questions asked by each platform's administrators):

- Identity information, such as your name, company name, organization type, and job title.
- Contact data, such as your address, email address, telephone number.
- Technical data, such as your Internet Protocol (IP) address, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access the Website.
- Usage data, which includes information about how you use the Website and our services, and any communications we may receive from you.

Usage of said data

By providing personal information, you are deemed to consent to your personal information being shared outside Mamino Histoires in the following circumstances:

- where Mamino Histoires needs to share your information to provide the service you have requested.
- where Mamino Histoires needs to send the information to third parties who work on behalf of Mamino Histoires to provide a service to you. We will only provide the information they need to deliver the service, and they are prohibited from using that information for any other purpose.
- where Mamino Histoires wants to keep you up to date on the latest service announcements, updates, or other Mamino Histoires information.
- where you have given us permission to share your information with third parties.
- Mamino Histoires will also disclose your personal information if required to do so by law in urgent circumstances, to protect personal safety, the public, or our website.

Data ownership

Mamino Histoires users that provide Application Question Responses:

Information you provide directly to an entity on Mamino Histoires that has created an application form in response to questions they have created specifically for their program or entity are called Application Question Responses. Application Question Responses that you provide to an entity on Mamino Histoires are available to that entity's administrators and designated evaluators. Entities, to which you provide Application Question Responses, may use that data, any associated basic information, and data available by virtue of your relationship with that entity both on and outside of Mamino Histoires.

Mamino Histoires users that solicit projects to provide Application Question Responses:

Mamino Histoires will not distribute or otherwise make available any Application Question Responses information without your permission. This provision extends to any evaluation notes and custom tags created by Evaluators. You will be notified if Anonymized Application Question Responses information will be made available to a third party, and you will have the opportunity to decline making such anonymized information available.

Data access

We may access your data as follows:

- to provide you with information about services and other items that may be of interest, provided that such use is consistent with this policy.
- to notify you of changes in the services we provide.
- to administer your account with us to allow you to use the site(s).
- to provide you with promotional material, but only in accordance with the terms.
- to use your data to customize the services we provide to you.
- to enable us to provide you with advertisements.

Other users of the site(s) may access your data if they have the rights to do so, or if you have given them the right to access or see your data. An example is that the designated evaluators of a program may access your application to that program. Any use that another user of the site(s) makes of your data is beyond our control. Any data you provide to us and the site(s) must comply with the terms.

Data aggregation

Mamino Histoires may use aggregated, anonymous data in its efforts to improve Mamino Histoires and to inform the ecosystem of ongoing trends.

This policy applies each time you submit data to the site(s). Your use of the site(s) means that you agree that we may use that data in accordance with this policy. Our privacy policy will change from time to time. The up-to-date privacy policy will always be shown on this page.

In the event that Mamino Histoires is involved in a bankruptcy, merger, acquisition, reorganization, or sale of assets, your information may be sold or transferred as part of that transaction. The promises in the privacy policy will apply to your information as transferred to the new entity and the services we provide.

Data storage duration and removal

Data are kept for any platform if the platform is not explicitly deleted by one of its administrators.

For a specific submission, the data will be immediately and irreversibly removed from the live servers.

Any deleted data, being either an entire platform or a specific submission, will stay archived in the backups for up to 6 months maximum.

Hosting

Any aforementioned data is stored on servers inside the European Union. Our hosting providers include but are not limited to <u>Google Firebase</u>, <u>postHog</u>, <u>Framer</u>, <u>Expo</u>.
