- The Travel Partner expressly undertakes to provide to Menooh.com only correct and valid information while requesting for any services under this agreement, and not to make any misrepresentation of facts at all. Any default on part of the Travel Partner would vitiate the bookings and shall disentitle the Travel Partner from availing the services from Menooh.com.
- Our System is a FIT (Free Individual Traveler) Reservation system which allows maximum of 8 Rooms or 48 Passengers to be booked at one time. However any activity which has more than 3 rooms or 9 Passengers booked for the "same date of travel & same hotel of stay" combination is handled as per "group terms & conditions". In such cases we have rights to cancel any confirmed or vouchered reservation(s) without any prior intimation. You are requested to contact our nearest support office in case of group or reservation with more than 3 room requirement.
- In case, Menooh.com discovers or has reasons to believe at any time during or after receiving a request for services from the Travel Partner that the request for services is either unauthorized or the information provided by the Travel Partner is not correct or that any fact has been misrepresented by him, Menooh.com in its sole discretion shall have the unrestricted right to take any steps against the Travel Partner(s), including cancellation of the bookings, etc. without any prior intimation to the Travel Partner. In such an event, Menooh.com shall not be responsible or liable for any loss or damage that may be caused to the Travel Partner or any of them as a consequence of such cancellation of booking or services.
- The Travel Partner unequivocally indemnifies Menooh.com of any such claim or liability and shall not hold Menooh.com responsible for any loss or damage arising out of measures taken by Menooh.com for safeguarding its own interest and that of its genuine customers. This would also include Menooh.com denying/cancelling any bookings on account of suspected fraud transactions.
- If the Travel Partner does not agree with any part of such terms, conditions and notices, the Travel Partner must not avail Menooh.com's Services.
- Our Support team will put in every possible effort to avoid a relocation however in scenarios where situation is out of control and Menooh.com is not able to honour

- Any dispute or claim arising out of or in connection with this website for India based
  agents shall be governed and constructed in accordance with the laws of
