

I will have to relate a story about Burma in 1943. I took a patrol out to contact another Column to deliver a message. All I had was an Azimuth reading. We got over there okay, but on the way back to our unit, a Jap machine gun opened up on us. No one got hit, our two BAR men opened up on the Jap area and that stopped the MG. We went on back to our outfit OK and that was that. Charlie Beck was one of the members of the patrol. Years later, we had a reunion in a nice hotel with a waterfall in the lobby. I was standing by the desk and the lobby was full of people. Charlie saw me when he came in and shouted, "Holt, you almost got me killed in Burma." AN UN-MEDICAL REPORT

I would like to update the report from Dr. Hopkins, Report Feb. 1992, Edition on April 8, 1944 – Nhpum Ga Burma I and three others were hit with friendly fire (60 MM mortar).

Cpl. Robert Norling died instantly. PFC Bernard Marshall,

Paul W La Panne were flown out early AM. I was evacuated in midafter noon. Paul died at the transfer air strip while Marshall and myself were taken to the Hospital. It was here I went to sleep for two weeks. It seems as though everybody celebrated my return to life!!! The wonderful care I got enabled me to return to a comfortable way of life. Bernard Marshall passed away while visiting me at my hospital bedside. This caused me to become despondent. They had saved my right leg and were fighting a bad osteo condition which I still have today, as I must change bandages twice a day. My left leg had extensive muscle damage and shoulder and chest wounds were minor. As I celebrated my 21st birthday there, I am very grateful to all the doctors and nurses for their excellent care.

After 52 years, they (VA) have elevated me from 80% to 100% disability because of the constant draining of my leg. I don't suppose there are any hospital people around but if there are – "God Bless You."

80TH BRITISH GENERAL HOSPITAL, DEOGARH, INDIA

Recently received a letter enclosing other documentation about this hospital which provided medical and surgical aid to us during the training period at Camp Deogarh in the Central Province of India. It was pointed out to me that many men who had malaria were treated at this hospital and would be interested in the reminder. A chap named Graham Thompson, is a relative of the Commanding Officer of that hospital, Lieutenant Colonel Edward Glass. They provided medical support during the period November 1943 and January 1944. Mr Thompson is interested in the history of the unit.

This came about because he sent me a copy of a letter signed by General Merrill to Gen Auchinleck, the Theater commander, thanking him for the high standard of efficiency maintained by that installation. It seemed likely that I had typed the letter since among my other HQ duties, Gen. Merrill frequently called me in to dictate letters to be sent out.

Those of you who survived the bouts of malaria, or were treated for other ailments might want to let him know of your experiences. I was in the 31st QM PK TR for a period of time before I was put in the 259th QM Co/Air Drop. I think the CO of the 31st was a LT Hurlburt. Remembering names back to those days, has almost completely left me. I remember 1st Sgt Campbell that was with Co E, 2nd Bn, 5307th. On December 17, 1943, I was assigned to the Red Combat Team of the 5307th Composite Unit (Provisional) as a Liaison Officer. Gen Merrill promised me that I could have an Infantry Platoon Leader's position as it became available.

On the third day of our march down the Ledo Road from Margherita, a Radio man who had just joined our RCT, committed suicide after saying, 'Major General Orde Wingate says that 2/3rd of us are going to die in Burma. If I have to suffer in Burma the way I've had to suffer these past three nights, I had rather die, first.' He put his big toe to the trigger of his Thompson, .45 cal Machine Gun and practically blew off his head. That was the end of his suffering.

What I'm writing to you about is to get a statement from someone who knew of our suffering in Burma. I got a bad case of Jungle Rot from being in water most of the time. On November 2, 1995, I had to have my left foot amputated to within five inches of my knee. I had 70% disability from war wounds that I suffered at Myitkyina Burma. The V.A. claims that there is something else other than Jungle Rot that has caused them to operate on my leg.

At Myilkyina, a Jap howitzer was fired at my position. I never heard it burst at my feet. I awoke tied to a stretcher and was told that I had been blown about 20 feet when the shell burst. I was taken to Dr Seagraves Hospital where I was bandaged and sent on to Ledo, Assam. My spinal cord had two processes broken; my left heel bone was crushed; shrapnel was in my right knee; my stomach was ruptured; three stitches were taken in my left eye-brow; my neck was nearly broken; and I was suffering from amebic dysentery, hemorrhoids and

other problems. If anyone saw anything that would help me with my claims, I'd appreciate all of the help that I can get. All who knew me called me Harland - my middle name. William Harland Hendricks, Major, Infantry Retired, 291 Joe Wright Rd, Klamath Falls OR 97603-9596

I've recently begun an effort to find some information about my Uncle, Father James Stuart, toward assembling a family biography before whatever is known becomes lost or too fragmented. All his nephews and nieces are too young to have more than a brief recognition that Father Jim, as we refer to him, did something important in WWII and little beyond that. So, whatever information I can find in Orlando will help fill in the gaps.

I did not know that Father Jim had written two versions of his report. I gather that he had a diplomatic sensibility although he also seems to have had a tart tongue, as seen in his references to Gen Merrill and about Cardinal Spellman's "Grand Tour". The version I have was given to me by my father at least thirty years ago. Supposedly it was written for a movie treatment that never materialized. It is on onion skin paper, is somewhat blurry but except for some smudges is readable. The process of retyping is raises some questions. Did Fr. Jim type the originals? He does refer to getting familiat with the typewriter but the thought of a novice typing 38 pages each of two versions is very remarkable. The other questions are: "Is the spelling of these place names correct? and, How do you pronounce them?" He also included what I think are map coordinates. Is it possible to decipher these references and locate them on a map? (DQ has taken care of this) My most important question is was Fr. Jim part of the OSS, or Merrill's Marauders or was he just casually attached to either as needed. His memoirs suggest both roles and he did get an award from the US Government, but as a civilian. way, it has been an interesting project to recapture his life story.

As for myself, I am a retired teacher from the Port Chester NY school system. I was born in New York City but was raised in Upstate HEADQUARTERS U. S. ARMY

I was hit the 31st of July, so I missed all of Camp Landis. I returned to the 475th below Myitkyina. The truck pulled in to the 3rd Bn at dark. Someone asked me what outfit I was with and I told him Co M, Machine Gunner. I was told there was no Co M and the MG were in HQ Co. The Lt told me that the MG squads were filled up and I would be his runner until they had a place for me.

In a couple of minutes, Lt Delorey came running over and really started to chew me out. The Lt explained to Don, that I had asked for the MG section and he was OK. I really enjoyed that.

As Don would say - Once a Machine Gunner, always a Machine Gunner. He was an old Machine Gunner and a Good Man. Lt Don Delorey.

I would like to know if there is a list of men killed at Myitkyina. I saw a boy, (Mike) Malcolm G Courtney shot on July 30th. Someone told me later that he had been killed.
