SPEAKER FRIDAY NIGHT DINNER - GRANT J HIRABAYASHI

Grant was born in Kent, WA in Nov. 1919 and in the year 1932, he went to Japan to continue his education. Upon graduation from High School in Japan, he returned and graduated from Kent High School in 1941. He then enlisted in the Army Air Corps after being inducted into the Army. October of 1942, he entered the Military Intelligence Service Language School and upon graduation, he volunteered for overseas assignment and served with the 5307th, 1st Bn, Red Combat Team and fought in the Battles of Walawbum, Shadazup, Nhpum Ga and Myitkyina.

After the India-Burma Campaign, he was assigned to the South East Asia Translation and Interrogation Center (SEATC), in New Delhi, India and was attached to the British Royal Air Force as Translator. Subsequently, he was transferred to HQ China Theater and assigned to Sino Translation and Interrogation Center (SINTIC), Chungking, China where he served

as an Interrogator until the end of the war. After he attended the Japanese Surrender Ceremony held in Nangking, China as Personal Interpreter to Major General Mc Clure, he returned to the USA and was discharged from the Army at Camp Mc Coy, Wisconsin in November 1945.

After discharge, he served as Japanese Language Instructor with the Military Intelligence Service from January 1946 to October, 1947. Then he was transferred to Supreme Commander for the Allied Powers (SCAP) Legal Section, Tokyo, Japan. He served as Interpreter, Interrogator, Court Interpreter and Court Monitor for the B Class War Crimes Trial held in Yokohama, Japan. Upon his resignation, he resumed education at the University of Southern California where he received his BA and MA degrees in International Relations. Grant served with the Department of State, Library of Congress and after thirty years of service, retired from the National Security Agency in 1979.

(His Military Decorations include the Combat Infantryman Badge, Presidential Unit Citation with Oak Leaf Cluster and Bronze Star with Oak Leaf Cluster.)

EIGHTH ANNUAL RANGER HALL OF FAME AWARD - OCTOBER 2000 CITATION, STAFF SERGEANT WARNER KATZ, 5307/3/OCT/I&R PLATOON

Staff Sergeant Warner Katz is inducted into the Ranger Hall of Fame for his heroic action while a lead scout for the I & R Platoon of Merrill's Marauders 3rd Battalion. After volunteering at the request of President Roosevelt for what was termed "dangerous and hazardous mission", Sgt Katz repeatedly demonstrated his experience and keen observation abilities by detecting trip wires and scattered mine emplacements which he scouted out, marked and planned by-pass routes through the dense jungle. His actions saved innumerable additional casualties. A number of times in various situations, he left his safe position within the perimeter to drag wounded comrades to safety. He was the first Marauder to kill an enemy and also the first to be wounded., but he refused to be evacuated. Prior to his service with the Marauders, he saw considerable action in the South Pacific in combat with the Americal Division in the Solomon Islands. Sergeant Katz exemplifies the motto of the Marauders, "Sua Sponte" - "Of Their Own Accord" - and of the Rangers, "The Rangers Lead The Way". Sergeant Katz's decorations include the Bronze Star with cluster, Purple Heart with cluster, Presidential Unit Citation and numerous service awards.
